


EXTENSION NAMED

Robert W. Shoffner

Robert W. Shoffner assumed duties as Director of North Carolina Agricultural Extension, July 1. He has been assistant director of the Extension Service since 1950.

In selecting Mr. Shoffner, the college chose a man with more than 32 years of experience in extension work.

His appointment climaxes a start from assistant county agent. to Farm Management Specialist. to district agent. to assistant director. to director.

As an undergraduate student at State College, he was a member of Alpha Zeta, Lambda Gamma Delta, Blue Key and Epsilon Sigma Phi--all honorary groups.

In 1958 he was honored by the USDA when they presented him with a Superior Service Award. Once more he was honored last year when the Progressive Farmer named him "Man of the Year in Agriculture."

Mr. Shoffner is a native of Burlington. He and his wife have a son. Besides being assistant manager of the N. C. State Fair since 1946, he has been quite active in civic affairs.

REGULATIONS GOVERNING ELECTION OF STATE 4-H OFFICERS

Candidates Eligible for Office: Only present or former district 4-H officers (those elected in 1958, 1959, 1960, and at the 1961 District Demonstration Days) now active in 4-H work may be nominated for one of the State 4-H Council offices of president, vice-president, secretarytreasurer, and historian. Club members who have completed one year of college work and are currently enrolled in college are not eligible for nomination. The officers this year will follow the usual rotation plan: President - girl; Vice-President - boy; Secretary-Treasurer boy; and Historian - girl.

Election Regulations: (The 1960 State 4-H Council members voted for the following new procedure.) The State 4-H Executive board will meet on Tuesday afternoon, July 25 from 4:30 to 6:00. The first part of the meeting will be devoted to the approval of officer candidates.

Nominations will be made at the morning assembly on Wednesday, 9:30 a.m. in the Coliseum. Short qualification speeches for each candidate should be made by campaign managers at this time and the candidate should make a short speech. Time alloted for campaign manager and candidate together - two minutes.

Votes will not be cast by ballot on an individual basis. One representative must be selected by each county. This county representative will cast all votes in the General Assembly on Friday afternoon, July 28. Each county will have a certain number of electoral votes depending on its 1960 4-H Club member enrollment. Every county will have 4 votes plus one additional vote for each 200 enrolled 4-H members. Therefore: County A receives 3 votes in addition to the 4 votes for a total number of 7 votes. Any number less than 200 such as the 58 members remaining in the above illustration of County A, are disregarded.

All officers will be elected at the Friday afternoon assembly. There might be any number of candidates for any one of the four offices. To be elected, a candidate must receive a simple majority vote. For example, if the total number of electoral votes held by all counties combined is 600, a candidate for any one office must receive at least 301 votes before being declared the winner. If the total number of electoral votes held by all counties combined is 900, a candidate for any one office must receive at least 451 votes before being declared the winner.

There will be a roll call of counties at which time the representative will call out the county's vote for each office. Any candidates not elected on the first roll call will be voted on again. A short caucus period will be allowed for county groups following the first roll call. During this caucus period, campaigning will be allowed if desired. After this period, a second roll call will be held. The county representative will again cast the votes for the respective candidates as determined in the caucus. As many additional roll calls will be held as necessary to obtain a majority vote for each office. Once one candidate for each office has received a simple majority vote, the General Assembly will adjourn.


The decision of how each county's alloted electoral votes are to be cast must be made by the County group. The County representative will assist in conducting the County Meetings. Counties will decide in the County meeting to be held on Thursday how their votes are to be cast on the first ballot. Votes must be cast in whole numbers, no fractions. For example: County A has 7 electoral votes. But, County A has 10 4-H delegates at Club Week. These 10 delegates vote on candidates for the various offices in their county meeting on Thursday. Their vote may be split - five for candidate R and five for candidate S. Therefore, 4 of the electoral votes may be cast for candidate R, and the other 3 for candidate S. Another example: County B has 24 delegates at Club Week and has 12 electoral votes. These delegates split their vote - 10 for candidate R, 9 for candidate S, and 5 for candidate T. Therefore; County B's electoral vote may be 5 for R, 5 for S, and 2 for T. Another example; County C has 6 electoral votes and 16 delegates and cast all votes for candidate R so all electoral votes go for R.

<u>Campaigning</u>: Campaigning may begin immediately following the nominations on Wednesday morning. Posters and campaign literature may be used. Posters may be used if they are placed on or near the bulletin boards in the YMCA, Dining Hall, Gymnasium, Coliseum, and dormitories. There is a limit of eight posters per candidate. Other campaign literature may be distributed only in the dormitories and cafeteria or carried by club members as portable banners or posters. <u>Glue</u>, <u>nails</u>, <u>or any</u> other materials which will harm structures are not to be used. Candidates should be conservative in the amount of money spent in campaigning. Large numbers of posters or other materials <u>do not</u> win elections. The State 4-H Council Executive Committee has gone on record opposing candidates conducting expensive campaigns.

No campaigning will be permitted during classes or assemblies, except Wednesday morning assembly when time is provided.

State College and personal property must be respected at all times. No campaigning is allowed within 50 feet of the polls. The candidate is responsible for seeing that all literature is taken down and picked up after the elections. No cars are to be used by anyone for campaigning purposes.

On Tuesday afternoon, July 25, at the State 4-H Executive Board meeting, each candidate for a state office is asked to submit to the State 4-H Executive Board 200 mimeographed copies of a summary of the candidates qualifications. These must be $8\frac{1}{2}$ " x 11" printed on one side only. These sheets will be distributed at this time to each county group for them to use in helping their fellow club members study the candidates qualifications to decide how to cast the county's electoral vote.

MARINE BAND TO APPEAR TONIGHT

A real treat is in store for 4-H members Monday evening during assembly. The 2nd Marine Division Band of the U. S. Marine Corps at Camp Lejeune, North Carolina will give a concert.

Whether playing popular marching music or a classical concert, this band creates a stirring atmosphere wherever they go. In recent months the band has played to hundreds of thousands of people in the Carolinas--at various civic and social events.

This is the second trip to Raleigh for the band this year. Thousands of people applauded them as they marched through the capital city on Armed Forces Day in May. The band is under the leadership of Chief Warrant Officer Karl W. Rhine, who studied music at the University of Southern California, Los Angeles. He has been directing bands in the Marine Corps for over 13 years in the Far East and the United States.

In 1959 the band completed a highly successful tour of Great Lakes cities where it entertained more than half a million people. This same band lined the streets of Chicago to serenade the Queen of England upon her visit here.

It has also entertained television audiences with performances during half-time ceremonies at several football Bowl games during the past few years.

Ruth Current

After 33 years of extension service, Miss Ruth Current, Assistant Director, Extension Home Economics, will retire August 31.

Miss Current's name is a household word in homes throughout the state. She is credited with broadening the scope of home demonstration club activities to include many new programs in such areas as citizenship, education, international relations, publicity, finance, health, and safety--just to name a few.

Honors have been heaped upon Miss Current for her outstanding work in the state and around the nation. In 1947, she was cited as "Woman of the Year" by Progressive Farmer. She was named Carolina Farm Leader in 1950 by the Carolina Cooperator; "Tar Heel of the Week" in 1953 by the Raleigh News and Observer; Chi Omega Sorority's "Woman of the Year" 1953; and "Woman of the Year" by the State Grange in 1953.

She has received many other awards attesting to her leadership in the state, which also includes a Distinguished Service Award in 1958 from the North Carolina Federation of Home Demonstration Clubs.

Her appointments to special Statewide committees during the past 20 years number almost half a hundred.



MEET THE 4-H STATE STAFF

Hats off to the North Carolina State 4-H Staff. Their efforts have made it possible for you to enjoy this week.

Their combined experience in 4-H work totals over 100 years. They now head the largest 4-H organization in the United States with a membership of over 168,000.

Mr. L. R. Harrill has been State 4-H Club Leader since 1926. He has served as Chairman of the National 4-H Sub-Committee, which is the 4-H policy committee for the U. S. In 1957 he was named the "Man of the Year" by Progressive Farmer. In 1950 Mr. Harrill received a gold key from the National 4-H Camp for 25 years of outstanding leadership in 4-H Club work. That same year he was named North Carolina's Man of the Year. The USDA awarded him a Superior Service Award in 1955.



Miss Mary Sue Moser became the Northwestern District 4-H Club Agent in 1948. Prior to that time she had served as Home Demonstration Agent in Davidson County and as an Assistant Home Demonstration Agent in Forsyth County. Miss Moser is presently serving as Secretary to the National 4-H Sub-Committee. She also just completed 2 years as Chairman of the Southern Region of State 4-H Club Leaders. She is a native of Monroe.



Mr. Dan F. Holler joined the State Staff as Southeastern District 4-H Club Agent in 1950. Before joining the staff, he was Cotton Marketing Specialist at State College. Mr. Holler is a native of Anderson, S. C. and graduated from State College. He served as assistant extension agent and county agent in Wilkes County. Mr. Holler enjoys gardening and lots of fishing.




