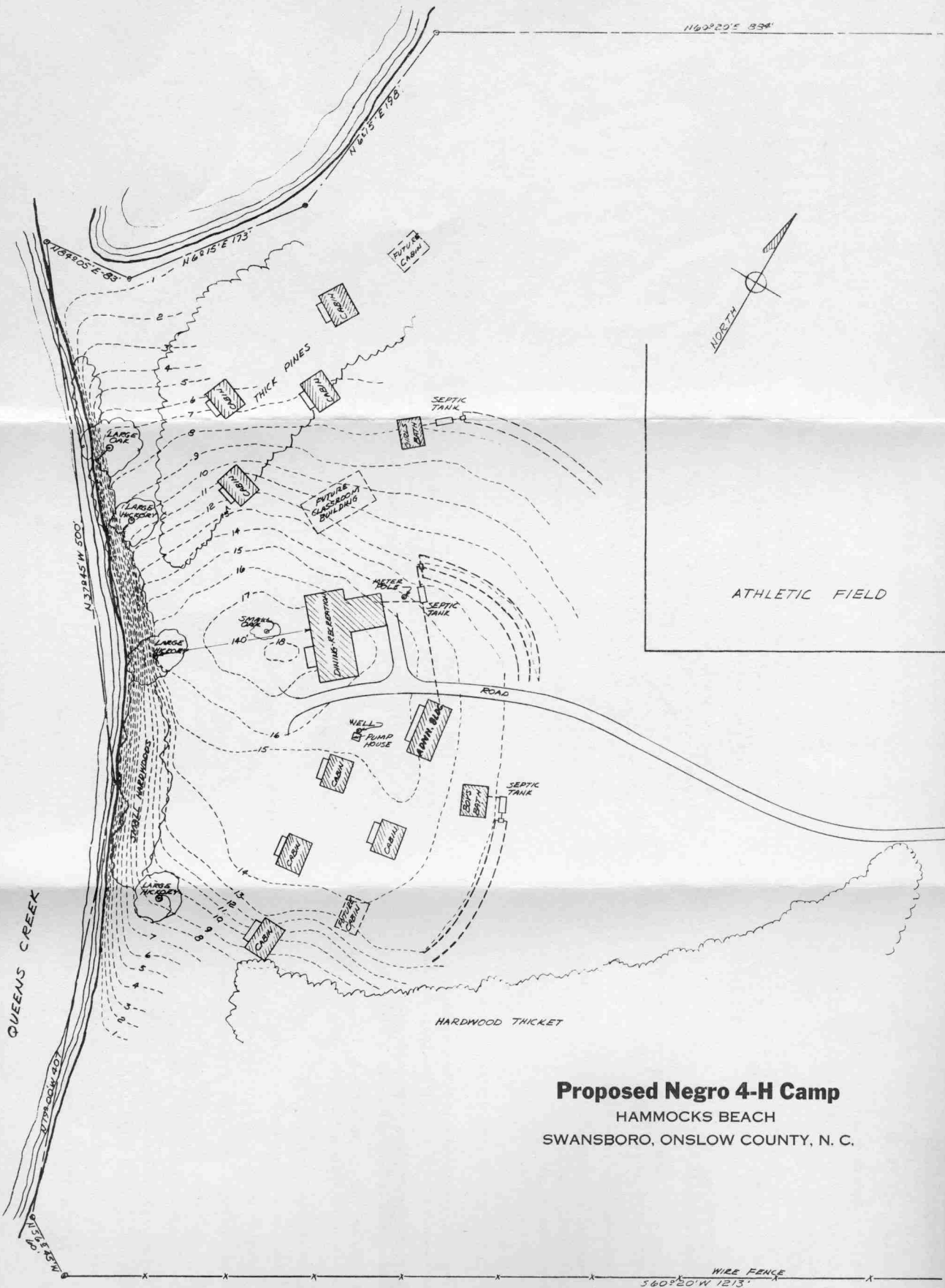

WE HAVE...

During the past FOUR years we have raised more than **\$37,000.00.**

Here is what we have done :

4-H Members, leaders and parents	\$29,488.92
Businesses	7,826.24
Grand Total	37,315.16
Less Expenses (surveys, lease, well, legal fees, auditing, etc.	5,773.24
Total Cash on Deposit	\$31,541.92

WE NEED...

To complete construction of the proposed camp we need an additional **\$36,629.08.**

Here is what we plan to build:

Dining and Recreation Building	\$23,200.00
Girl's Bath House	6,763.00
Boy's Bath House	5,791.00
Administration Building	8,945.00
Eight Cabins	23,472.00
TOTAL CONTRACT PRICE	\$68,171.00

This will accomodate 150 4-H members per week—or a total of 1800 each camping season.

1. Who is sponsoring the building of this 4-H camp?

Answer: The 4-H Club Foundation of North Carolina, Inc.

2. What is the 4-H Club Foundation?

Answer: A non-profit and education corporation composed of individuals interested in aiding and promoting 4-H Club work among Negroes in North Carolina.

3. How may contributions be made?

4. Are contributions deductible for income tax purposes?

Answer: Yes, all donations are deductible on Federal and State income tax returns.

5. Where can I obtain additional information about this 4-H camp?

Answer: From county Extension workers, or the Secretary of the 4-H Club Foundation of North Carolina, Inc., Box 67, Greensboro, N. C.

Sustaining Membership Fees By Way Of Contribution

\$10.00 minimum for individuals and rural families

\$25.00 minimum for merchantile establishments and corporations, fraternal groups, and other organizations

If construction is started April 25, work should be completed in 90 days, providing money is available.
