Dear Dr. Bostin,

I am enclosing a clipping of an article which recently appeared in the Pittsburgh Press entitled "Why Force Athletes to Study". We must admit this article contains some very significant statements and it is quite definite that the colleges having the leading football teams follow the rules laid down in this article.

We at State College want an athlete to be a good student while the University, Duke and Wake Forest want their athletes to be good athletes. It is useless for our coaching staff to recruit a good athlete if he flunks out in his studies the first or second year. During the past thirty years I have been responsible for many athletes from this district entering State College. At least fifty per cent of them were let out during their first or second year. I finally decided that it was wasted effort.

With the football material we have had at State during the past five years, ten of the leading coaches in the country could not have placed a winning team on the field. If we cannot follow the rules adopted by the surrounding colleges about having easy courses, etc., we might as well give up football as it would be beyond the limits of any coaching staff to produce a winning team. Herman Hickman, who was one of our line coaches for a number of years told me once that football players at Tennessee do not graduate in four years. My nephew played football at Wake Forest and never graduated. When Jock Sutherland was coaching the Pitt team the players always came back two additional years if they graduated.

I am also attaching a clipping from one of the Pittsburgh papers indicating that Bob Brodhead, a local athlete has decided to go to Duke and that he and his parents are visiting the Duke campus. Having done considerable scouting in this area, and considering that twenty-three other colleges were after this young man, I can readily understand that the football department at Duke went to considerable trouble to induce this lad to enter Duke. We can therefore rest assured that he is not going to flunk out during his first or second year. Every winning team must have four to eight outstanding athletes on their squad at all times. If this is not true, the quality and ability of the coach helps very little.

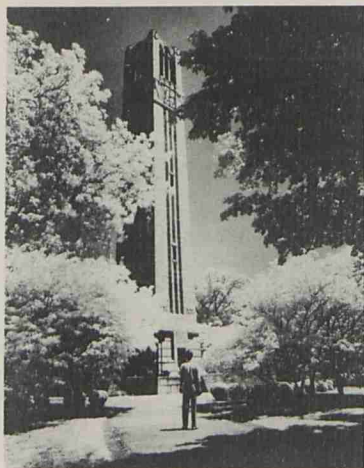

At their meeting on May 24, our Board of Trustees gave us authorization to make an agreement with you for providing facilities as outlined in your letter of May 17. Actually, authorization was granted by unanimous vote without our being called upon to identify the agency involved. I should add also that the matter was approved by the Executive Committee and not by the full Board, so that only twelve individuals know about the matter.

The lease for the use of Rooms 115 and 116 in 1911 Building has been properly signed and sent to you. You may, therefore, begin using these rooms immediately.

We shall be glad to receive a formal proposal for utilizing all of the building as outlined in your letter of May 17; which excludes Rooms 106, 310, 311, 314, and 315.

Dear Dr. Bostian:

This will confirm our recent discussions concerning the utilization by the Housing and Home Finance Agency of certain facilities of North Carolina State College.

As we indicated to you orally, the major part of the facilities which we will require would be needed only upon the occurrence of events constituting an emergency serious enough to warrant the steps which we outlined to you. Certain of such facilities would be borrowed by our Agency only for a short time, until permanent replacements could be secured.

We are summarizing below our anticipated needs and the tentative solutions to them developed in our discussions with you. We understand you will wish to discuss further our tentative agreements with the Board of Trustees at their meeting on May 24th on these matters.

Our office space requirements could be met through utilization of the building designated as Building 1911, excluding Rooms 106, 310, 311, 314, and 315 which you indicated could not be vacated. In the event that we can conclude arrangements for use of this space in the contingency discussed with you, we should like immediately to begin using Rooms 115 and 116 in that building for the storage of certain records under the terms of the lease which we left with you.

As you know, we will need furniture and other office equipment on very short notice. With the exception of typewriters and adding machines, the furniture and equipment now in Building 1911 would be sufficient to meet our emergency needs, and if that equipment could be left there for our use we would replace it with our own as soon as conditions permitted. We understand that we might also be able to borrow an additional 50 to 60 typewriters and 10 to 20


adding machines until replacements can be secured, and that supplies, printing, and other services available at the College might be furnished on a reimbursable basis. We would use, on a reimbursable basis, the telephone branches now in the building until the additional service for which we would arrange with the telephone company has been installed.

It was our understanding that Watauga Hall, a dormitory on the campus, having 54 rooms, might be made available for emergency housing, subject to reimbursement by the individuals occupying the dormitory, and that our personnel might also have access to the cafeteria facilities on the campus.

I am sure you are aware of the importance of this undertaking and our appreciation of your favorable consideration of our request. If the arrangements tentatively developed with you and summarized above meet with the approval of the Trustees, we will submit for your review an agreement which would formalize these arrangements.

I am informed by the Office of Defense Mobilization that this is the only Government Agency authorized to negotiate for this type of help within your County. This, of course, does not include the Defense Department.



Dear Dr. Bostian:

Reference is made to the confidential discussions heretofore had between our respective representatives. In pursuance thereof, the United States of America, acting by and through the Housing and Home Finance Agency, represented by the undersigned as contracting officer, hereby proposes to acquire the right to use and occupy the facilities described in the enclosure hereto, marked Exhibit "A", as hereinafter provided.


In the event of an enemy attack or the imminence thereof and upon notice verbal or written to such effect, by an authorized representative of the Government, it is understood and agreed that you will permit the Housing and Home Finance Agency immediately to take possession of the facilities described in Exhibit "A". As soon as possible thereafter, the Government will enter into negotiation with you for the execution of a formal lease covering the rights and obligations of the parties with respect to the aforementioned facilities and providing fair compensation for the use thereof by the Government commencing with its initial occupancy. Such formal lease or other instrument will be negotiated by General Services Administration. All prior conversations or negotiations between our respective representatives are merged in and superseded by this letter.

It is understood and agreed that the Government will not be responsible for any expenses incurred by you prior to the period covered by the formal lease or other instrument to be hereafter negotiated.

It is further understood and agreed that from time to time due to changed conditions, it will be necessary to amend or supplement Exhibit "A" by the addition or deletion of facilities therefrom.

Please indicate the acceptance by your governing body of the foregoing by signing and returning to us the original and two copies of this letter. A copy is attached for your files.

EXHIBIT "A"

DESCRIPTION OF FACILITIES

1. Location:

North Carolina State College, Raleigh, North Carolina

2. Space Suitable for Offices:

In Building 1911, presently used for offices and classrooms, all space excepting only Rooms 106, 310, 311, 314 and 315, and also excepting Rooms 115 and 116 for which HHFA is presently negotiating with NCSC by separate lease agreement. Excluding these seven rooms, the space so to be provided HHFA in this building totals approximately 22,400 square feet of office space, plus all public spaces, corridors, toilets and incidental closets, lavatories and presently installed utilities and building fixtures not exclusively serving the rooms excluded above. All furniture and equipment now in the non-excluded areas will also remain for use by HHFA, to be released back to NCSC as quickly as HHFA can provide its own equipment in lieu thereof; equipment so to be loaned HHFA by NCSC shall include 50 to 60 typewriters and 10 to 20 adding machines.* Building 1911 is a three-story brick and masonry structure with wood floors, and is located on the College campus grounds.

3. Space Suitable for Storage:

None required.

4. Land (Number of Acres and General Boundary Description):

None required.

5. Housing:

a. Dormitory: Watauga Hall, a student dormitory on the campus, having 54 rooms. HHFA to be provided all or such space therein as required for housing of personnel, reimbursement therefor to be made by the individuals to the College, at current rates. Space so furnished to include all furniture, equipment and facilities normally provided tenants.

b. Other Types: None

6. Cafeteria and other Mess Facilities:

HHFA to be allowed use of such cafeteria facilities on the campus as are then being operated, on an individual reimbursement basis. No possession or operation by HHFA.

7. Utilities:

All telephone equipment and service, including existing business lines and branches, to remain operating in place in 1911 Building and Watauga Hall, to be used by HHFA on reimbursable basis. HHFA to arrange as quickly as possible with local telephone company for direct billing and such additional equipment as needed.

NCSC to provide heat, electric light and power, and normal water service to 1911 Building, reimbursement to be made by HHFA; and to Watauga Hall, reimbursement to be made by tenants.

8. Miscellaneous Facilities and Services:

Supplies as available to be furnished HHFA by NCSC on reimbursable basis. Printing and related services as available from the College facilities to be furnished HHFA on reimbursable basis. All other facilities and services available and requested from NCSC to be furnished HHFA on reimbursable basis.

*NOTE: Concerning the typewriters and adding machines to be loaned HHFA per item 2 above, it is specifically understood that HHFA will exert immediate efforts to replace and return these machines at the earliest possible moment.
