
In response to your letter of December 6, in which you requested "continuing support" of R. J. Reynolds Tobacco Company for the North Carolina Engineering Foundation on the basis of ten cents per employee per quarter, please be advised that at a meeting of the Company's Executive Committee, held December 12, it was agreed that by taking as a basis the average number of Company regular employees on roll in Winston-Salem during September, October and November, 1955, namely, 10,400, a check be sent you for \$4,160 for the year 1955.

Similarly, using the above basis to compute the amount for 1956, a check will be sent you in December 1956 for that year. In December 1956 your request for "continuing support" will again be reviewed but at this time the Executive Committee was reluctant to go beyond 1956.

We hope this is satisfactory to you and will be of help in meeting your requirements.
