As a student, he was president of the student body, played guard on the football team, won the Elder P. D. Gold Medal for being the most outstanding student. In his senior year, he formed and coached the first North Carolina State swimming team that has since produced many All American swimmers.

After graduation, he served as Assistant Dean of Students at N. C. State until 1941, when he entered the Army as First Lieutenant. Serving with the college ROTC, then with Special Services in Washington and New York, he returned to State College for one year after the war. He then joined Atlantic Life Insurance Company of Richmond as a North Carolina agent. He was soon named Assistant Manager of the Raleigh area and later assigned Atlantic supervisor for the entire state. In 1952, he was promoted to Manager of Atlantic for the Raleigh area.

He has been Jaycee president, Chamber of Commerce board member, Kiwanis secretary for seven of the six years his club won the highest achievement award for the two Carolinas, budget chairman for Family Service and The Heart Society, president of the Wake County North Carolina State Alumni and board member of the Life Underwriter's Association. He formed the first LUTC course for Raleigh insurance men and has written several articles on insurance for national magazines, including Courant, Management, and Life Insurance Selling. Outstanding have been his efforts for youth, giving Raleigh two major ideas--Student Government Day, during which High School students now take over the city government for one day each year; and newspaper selling day to raise funds for a one-day trip to the beach for Raleigh orphans each summer.

He is now a member of the Milburnie Fishing Club, Carolina Country Club, Mine O'Clock Cottillion Club, and the Circle Club. He is a member of the Sacred Heart Cathedral Catholic Church and was recently promoted to full colonel as a commandant of the USAR school in this area.

I informed him there had been, but your decision in basketball was only a trial for the remainder of the season. They brought out the point that we should have printed ticket information, which they had never seen, so I gave him a copy of our ticket policy for 54-55, and I am sending you a copy which might refresh your memory in case they care to discuss this matter with you.

I think that they will go along with our plan, but they are not too happy about it. They did leave here willing to try to work the matter out, hoping they could come up with a solution satisfactory to the student body.

- (B) On all games sections 17, 18, 19, 20 and even side 21 will be set aside for student use.
- (C) Date tickets may be purchased at ticket booth in front of student gate starting at 12 noon for afternoon football games and starting at 6 p.m. for night football games for half price.
- (D) Students and dates may sit in any seat available in the student section on a first-come first-choice basis.
- (E) No student will be allowed to save seats for any other pary or group.

Dear Mr. Friday:

Around August 31, 1956 Chancellor Bostian, Chancellor House, together with Director of Athletics, C. P. Erickson for Carolina and Roy Clogston for State College, worked out the points of agreement set forth below and as recorded by C. P. Erickson.

- As I understand the instructions, this letter is to apply to all sports where any assistance is given to an athlete.
- This agreement is to become effective on October 1, 1956, and remain in effect until superceded by a Conference ruling.
- 3. The letter is to be signed by the applicant and by parent or guardian.
- 4. The same letter is to be used by all institutions of the Consolidated University of North Carolina.
- 5. When the signed Letter of Intent is received by an institution, a copy is to be mailed to the athletic director at the other school.

This was cleared by all concerned with no changes except that State College suggested and all accepted the provision that the earliest date for signing an application for a grant-in-aid should be December 1.

I am attaching the mimeographed form of the application for a grant-in-aid.

I am also sending a copy of this communication to you to Chancellor Bostian, Director Clogston, and Director Erickson. I am requesting that each one initial this copy and return it to your office. You will then have the agreement, the document to be used, and the signatures of all parties.

Dear Mr. Clogston:

It has been decided that we should have a definite policy of reporting to the press and to the Commissioner's office of the Atlantic Coast Conference any complaints by our coaches of the actions of coaches at other institutions. It is, therefore, requested that our coaches send to you all complaints which they wish to make about practices of other coaches. If you consider these deserving of further attention, please send them to me with a statement of your own opinion.

It should be kept in mind that complaints should not be made unless they can be supported by substantiating facts. After receiving such information from your I shall trafficult a request to the President of the University that he consider the reports and send them to the Commissioner's office if there appears to be sufficient grounds for believing rules and regulations have been violated.

These procedures seem necessary because the Board of Trustees has made the President and the Chancellors completely responsible for the Athletic Department. You may be assured that I shall endeavor to provide all possible assistance to members of our coaching staff and to you in seeing that rules and regulations are being followed and shall, of course, expect and appreciate that members of our own staff conduct all their practices in accordance with current rules and regulations.

Dear Chancellor House:

Members of our faculty are greatly pleased with the privilege of buying tickets for the State-Carolina game at half price. I told President Friday this morning that I was quite willing to accord the same arrangement to the faculty at the Woman's College, if okay with you.

I am sorry that we have not responded earlier to the proposed letter of intent sent about ten days ago by Mr. Erickson. Shortly after receiving the proposed letter of intent, a meeting of our Faculty Athletic Committee was held for another purpose. It occurred to Mr. Glogston and me that we should apprise members of our Athletic Committee of the proposed letter and give them an opportunity to make suggestions. They were unanimously in accord with the idea but did have one suggestion which appears an essential feature of a letter of intent. There should be a date before which letters of intent should not be secured from students in high school and prep school. We suggest that it be understood that no letter be secured prior to December 1 of each year covering the enrollment of a student the following year. We suggest also that the letter of intent be printed in triplicate with one copy to be retained by the student and the others by the Athletic Directors.

We are, therefore, giving our approval to the letter of intent submitted by Director Erickson and to the five conditions listed in his letter of August 31 with the request that we add this date of December 1. You may consider this letter our approval of using this letter of intent until such time as the Atlantic Coast Conference adopts a regulation or until we wish to change it by mutual consent, or you may have Director Erickson submit a revised letter of intent with the additional condition I have suggested for my signature.

Centlemen;

Because of your great interest in the proposed changes in the operation of the Coliseum, I wish to bring you up to date on developments.

Just as we were ready to make a public announcement of the changes which are to become effective July 1, 1956, we were advised by Acting President Purks and Mr. William C. Friday, Secretary of the University, to seek approval of the Finance Committee of the Board of Trustees. They informed me yesterday that in June 1950 the Finance Committee of the Board of Trustees had authorized a "Reynolds Coliscum Authority." Betther the Coliscum Advisory Committee nor I knew of this but it now appears that it will be desirable to ask the present Finance Committee to approve the proposed changes in order to avoid any possible difficulty later from the Board of Trustees.

The Finance Committee has authority to approve the changes without submitting them to the Executive Committee of the Board. We are taking immediate steps to get approval from this Finance Committee. No difficulty is anticipated since the recommended changes have both my approval and that of Acting President Purks.

On December 22, 1955, the Coliseum Advisory Committee was appointed consisting of the following individuals: H. B. James, Chairman; W. H. Sullivan, Frank B. Turner, R. J. Preston, J. J. Stewart, C. A. Hickman, and James Rolan. Any suggestions you may have concerning the future operation of the Coliseum may be sent to me or to any member of this committee.

Dear Mr. Clogston:

This will present the current understanding we have about your assuming the Directorship of the Coliseum in addition to your duties as Director of Athletics on October 17, 1956.

- 1. Concessions will be handled by the Students Supply Stores beginning July 1, 1956.
- 2. The Coliseum Engineer and the small staff of full-time janitors will continue to work exclusively at the Coliseum and under the Director of the Coliseum as is now the case.
- 3. The cleaning of the building after special events will be done by Maintenance and Operations on a full reimbursable basis with the collaboration of the Coliseum Engineer and the full-time staff of janitors.
- 4. Reginning July 1, 1956, the Department of Maintenance and Operations will assume responsibility for all repairs to the building. Repairs to equipment will be done either by Maintenance and Operations or by the Coliseum Engineer, depending upon the nature of the equipment and as decided by mutual agreement.
- Mr. W. Z. Betts and the present secretary, Mrs. Hannon, will remain in their present positions until October 17, 1956.
- 6. The budget for the Coliseum for 1956-57 will be divided into two parts with October 17 as the dividing point. Employees of the Athletic Department including yourself, who will be joint employees after October 17, will have their full salaries paid by the Athletic Department until that date.
- 7. The ticket manager will be responsible to the Director of the Coliseum. He will issue tickets according to instructions from the Director of the Coliseum after policies have been approved by the administration. An exact record of every complimentary ticket will be kept and no complimentary tickets issued except by written request of the Director of the

Coliseum. During the five days immediately preceding any event, complimentary tickets may be issued upon written request of the Business Manager, Assistant to the Chancellor for Public Relations, and the Chancellor.

8. The selary of the Director of Athletics and of the Coliscum will be at least \$11,000, effective July 1, 1956, and will be increased to \$12,000 annually on July 1, 1957; subject to any required approval of other agencies, such as Budget Bureau or Trustees - CHB

If this statement does not agree with your understanding, I shall be glad to confer with you after my return to the compus on July 5.

This will present the current understanding we have about your assuming the Directorship of the Coliscum in addition to your duties as Director of Athletics on October 17, 1956.

- 1. Consessions will be handled by the Students Supply Stores beginning July 1, 1956.
- The Colineum Engineer and the small staff of full-time janitors will continue to work explusively at the Colineum and under the Director of the Colineum as is now the case.
- 3. The cleaning of the building after special events will be done by Maintenance and Operations on a full reimbursable basis with the collaboration of the Colissum Engineer and the full-time staff of janitors.
- 4. Beginning July 1, 1956, the Department of Maintenance and Operations will assume responsibility for all repairs to the building. Repairs to equipment will be done either by Maintenance and Operations or by the Colissum Engineer, depending upon the nature of the equipment and as decided by mutual agreement.
- 5. Mr. W. E. Betts and the present secretary, Mrs. Hannon, will remain in their present positions until October 17, 1956.
- 6. The budget for the Coliseum for 1956-57 will be divided into two parts with October 17 as the dividing point. Amployees of the Athletic Department including yourself, who will be joint employees after October 17, will have their full salaries paid by the Athletic Department until that date.
- 7. The ticket manager will be responsible to the Director of the Coliseum. He will issue tickets according to instructions from the Director of the Coliseum after policies have been approved by the administration. An exact record of every complimentary ticket will be kept and no complimentary ticket sissued except by written request of the Director of the

Coliscum. During the five days immediately preceding any event, complimentary tickets may be issued upon written request of the Business Manager, Assistant to the Chancellor for Public Relations, and the Chancellor.

8. The salary of the Director of Athletics and of the Coliseum will be at least \$11,000, effective July 1, 1956, and will be increased to \$12,000 annually on July 1, 1957.

Dear Mr. Clogston:

Attached is a copy of the letter which has been written to the Scholarship Committee authorizing athletic awards for next year. Will you please notify the five head coaches who are involved.

It is expected that they will continue to exercise much diligence and care in the selection of students for recommendation to the Scholarship Committee. They should also realize that we are approving this budget for next year without having funds available for paying chligations for this current year.

We are operating on faith that the Wolfpack Club will provide the share of funds as pledged last September. If these funds are not forthcoming and we have already awarded scholarships for next year amounting to approximately \$128,000, we shall be running the risk of not being able to make any awards for 1957-58.

Thus, it is very important that scholarships for next year be awarded to students who have both superior athletic ability and academic qualifications for satisfactory progress in school.

Dear Coach Edwards:

Soon after your letter was received in which you reported the great need of travel funds for bringing prospective players to the campus Mr. Vann and I approved a transfer of funds to the account which is being used for this purpose. At this time, we do not know of any other source of funds except those which may be secured from friends and alumni of the College.

We are engaged in a great effort to secure more funds for athletic scholarships than during any previous year. When budgets for athletic scholarships are made for next year, we must include an item for travel. There is no question but that this is an indispensable link in the chain which must provide the means for conducting a successful athletic program.

At this time I have no suggestion about a possible source of increased funds for travel except that we shall all extend our efforts toward meeting the current obligations of the weifpenk Glub and of the College. You will agree readily that there is no point in bringing prospective players to the campus and offering them scholarships unless funds are going to be available for providing this aid.

The practice game last Saturday showed that you will have much more talent evailable for next fall. I saw the entire game and while no expert was well impressed with the defensive playing and the spirit of the men. I am very hopeful that before the season begins you will have identified a couple of quarterbacks who can make better use of the large array of backs at your disposal.

You and your associates have been making mighty good use of the talent at your disposal and we look forward to next season with much optimism and confidence.

Mr. Ray, Mr. Vann, and I stend ready to work with the Athletic Director, officers and directors of the Wolfpack Club, and with members of the coaching staff in providing the necessary funds for our programs and shall velcome any suggestions you wish to make. It is an enterprise in which all of us must work together.
