SUBJECT: Clarification of matters related to Affirmative Action

Dr. Kelly sent you two different items at once. The second item "Affirmative Action Plan for Additional Administrative Units" is the temporary title assigned to the plan developed to cover all the units on campus that were too small to generate a separate plan of their own and yet needed to be included in a plan for the University as a whole.

Dr. Carnesale coordinated the work among these 13 units and developed the plan which should not be confused with a plan for the administration. University Studies was included among this group because Dr. Carnesale did not want to become too closely identified with any School and feared he might if he were included with one for Affirmative Action purposes. The term research assistants and research associates in Table 1 refer to EPA positions, not graduate students. "Other" refers to EPA positions not included in the above titles.

The first item is a draft of a statement that was intended to help you formulate a statement related to University administrators. For purposes of Affirmative Action planning we pulled out Deans, Assistant Deans, Directors, Department Heads, Vice Chancellors, etc., and put them in a separate group totaling 96 individuals. We had two purposes: 1) to establish a workable group of administrators that could be discussed at one time 2) to reduce the average salary for white male faculty. The printout of those included is attached. Part of our problem in developing this list is that the computer lists individuals by rank rather than title. No doubt there are individuals who are mainly considered administrators on campus.

As I noted before the draft was really designed to serve as a starting point for you in developing your own statement of what our goals should be for changing the administration from a bastion of white male supremacy.

One final point. Since we have protested so long and virogously that we have not discriminated in the case of Joesting, Mueller, and Bireline, we should maintain that position in our statement. Maybe we can plead guilty to "institutionalized discrimination."

SUBJECT: Meeting of Long Range Planning Committee/UNC, July 10, 1974

This is a report of the meeting of chief academic officers in the General Administration Building, July 10. The meeting was chaired by Ray Dawson with John Sanders and Robert Williams in attendance.

Two specific items of business were addressed relating to the HEW Affirmative Action Plan.

1. We were informed that Mr. Dawson's office will establish a central faculty position pool as outlined in a recent memo to the Chancellors. A standard form will be used by all institutions to announce vacant positions to Central Administration. This is an information pool only and each institution will be expected to pursue employment action as in the past. Information on salary is to be included in the position description. Information from this pool will be sent to applicants upon request and they will be advised to communicate directly with the institution in which they are interested.

We queried Mr. Dawson about Item c on page 169 of their report which provides for a central faculty applicant listing service and he indicated that they will not keep a list of applicants but only a list of vacant positions. We double checked this point and both Dr. Clark and I got the impression that they were wanting to keep that item rather vague but perhaps inoperative.

2. They hope to encourage faculty exchange among the institutions, particularly if they get the requested \$100,000 in the 1975-76 budget request. Funds in this budget will be used to defray the cost of temporary dislocation of faculty members involved in the exchange, but will not be used for salary items. It is anticipated that these exchanges will be for one semester or so but not permanent transfers. They will do all possible to discourage raiding but do not expect that it will be legally possible to prevent it altogether. A committee will be appointed to work out appropriate details and these will be presented to the Provosts of the various institutions.

3. Copies of the HEW Plan as finally accepted are being printed and should be available in early August. The copies will include a summary of the commitments.

4. President Friday's office expects to send out supporting and informational memoranda from time to time to clarify and update policies and actions on the HEW plan. These memos will be sent to the Chancellors of the respective campuses.

5. A faculty development plan is being drafted which would provide financial and leave arrangements to permit the completion of degrees and other activities designed to upgrade the faculty of the black institutions. It is acknowledged that this will tend to give the affected faculty members greater mobility, but they hope that this will be a means of improving overall faculty competence.

6. Dr. Robert Williams distributed information that is being accumulated on the inventory of degrees offered within the University System. Dr. Clark has the N. C. State portion and will check the accuracy and return to Chapel Hill by early next week. The descriptive narrative is given to illustrate the type of information needed but individual institutions were requested to re-write or amend this narrative as needed. We were specifically admonished to keep it within one page.

We pointed out that there are many other aspects of Long Range Planning which needed to be addressed and we requested further meetings at an early date at which problems of allocation of funds and responsibility could be addressed. Another meeting of this group was set for July 24 for this purpose.

On the one hand, we must be sensitive to the intriusic problems of predicting the future, to the limitations imposed by the necessary deferral of final decision about several aspects of this action program, and to the special local characteristics of the constituent institutions. On the other hand, we intend to establish substantial objectives, toward which we will be reaching conscientiously.

The projected goals, presented on an institution-by-institution basis, will be submitted, as a supplement, by no later than March 15, 1974.

Dear Secretary Harris:

On October 5, 1979 you sent to presidents of colleges and universities a letter stating your conclusion that the Supreme Court decision in Southeastern Community College v. Davis requires no changes in the Department's regulation implementing Section 504 of the Rehabilitation Act of 1973. Your letter focuses exclusively on questions concerning the proper interpretation and application of Section 84.44(a) of the Section 504 regulation. In so doing your letter leaves unaddressed questions regarding the impact of the Davis decision on other sections of the regulation. For example, your letter includes no reference to the real question whether the Davis decision requires changes in the preadmission inquiry prohibition set forth in Section 84.42 of the regulation. As Assistant General Counsel of the American Council on Education, a membership organization of over 1,600 colleges and universities, it is in this regard that I write respectfully to request clarification of the position stated in your letter.

As you know, the Supreme Court in <u>Davis</u> held that "[n]othing in the language or history of §504 reflects an intention to limit the freedom of an educational institution to require reasonable physical qualifications for admission to a clinical training program." Your letter recognizes that it is "the institution's prerogative to define the role and purpose of its educational program and to determine academic requirements...." A logical corollary of the freedom to establish legitimate physical requirements for entry into specific academic programs is the freedom to evaluate the ability of applicant's to meet such physical standards. It is in this context that there is an obvious conflict between the holding in the <u>Davis</u> case and the Department's 504 regulation. The Honorable Patricia Roberts Harris -2- October 23, 1979

Section 84.42(b)(4) generally prohibits preadmission inquiries as to whether an applicant has a handicap. Only institutions taking remedial or voluntary affirmative action are exempt from the application of this prohibition. To the extent that this ban is and has been interpreted by the Department to preclude general inquiries as to the ability of applicants to meet reasonable physical standards for admission, the holding in the Davis case and the regulation cannot be said to be consistent. In light of the broad conclusions stated in your letter of October 5, I would appreciate it if you could provide some clarification on this point.

Secretary Harris has asked me to respond to your recent letter inquiring about the Supreme Court's decision in <u>Southeastern Community College v. Davis</u> and its effect on the HEW regulation implementing Section 504 of the Rehabilitation Act of 1973. You questioned whether Section 84.42(b)(4) of the HEW Section 504 regulation (45 C.F.R. Section 84.42(b)(4)) is consistent with the <u>Davis</u> decision. We believe that the regulation is consistent with <u>Davis</u>.

Section 84.42(b)(4) generally prohibits preadmission inquiries about whether an applicant has a handicap. The Supreme Court in <u>Davis</u> did not hold that such inquiries are permissible. Rather, the Court held that a college or university may require that an applicant for admission to a program of instruction be physically able to perform specified functions necessary for participation in the essential aspects of the program. An educational institution may make preadmission inquiries about essential functional abilities, but not about handicap status; as the Court observed, the "mere possession of a handicap is not a permissible ground for assuming an inability to function in a particular context."

Of course, Section 34.42 does contain an exception to its general prohibition against preadmission inquiries about handicaps. Section 84.42(c) permits a college or university to ask about handicap status if the institution is taking voluntary action to overcome the effects of conditions that have resulted in limited participation in its federally assisted program by the handicapped. Educational institutions also are permitted, under Section 84.42(c), to make preadmission inquiries about handicap status if they.

are taking remedial action to correct the effects of past discrimination. However, if an institution is not undertaking remedial or voluntary action, it may not inquire about whether an applicant for admission is a handicapped person.

I hope this answers your questions about the impact of the <u>Davis</u> case on our Section 504 compliance program. Please do not hesitate to contact us if you desire additional information.

Dear Ms. Guthrie:

I received your December 18, 1979 letter, and I appreciate the opportunity to comment with you on the subject at greater length.

As you know, HEW's General Counsel, Joan Bernstein, has said that an educational institution "may make preadmission inquiries about essential functional abilities, but not about handicap status." In my opinion, HEW is trying to find a regulation where none need exist. The line drawn is entirely too thin to enforce. It is reduced to using or not using certain terminology. If a college is going to be sued for such discrimination, then the use of rote regulatory terminology is not going to prevent it. On the other hand, a college's failure to use such rote terminology in the regulations of HEW could well strengthen the plaintiff's case before a court of law.

If we are to follow Bernstein's regulations it appears that we must describe all behaviors needed by applicants in selected programs rather than to list handicaps such as deafness or blindness, which would be incompatable with certain programs. I submit that the listing of <u>all</u> behaviors would be extremely difficult and time consuming, if not impossible. Leaving out <u>one</u> might guarantee the entry of an unqualified student. In the Davis case, we would have had to ask Mrs. Davis, "Are you able to hear and understand direction briefly spoken in a hasty tone whether facing or not facing the speaker?", etc.. All the college needs to know is that it is illegal to discriminate against a qualified handicapped applicant. Such regulations will proliferate on the fringes of this truth to confuse the eligibility of such persons rather than enlighten anyone on anything.

Regarding the inquiry into "essential functional abilities," I propose there is no real difference between that and asking a person what, if any, handicaps he has which will

interfere with the duties of the position. HEW's interpretation and required terminology is another bureaucratic game in semantics much as their ill-fated "otherwise qualified" language which caused such mass confusion about the 504 regulations in the Davis case.

I understand that Joan Bernstein has further ruled that a college <u>may</u> make preadmissions inquiries when it is taking voluntary affirmative action to "overcome the effect of conditions that have resulted in limited participation ... by the handicapped..." The authority by which such unilateral pronouncements are made overwhelms me! How could such motives possibly be analyzed, proved, or enforced? College administrators are indignant about this kind of detailed regulation which seems to grow from HEW's own biases as they seek to correct that of everyone else.

Regarding religious bias rules, I understand EEOC has pronounced an equally absurd rule that job applicants cannot be asked about religious observations which would interfere with work. They <u>can</u> be asked <u>after</u> receiving the job offer! Here it would seem that if you offered a person a job on the right and took it away from him on the left, you would be guaranteeing a law suit, not merely running a greater risk of one.

The fact is that in the Davis case the court recognized the basic essential need for a college to know the qualifications or lack of same of a potential student and to act on that information. Recent court decisions have also recognized that employers cannot be significantly inconvenienced by religious practices. The employer needs to know this immediately, not after a job offer is made.

Dr. Clausen Jenkins, Executive Assistant to the Chancellor, North Carolina State University, Raleigh, North Carolina has some interesting thoughts and observations regarding EEOC regulations and religious discrimination. I think you might like to have his observations before pursuing this matter further.

Thank you for sending me a copy of your letter to Mr. Steinbach concerning our efforts to obtain clarification of HEW's position regarding the validity of pre-admission inquiries under section 504.

Enclosed for your information is a copy of my letter to Secretary Harris of October 23rd and the Department's response signed by HEW's General Counsel, Joan Bernstein. In her letter of December 3rd Ms. Bernstein states that a college or university "may [under the 504 regulations] make preadmission inquiries about essential functional abilities, but not about handicap status." This means that HEW agrees that, without relying on the so-called "affirmative action exception, "colleges may make narrow inquiries of applicants about their abilities to perform effectively functions related to successful completion of the college's particular education program.

I would be interested to know whether you consider the standard for pre-admission inquiries set forth in Ms. Bernstein's letter workable. From your perspective are there compelling administrative or educational reasons why a college needs more flexibility than is provided in the application of the physical function standard the Department has adopted? Your views on this issue would be very helpful to me in deciding what further action ACE should take in this area.

I look forward to hearing from you in the near future. Again, thanks for your supportive letter.

SUBJECT: Affirmative Action Report for SALS

In response to your request dated May 29, 1975, we are enclosing the following material:

- 1. Edited computer read-outs for EPA Faculty and EPA Non-Faculty by reporting units
- Completed tables for EPA Faculty, EPA Non-Faculty, and SPA Personnel
- 3. Narrative statements from four departments

In regard to the EPA Faculty and EPA Non-Faculty listings, we have sought to conform to the 22 reporting Departments and Divisions identified with your memorandum dated May 29, 1975. There are instances where individuals have been redlined or deleted from one Department or Division and added to the appropriate unit. Information is provided for correcting the input computer cards.

Major changes in personnel assignment were involved in the divisions for SALS-Administration, Extension Home Economics and Extension 4-H. No reasonable listing of the SALS-Administration complement was provided. As a consequence, a listing was compiled and is attached to my memorandum dated June 10, 1975, to Dr. Hassler. The Ag Extension listing as forwarded to us has been utilized to identify the personnel complement for Extension Home Economics and Extension 4-H.

We discovered during our compilations that Sociology and Anthropology had previously included both their Liberal Arts and SALS EPA Faculty complement. This has been corrected to include only SALS personnel, and appropriate adjustments were made to our School totals for all years. This change, plus the reconciliation of the personnel composition of SALS-Administration, Extension Home Economics and Extension 4-H, will need to be taken into consideration when individual department or division summaries in your files are reconciled with those attached and compiled, June 1975. In addition, the deletion of EPA Faculty in Liberal Arts has reduced the SALS totals for all years reported. Assistant Provost Lawrence M. Clark -2-

Only a combined table for SPA Personnel including all divisions and departments has been included. Dr. Gehle has confirmed this as being adequate with Dr. Hassler, since it conforms to our previous reporting procedure. The increase in number of SPA for 1975 over 1974 is attributed to the 31 vacancies existing at that time and the addition of 5 personnel from the Division of Research Stations and 18 from the Central Crops Research Station.

All of our EPA appointments have been preceded by approval of AARR by the Office of the Provost. Our advertising has been extensive. Since June 1973 we have increased the number and proportion of women in EPA Non-Faculty. We find the pool of qualified faculty for females and minorities to be most limited. There was increase of three white females for 1975 over 1974. Individual narrative resumes for four departments are attached, and the procedures for our other departments parallel these.

AFFIRMATIVE ACTION STATEMENT

The Department of Economics and Business sent announcements of vacant positions to approximately 400 departments of economics, agricultural economics and schools of business. In addition the American Economic Association has started publishing a bimonthly listing of jobs entitled, "Job Opportunities for Economists." This latter publication is widely distributed and led to a very large number of applications. We did send announcements of job openings to predominantly black schools listing economists on their faculty. We received approximatley 230 applications for our positions with eight female applicants.

We filled six positions with white males and two positions with white females this year. Our remaining vacancies (5) are in the School of Agriculture and Life Sciences. To this point, we have been unable to obtain applications from females or blacks for any of these positions. In fact, we have been unable to obtain many applications of any kind for these positions.

For the last SPA position filled, we had nine applications from white females only. We do have three black secretaries in the Department.

Department of Veterinary Science Recruitment for 1975-1976 Narrative Report

The Department of Veterinary Science has filled an open position effective July 1, 1975. The following is an outline narrative of the position and recruitment procedures.

III. Consideration and Review of Candidates

Curriculum vitae and other materials submitted by candidates were examined independently by members of a departmental screening committee. Each ranked candidates on the basis of (1) professional qualifications, (2) experience and competence demonstrated, (3) compatibility and/or support by the candidate's area of interest to existing faculty and departmental objectives, and (4) an estimate of the candidate's potential for outstanding performance and contribution.

The screening committee presented and discussed their reviews collectively with the Department Head and recommendations were made for action. Attachment #2 is a summary list of candidates and actions.

Among the 4 candidates interviewed were 3 white males and 1 black male. The position was offered to a white male who declined because of insufficient salary and academic rank. It was subsequently offered to a second white male who accepted.

AFFIRMATIVE ACTION REPORT FOR THE SCHOOL OF DESIGN, 1974-75 Submitted June 20, 1975

At the end of the 1974-75 academic year, the School of Design has made some progress in meeting our affirmative action goals. There has been a significant increase of three women faculty members. This meets the 1975-76 goal. But one Black faculty member was lost and was not replaced. Therefore, the School has lost ground in this most important area. We remain two Black faculty members short of the 1975-76 goal.

In this report for 1973-74, Roger Clark recommended that the School identify and recruit Blacks vigorously. The Affirmative Action officer is concerned about our inability to fulfill our commitment in the School of Design at this time to secure Black faculty members. There is a solution: the top administrators in the School could commit the School to fill several positions with only Blacks as done this year with our SPA recruiting.

One bright spot in Black recruitment has been the students' effort, with the assistance of the Dean, to contact and attract potential Black students. Although this will not begin to "pay off" until 1976, the student effort has been commendable. The School should commit itself to following this up with whatever is necessary to attract a significant number of Black students. Specific programs include another intensive high school recruiting campaign and a summer program for potential students.

1. Attached is the Affirmative Action Plan Report for the School of Education which includes EPA Faculty, EPA Non-Faculty and SPA data as follows:

- a) Consolidated School of Education
- b) Adult and Community College
- c) Agricultural Education
- d) Center for Occupational Education
- e) Curriculum and Instruction (formerly Division of Education)
 - f) Industrial Arts Education
 - g) Industrial and Technical Educttion
 - h) Mathematics and Science Education
- i) Psychology
- j) Introduction to Vocations
- k) Office of the Dean (which includes Office of Publications, Curriculum Materials Center, and Computer Facility).

2. A brief explanation of the Affirmative Action Plan of the School of Education is offered.

A. EPA Faculty

Two blacks, Dr. Lawrence Clark and Dr. William Maxwell, serving as professors of Education in Mathematics Education and as Associate Professor of Education, respectively, are not counted in these data by virtue of their other positions, Assistant Provost and Associate Dean, respectively. One black female was hired as instructor in August, 1974. This instructor resigned at the end of the Fall, 1974, Semester, in order to devote full-time to completing her doctoral work at Duke University. Therefore the figure of one black out of a Page 2 Assistant Provost Lawrence Clark June 23, 1975

total faculty of sixty-six is misleading. Three out of sixty-eight, or four percent, would be more accurate for the School, but for accounting purposes.

It should also be noted that intensive recruiting efforts were exerted to find qualified Blacks for the anticipated 1974-75 vacancies. Two Blackswere offered a position in the Guidance and Personnel Services Department, but both declined the offer. Persistent effort, however, finally paid off in that one black has accepted the offer to join that department for the Fall, 1975, semester.

B. EPA Non-Faculty.

Most of these ten positions are filled by persons holding a doctoral degree. Again, the absence of Blacks reflect the market and not our recruiting efforts. The School will continue its policy of sustained effort to identify qualified Blacks whenever a vacancy is anticipated in any of these positions.

C. SPA

Eight of the thirty-four SPA positions are filled by Blacks. This represents twenty-four percent of the positions. Beyond these raw figures, this achievement, exceeding the long-range goal of twenty-percent, has been accomplihed with minimal difficulty. All of the SPA personnel work in an atmosphere of cordial respect and with less employee tension than normal in a racially homogenous operation. The School of Education is proud of this achievement.

3. The above listing of reporting units reflects the previous departmental organization of the School. Future reports will reflect the present (June, 1975) organizational pattern.

MEMORANDUM

TO: Larry Clark Associate Provost

FROM: Robert O. Tilman

We are making headway slowly on our Affirmative Action Program, though I suspect this School is nevertheless doing better than most on campus. Seven of our eight departments recruited new EPA personnel during the 1974-75 academic year. These seven departments received approximately 3500 applications for 20 available positions. Of these 3500 applicants about 750 were females. We were able to identify less than ten blacks, though it is probable that there were more since we do not request or receive information on racial origins. We interviewed some 135 candidates for the 20 positions. Of these 35 were female and six were black. We ultimately hired five females and three blacks for fall 1975. I think the following table demonstrates our determination, commitment, and progress.

In both cases we have succeeded in interviewing and hiring a larger percentage than was represented in the original applicant pool. I should add that we have also done this without any lowering of standards, and, indeed, it has occurred at a time when our standards have probably been rising.

Among our SPA staff the School now employs a total of 10 blacks and 5 males. While it is unlikely that we shall ever have a significant number of male SPA employees, our percentage of blacks (24%) fairly well represents the percentage of blacks in the surrounding community. I should also point Memorandum to Larry Clark Page 2 June 24, 1975

out that beginning July 1 we shall have two black departmental head secretaries out of a total of nine.

Our affirmative action plans have been frustrated by a failure to receive expected new positions and by a reduced turnover among our current employees. However, we are doing our best and will continue to do so.
