

Constitution of Adventist Christian Fellowship
North Carolina State University

Article I: **Name and Purpose**

- Section I: This organization shall be known as Adventist Christian Fellowship.
- Section II: The Purpose of this organization is to exalt the name of Jesus Christ as both Savior and Lord, to build one another up in Christian fellowship, while promoting wholesome worship, discipleship and evangelism.

Article II: **Membership**

- Section I: Membership shall be open to all students who are currently enrolled in North Carolina State University both Undergraduate and Graduate Students attending this university. Adventist Christian Fellowship is an open organization and it welcomes the involvement of all students attending North Carolina State, regardless of background, race, sex, handicap, religion or national origin.
- Section II: Potential Members shall fill out an application in order to be a part of the organization, and they will be required to abide by the bylaws of the organization, bylaws that will be decided and voted upon by the members of the organization.
- Section III: No membership dues shall be required to join this organization

Article III: **Officers**

- Section I: The elected officers of this organization shall be the President, Vice President, Public Relations Representative, and Treasurer.
- Section II: To be eligible to serve as an officer, the student must be in good academic standing at the time of his/her election. In addition, the student may be deemed ineligible for office if found guilty by the Student Judicial Board for violating the rules of Student Conduct.
- Section III: The elected officers shall serve a term of one year beginning in August and ending in May. New officer elections shall be held in March, two weeks after spring break for the upcoming academic year.
- Section IV: The Public Relations officer shall handle voting procedures and every member is entitled to one vote. The winners of contested positions need only a simple plurality with the votes.

Article IV: Amending the Constitution and Bylaws

Section I: Amendments to the constitution or the bylaws shall be presented by members in the organization in writing and then read at a regular meeting but shall not be voted until the next regular meeting, and then only after informing each member to the proposed amendments. A majority of $2/3$ for the members present at the voting shall be required.

Article V: Meetings

Section I: Meetings shall be weekly and they shall be determined by the general body at the beginning of the academic school year.
