Article I. Name and Purpose

Section I. This organization shall be known as the African Student Union.

The Purpose of this organization will be to promote African Culture here on the campus of North Carolina State University, and to promote the importance scholarship and service.

Article II. Membership

Section I. Membership shall be open to all North Carolina State University students.

Article III. Officers

Section I. The elected officers of this organization shall be the president, the vice president, the secretary, the treasurer, and the historian.

- -The president shall be the chief executive officer for the organization; he or she shall be present at all regular and special meetings, and appoint all committee chairpersons.
- -The Vice president shall assume the duties of the President when the President is not available, and shall be directly responsible for oversight of all committee activities.

Section II. -The Secretary shall record the minutes of all organizational activities and keep all official records. It will be duty of this person to communicate with organization membership and all organization correspondence.

-The Treasurer shall receive all monies, writing receipts, and shall deposit and disburse monies in accordance with the constitution. He or she shall maintain all financial records.

-The Historian shall keep log of all organization programs and activities and have primary responsibility of developing a scrapbook for the organization.

Section III. Elections- Nomination of all officer shall be made directly from the floor. The officers shall be elected in the beginning of every school year, unless otherwise needed anytime while school is in session. Members have to be present during the voting. Winners will be based on majority vote.

Section IV. Dues- Dues shall be in the special assessments voted on by the majority of the member present and voting.

Article IV. Meetings
