AFROTC Honor Guard Constitution 15 Mar 08

#### Article I

#### Section I

This organization shall be known as the AFROTC Honor Guard.

#### Section II

The purpose of this club is to train and equip AFROTC cadets to properly display the nation's colors at various sporting and university events. Additionally we train to represent NCSU at the annual Tulane drill competition.

#### Article II

#### Section I

Membership is open to any AFROTC cadet interested in improving drill performance and representing the United States Military by presenting our nation's colors.

#### Section II

Membership is determined by the following requirements each semester:

- -Attend 70% of practices
- -Complete 3 color guards
- -Remain enrolled in AFROTC
- -Attend 1 fundraising event

#### Article III

#### Section I

Club officer in charge (OIC) each semester will be the cadet chosen to fill the position of Honor Guard Squadron Commander, which is determined by the AFROTC cadet wing commander for that respective semester. This cadet will always be upperclassmen. The OIC will be in charge of fulfilling color guard commitments to the university and keeping all pertinent records, including the budget.

The trainer position will be selected by the OIC. This cadet will be responsible for planning and conducting color guard training.

#### Section II

Each position will be held 1 semester.

#### Article IV

#### Section I

Dues for the semester will be paid in the form of the fundraising event required. Additional fundraising may be necessary to meet budget needs.

#### Article V

#### Section I

Any requested amendments to the constitution will be reviewed by the OIC as well as the Group Commander. All amendments must comply with Air Force regulations.

#### Article VI

#### Section I

AFROTC Honor Guard will meet for one hour a week on Sunday afternoons. Additional practices will be scheduled as need for competition.

## Constitution Of The Wolfpack Warrior Booster Club

#### Article I. Name

The organization shall be known as the Wolfpack Warrior Booster Club.

#### Article II. Purpose and Goals

The purpose of this club shall be to financially support the activities/supplies enjoyed and needed by the members of the Wolfpack Warrior Booster Club.

#### Article III. Membership

- Section I. Initial membership shall be granted upon the payment of the predetermined membership fees, which are decided by the officers of the club. Membership in the Wolfpack Warrior Booster Club ends at the conclusion of the spring semester. For a member to remain in good standing, the member must be on track to complete a predetermined amount of fundraisers each semester.
- Section II. Membership shall be divided into five classes. The five individual classes are based on the AS class(es) that the person is in enrolled in. They are classified as first-year membership, second-year membership, third-year membership, fourth-year membership, and fifth year membership. For people not enrolled in an AS class(es), membership classification is dependent on how long they have continuously been a member.
- Section III. Each member is responsible for completing a predetermined amount of fundraising events with the Booster Club. The officers of the Wolfpack Warrior Booster Club are to decide this number. If a member chooses not to complete predetermined fundraising events by the end of the fall semester, that member will lose membership status and all advantages associated with it at the start of the spring semester. The membership process starts over after the spring semester.
- Section IV. Members in good standing receive free Dining-In, Military ball, plus free and discounted prices for other planned events/activities.

### Article IV. Description of Boards

- Section I. The officers of the club shall make overriding decisions concerning issues within the Wolfpack Warrior Booster Club. These officers will be comprised of one member from the each of the five classes. Potential candidates are self-nominating and should not presently be a member of the AFROTC Det. 595 Wing Staff. The president shall be the fourth year

member and he/she shall have overriding authority. The Vice-President of the booster club will be the third year member and that member shall have overriding authority when the President is absent from booster club functions.

- -Section II. An Advisory Board consisting of all members of the Wing Staff will make decisions on spending. They will also make votes on amendments and elections when necessary. The Advisory Board consists of seven members and they will change every spring and fall semester.
- -Section III. The duties of the officers are to collect the membership fees and to oversee the Wolfpack Warrior Booster Club fundraising. The officers are also responsible for tracking attendance at fundraising events and accountability of funds.
- -Section IV. The officers shall meet at least once every two weeks to make certain the financial aspects of the Wolfpack Warrior Booster Club are running smoothly.
- **-Section V.** The current officers shall also ensure elections of the following officers run smoothly at the end of each fall and spring semester. It is the responsibility of at least one of the current officers to attend the first two meetings of the new officers.

#### Article V. Officers

- Section I. The elections for the second year through fifth year member representatives shall take place on the third-to-last week of the spring semester. Each representative's term will run from the second-to-last Monday of the spring semester until the second-to-last Monday of the next spring semester. The election of the first year class member will be held on the fourth week of the fall semester. The term for the first year representative will end on the second-to-last Monday of the spring semester.
- Section II. The Advisory Board, consisting of the wing staff, must reach a unanimous vote to remove any officer. If the President is removed by the Advisory Board, or chooses to leave at his own discretion, the Vice-President shall assume overriding authority until a new President is elected. Elections to fill vacant slots can be held at any time during the year if the Advisory board sees fit.

#### Article V. Finances

The only people authorized to write checks or authorize money are the President, Vice-President, and a member of the Advisory Board. All member fees and fundraising monies that are collected by the Wolfpack Warrior Booster Club are to be deposited in the Wolfpack Warrior Booster Club bank account. The President is responsible for depositing all funds into the Wolfpack Warrior Booster Club's bank account within 72 hours after initially receiving the funds. The officers are not sanctioned with the ability to initiate spending of funds. The officers retain the power to veto spending programs.

#### Article VI. Amendments and Ratification

Under the officers' suggestion, the Advisory Board can amend or ratify the constitution and bylaws. Amendments only become permanent through a five-sevenths vote of the Advisory Board, after a four-fifths initial vote from the officers. Once an Amendment has been passed, the President has until the next general meeting of all members to publicly announce the changes that will affect the club.

# Cadet Association of "Wolfpack Warriors"

Article I	Section 1	This organization shall be known as the Cadet Association of Wolfpack Warriors.
	Section 2	The purpose of this club shall be to foster morale, build esprit de corps, and financially support the cadets of AFROTC Det 595.
Article II	Section 1	Membership will be granted upon the payment of the predetermined membership fees. Each member must attend two fundraising events per semester.
Article III	Section 1	The elective officers for this club shall be: President-WC, Vice President-CV, Treasurer-LG, Activities Coordinator-SG, Sergeant at Arms-OG, Secretary-CCE, Public Affairs-GA.
	Section 2	The officers shall be elected by the club members to serve a term of one semester, beginning at the start of each semester.
Article IV	Section 1	Dues will be set according to budget at the beginning of the semester. Each member must participate in at least two fundraising events or forfeit benefits of club membership.
Article V	Section 1	Amendments to the constitution or by-laws shall be presented by officers of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member for the proposed amendments. A majority of 2/3 for the officers present and voting shall be required.
Article VI	Section 1	Meetings will be fulfilled at wing staff meeting, and meet weekly at a time decided at the beginning of the semester by the voting members of the club. The club shall operate in accordance with appropriate AFROTC operating instructions.
