# All-In Hold'em Poker Club Constitution 12/04/2007

#### ARTICLE ONE - NAME AND PURPOSE

#### Section 1 - Name

From henceforth this Student Organization shall be known as "All-In Hold'em Poker Club." It is a Student Organization comprised of currently enrolled Students at North Carolina State.

## Section 2 - Purpose

The All-in Hold<sup>2</sup> em Poker Club is designed to both carryout social events for the benefit of its members and North Carolina State University and educate it's members and the North Carolina State University community of theory behind No Limit Texas Hold'em without the use of gambling.

## **ARTICLE TWO – MEMBERSHIP**

Membership shall be open to all regularly enrolled students who are interested in the education of poker theory through play and discussion.

## Section 1 - Regular Membership

Regular membership shall be currently enrolled students in the University, be a student in good standing, remain a student in good standing, pay dues, and be active in the club.

## Section 2 - Honorary Membership

Honorary membership may be granted to whomever the current active members desire. To bestow such an honor, they are subject to the recommendation and confirmation of the current active members by a simple majority vote. Removal of honorary members will require a two-thirds majority vote from all active members.

### **ARTICLE THREE – OFFICERS**

The power of general oversight of the club shall be vested in the officers of the club.

#### Section 1 – Officer Composition

The leadership of the club shall be comprised of:

- A. President;
- B. Vice President;
- C. Secretary; and,
- D. Treasurer.

#### Section 2 – Officers Elections

The election of officers shall occur before the last scheduled meeting in the spring semester by a simple majority vote of active members.

## Section 3 – Officers Terms

The term of each officer shall be one year, beginning in the last regularly scheduled meeting of the spring semester.

#### Section 4 – Officers Vacancies

Vacancies created by the resignation or removal of a duly selected officers shall be filled by a replacement member selected by the same methods as the original member and shall serve the duration of the unexpired term.

## Section 5 – Officers Duties

The officers of the All-In Poker Club shall:

- A. accept nominees for the positions of the stated officers;
- B. prepare the annual programming budget and present it to the members of the club for their approval;
- C. gather and present a list of proposed Emeritus and Honorary members for the club to approve;
- D. schedule programs and activities for the club;
- E. maintain a checking account;
- F. review and approve or reject all changes in programming

## Section 6 – Authority

The officers shall be responsible for the execution of the policies, programs, and activities of the organization.

#### Section 7 – General Qualifications

Each officer shall at the time of their selection be a regularly enrolled student in the University, must remain an enrolled student in the University, be a student in good standing, and remain a student in good standing.

## Section 8 - Line of Succession

If the President is removed or leaves office for any reason, the Vice President shall serve the remainder of his or her term. If for some reason, the position of Vice President is vacated, then the Secretary shall succeed to the position of Vice President. If for some reason the position of Secretary is vacated, then the Treasurer shall succeed to the position of Secretary. If for some reason all positions become vacant, then there shall be an election to fill the vacated position in the same manor as the other officers were selected.

## ARTICLE NINE -MEMBERS RIGHTS, PRIVILEGES, POWERS, AND DUTIES.

The members of the All-In Poker Club shall:

- A. nominate members of the club seeking a leadership role as an officer;
- B. approve officers of the club by a simple majority vote;
- C. set the amount of dues paid by any given member;
- D. establish a yearly budget by a simple majority vote;
- E. change the structure and content of the governing documents by a two-thirds majority vote;
- F. award honorary membership by a simple majority vote; and,
- G. receive and administer gifts and request appropriations through the NCSU Student Body appropriations process and request as needed funding through the NCSU Union Activities Board.

# **ARTICLE TEN – DUES**

Each member shall pay dues as prescribed by the current members.

## **ARTICLE ELEVEN – MEETINGS**

Meetings are to be determined by the club membership each semester.

#### **ARTICLE TWELVE – PROGRAMMING**

All programs and activities shall be planned, supervised, and executed by the Organizations Officers.

# **ARTICLE THIRTEEN – COMMITTEES**

The club shall make provision for any standing committees needed and/or for forming any special committees when needed.

## ARTICLE FOURTEEN - THE ORGANIZATIONS CONSTITUTION

The Organizations Constitution shall be the by-laws of this club. Amendments to the by-laws shall require a two-thirds majority vote by the current active members. The Organizations Constitution shall be published in such a way that it is readily available to the Student Body.
