

Constitution
Of
ALPHA PI OMEGA SORORITY, INC.

January 28, 2005

Article I

Name and Purpose

Section 1. The name of this organization shall be Alpha Pi Omega Sorority, Inc.

Section 2. The purpose of this organization is to uphold the founding principles of Alpha Pi Omega Sorority, Inc. and to create a strong sisterhood that shall support college women in today's society.

Article II

Membership

Section 1. Application for membership into Alpha Pi Omega is open to women who have at least 12 credit hours, a 2.3 cumulative GPA, and no previous Greek affiliation, other than honorary organizations.

Section 2. The members shall be those sisters of Alpha Pi Omega Sorority, Inc. who have successfully completed the Sorority's honey process.

Article III

Officers

Section 1. The elected officers of Alpha Pi Omega Sorority, Inc. shall be a President, a Vice President, a Treasurer, a Secretary, a Historian, a Chieftess, a Keeper of the Flame, a Keeper of the Spirit, a Dean of Honeycombs, a Circle Scholar, a Busy Bee, and a Social Director.

Section 2. Nominations for officers shall be held at the first meeting in April.

Section 3. The officers shall serve one year beginning the close of the meeting at which they are elected.

Article IV

Dues

Section 1. Dues shall be determined at the first meeting for the school year and shall cover the entire school year.

Article V

Amendment of the Constitution

Section 1. Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the members present and voting shall be required. Amendments shall take effect upon their approval by the Grand Keepers of the Circle of Alpha Pi Omega Sorority, Inc.

Article VI

Meetings

Section 1. The regular meeting of the organization shall be determined at the first meeting of the school year.

Section 2. The organization will have at least two business meetings per month and one sisterhood meeting.

Section 3. Business meetings shall consist of all oral and written reports of officers, committees, and clans, and any other business that may arise in the organization. Written reports must be typed using Garamond font.

Section 4. Sisterhood meetings shall consist of any activity and shall not include business that is to be discussed in a business meeting.

Section 5. Special meetings of the organization may be called by the President and shall be called upon with written request from at least two members of the organization. The purpose of the meeting shall be stated in the call and no other issues other shall be addressed at the special meeting. At least three days notice shall be given.

Article VII

Committees

Section 1. The organization shall make provision for any standing committees needed and/or for forming any special committees needed.

Article VIII

Parliamentary Authority

Section 1. The rules contained in the current edition of *Robert's Rules of Order Newly Revised* shall govern the organization in all cases which they are applicable and in which they are not inconsistent with this constitution or The *Articles of Incorporation, Bylaws, and Special Rules of Order of Alpha Pi Omega Sorority, Inc.*
