The Constitution of ASB – team Arizona 1 October 2005

Article I Name & Purpose

Section 1

This organization should be known as Alternative Spring Break - team Arizona.

Section 2

The purpose of this club is to conduct a service project during spring break in Tuba City, AZ

Article II Membership

Section 1

Membership should be open to all regularly enrolled students who show interest in service and learning.

Section 2

All members will be chosen through applications available at the Center for Students, Leadership, Ethics, and Public Services (CSLEPS) office. The application process will initially put a member in the pool of applicants and chosen based on a future member's preferences.

Article III Officers

Section 1

The elected officers for this club shall be the Team Leader, Fundraising Chair, Volunteering Chair, and On-site Manager

Section 2

The Team Leader will be selected through CSLEPS and granted the authority of all trip planning.

Section 3

The Fundraising Chair, Volunteering Chair, and On-site Manager will be elected by the other members and will serve a term of one year.

Article IV Dues

Section 1

Dues for the club will be \$740 per year

Article V Amending the Constitution

Section 1

The constitution may be amended by the Team Leader and must meet the approval of the club advisor and one third of club members' votes. The voting will take place at the next club meeting following the proposed changes. At least one half of the club must be present for an amendment to be discussed.

Article VI Meetings

Section 1

Meetings will take place on a monthly basis or when the Team Leader or club advisor deems necessary.

Article VI Committees

Section 1

There will be two standing committees: volunteering and fundraising. The elected chairs will head these committees and make decisions as necessary or requested by the Team Leader. Special committees will be created based on needs.

ALTERNATIVE SPRING BREAK DELEGATION

CONSTITUTION

Article I. Name and Purpose.

- 1. This organization shall be known as the Alternative Spring Break Delegation.
- 2. The purpose of this organization shall be to engage in a community service project in a foreign country during Spring Break.

Article II. Membership.

1. Membership is open to all students who are chosen by ASB leaders, with the direction and guidance of NCSU's Center for Student Leadership, Ethics, and Public Service.

Article III. Officers.

- 1. The elective officers of this organization are president, vice-president, treasurer, and secretary.
 - 2. Officers shall have terms of one semester, beginning in January.

Article IV. Dues.

1. The amount of dues shall be determined by the organization leadership, and payable in four installments at dates determined by the officers.

Article V. Meetings.

1. The organization shall meet regularly at dates to be determined by the leadership.

Article VI. Committees.

1. Committees shall be formed at the discretion of the organization leadership.

Article VII. Amendments.

- 1. Amendments to this constitution must be approved by the organization's president.
- 2. Amendments must be approved by a majority of the organization's membership, at a meeting for which quorum is defined as 2/3 of the organization's membership.
