CONSTITUTION AND BYLAWS: NORTH CAROLINA STATE UNIVERSITY CHAPTER OF THE AMERICAN SOCIETY OF LANDSCAPE ARCHITECTS

(as amended on September 29, 1986)

PREAMBLE:

The name of this organization shall be The North Carolina State University Student Chapter of the American Society of Landscape Architects.

The objective of the Chapter shall be to unite all students interested in Landscape Architecture and combine their interests and efforts to extend their knowledge of the practice of Landscape Architecture, complementing and extending the curriculum at North Carolina State University; and to help advance the profession' visibility. Specific goals shall be:

- 1) To encourage communication between our Chapter and other students of Landscape Architecture and/or related disciplines; and to improve and encourage active communication between other student chapters and the State/Regional Chapter of ASLA in an effort to strengthen the common goals of each as well as to maintain visibility/awareness of the profession and all of national ASLA programs.
- To develop vehicles to solicit presentations and demonstrations of subjects related to Landscape Architecture.

ARTICLE I: Membership

- Section 1. Eligibility: The following individuals shall be eligible for membership in the ASLA Student Chapter:
 - A. Any student who is interested in the profession of Landscape Architecture.
 - B. Any interested faculty member.
- Section 2. Advisor: A representative from the Landscape Architecture faculty shall act as advisor.
- Section 3. NCASLA/ Student Chapter Liaison: The North Carolina Chapter of the American Society of Landscape Architects (NCASLA) Student Liaison shall be an ex-officio member of the Student Chapter and shall have no voting privileges.

ARTICLE II: Governing Organization

- Section 1. Executive Council: The Executive Council shall consist of the Student Chapter officers; the President, Vice President, Treasurer, Secretary and Committee Chairpersons.
- Section 2. Qualifications for Executive Council members: All council positions shall be filled by graduate students of Landscape Architecture and/or students of Environmental Design who:
 - A. have declared Landscape Architecture as a major.
 - B. are an active member of the ASLA Student Chapter.
 - C. have and maintain a 2.0 grade point average.

Section 3. Duties of the Student Chapter officers:

A. President: The President shall preside over all General and Executive Council meetings, shall form committees as needed, appoint committee chairpersons with the approval of the Executive Council; shall allocate duties and responsibilities to other elected officers beyond their stated duties; shall coordinate all Student Chapter communication outside the Student Chapter; shall be responsible for executing all business as directed by a majority vote of the members; shall represent the Student Chapter as an ex-officio member of the North Carolina ASLA (NCASLA) Chapter Executive Committee.

(ARTICLE II continued)

- B. Vice President: The Vice President shall assume the duties of the President in his/her absence; shall preside over Committee Chairpersons and report their progress to the President and the Student Chapter; and shall act as Parlimentarian at all General Chapter Meetings.
- C. Treasurer: The Treasurer shall supervise collection of all fees, dues, charges and other monies due the Student Chapter; shall maintain accounts and records of all transactions and monies recieved and paid out of the Student Chapter funds; shall supervise the auditing of the accounts, which shall be open at all times to inspection by the President and the Executive Council; shall be responsible for the deposit and withdrawal of funds; shall give financial reports to the Executive Council, the University and as required at Student Chapter meetings.
- D. Secretary: The Secretary shall be responsible for recording and maintaining minutes at each General and Executive Council meeting; shall maintain an accurate file of Student Chapter correspondence, constitution and other items of presevable importance; shall record all voting results; shall be responsible for the Student Chapter printing and typing needs; shall be responsible for the advertisement of all meetings; shall submit an annual report of the Student Chapter activities to the ASLA Student Services Committee; shall be responsible for reporting election results of Student Chapter officers to ASLA administrative headquarters.
- Section 4. Committee Chairpersons: Committee Chairpersons shall be active members of the Student Chapter appointed to lead specified committees.

ARTICLE III: Procedures

- Section 1. General Meetings: General Meetings shall consist of the membership of the chapter.
 - A. Regular General Meetings shall be held monthly during the academic year with seven days notice given to the membership.
 - B. Special General Meetings shall be held at the request of the Executive Council with three days notice given to the membership.
- Section 2. Executive Council Meetings: Executive Council Meetings may be called by any officer with a quorum consisting of three officers.
- Section 3. Parliamentary Procedure: Robert's Rules of Order shall be used as a guidline in conducting activities during the General Chapter Meetings.

ARTICLE IV: Ratification and Amendments

- Section 1. Ratification: Ratification of this constitution shall consist of being presented at a General Chapter Meeting of the ASLA Student Chapter which there is a quorum of twenty percent of the membership, and approved by a majority vote (fifty percent plus one) of the members present.
- Section 2. Amending the Constitution: Amendments to this constitution will become effective through the process of Ratification as set out in ARTICLE IV, Section 1.
- Section 3. Any article of this constitution or part thereof that is in direct violation of the Student Government constitution or by-laws shall be null and void and declared unconstitutional by the President of Student Government. Any differences of opinion between the club and the President of Student Government shall be brought before the Legislature, whose decision shall be final.

ARTICLE V: Dues and Finances

- Section 1. Dues: The Student Chapter shall assess dues from all members. The dues fee shall be established on an annual basis by the Executive Council prior to the first Fall Semester meeting and shall be collected and maintained by the Treasurer. All dues and funds collected shall be for the exclusive use of the Student Chapter towards accomplishing the goals of the Chapter. No portion of the funds shall inure to the benefit of any person whomsoever.
- Section 2. Disposal of Monies at Disbandment: If disbandment of the Chapter should occur, all remaining monies after payment of outstanding debts, shall be donated to the North Carolina Chapter of the American Society of Landscape Architects Scholarship fund.
- Section 3. Expenditures: The Executive Council shall have the power to allocate funds for the ASLA Student Chapter.
- Section 4. Check Signing: Checks must be signed by the Treasurer or the President.

ARTICLE VI: Nominations and Elections

- Section 1. Nominations and Elections:
 - A.Candidates for Student Chapter offices shall be nominated from the floor of a General Chapter Meeting.
 - B. Voting for each office shall be by closed ballot and shall occur immediately after nominations for that office are closed and shall be decided by a simple majority of a quorum.
 - C. Public announcements must be posted at least one week prior to nominations and elections.
 - D. Elections for officers shall be held during the last half of Spring Semester with terms of office commencing on the last day of final exams.
- Section 2. Terms of Office: The term of office for all officers and committee chairpersons shall be one year.
- Section 3. Vacancies: Vacancies of offices are to be filled by simple majority vote of quorum on candidates nominated from the floor at the next General Chapter Meeting.
- Section 4. Removal from Office: Executive Council Members who are absent two consecutive General Chapter Meetings or have a total of three absences during any one semester may be subject to removal from office by majority vote of a quorum at the next General Chapter Meeting.

- 4. Have and maintain a 2.0.

Section III. Expenditures

The Executive Committee shall have power to allocate funds for the ASLA Student Chapter.

Section IV. Check Signing

Checks must be signed by the treasurer and cosigned by the president or faculty advisor.

Article III. Procedures

Section I. Meetings

1. Meetings of the ASIA Student Chapter shall be held at least once monthly during the academic year.

2. General Meetings

A quorum shall consist of 20% of the members of the ASLA Student Chapter.

3. Special Meetings

Special meetings shall be called at the request of the presiding officer.

4. Executive Meeting

May be called by any officer with quorum consisting of three officers.

Section II. Ratification

Ratification of this Constitution and its amendments shall consist of being heard at a meeting of the ASIA Student Chapter and approved by a majority vote of the members present.

Section III. Nominations and Elections

1. Candidates for Executive Council shall be nominated from the floor.

- 2. Voting for each Council position shall be by closed ballot and shall occur immediately after nominations for that Council position are closed, and shall be decided by a simple majority of quorum.
- 3. Public announcements must be posted at least one week prior to nominations and elections. This does not apply to Spring Semester, 1981.
- 4. Elections for Council members shall be held during the last half of Spring Semester with terms of office commencing immediately.

Section IV. Terms of Office

The term of office for all Council members shall be one calendar year.

Section V. Vacancies

Vacancies of Coucil positions are to be filled by simple majority vote of quorum on candidates nominated from the floor.

Section VI. Removal from Office

Council members who are absent two consecutive regular meetings of have a total of three absences during any one semester may be subject to removal from office by majority vote of a quorum.

Section VII. Fees

To become a member of the ASIA Student Chapter each student or faculty member shall be required to pay a fee of \$2.00 per year and maintain an active membership in the Chapter.
