# CONSTITUTION OF THE ANIMAL SCIENCE GRADUATE STUDENT ASSOCIATION NORTH CAROLINA STATE UNIVERSITY

#### ARTICLE I. NAME

The name of this organization shall be the Animal Science Graduate Student Association. It shall be hereinafter referred to as the ANS GSA.

#### ARTICLE II. OBJECTIVES

The objectives of this organization shall be:

- To disseminate information of interest or importance to the graduate students involved in ANS programs;
- (2) To provide a forum for discussion of problems and other matters of importance to the students of North Carolina State University; and
- (3) To organize and conduct professional and social activities for ANS graduate students.

# ARTICLE III. MEMBERSHIP

Membership shall consist of all graduate students who are pursuing a degree with a major in the field of ANS, associated programs, or under the guidance of a member of the ANS faculty.

# ARTICLE IV. AMENDMENTS

Amendments to this constitution shall be passed by a simple majority of the votes present at the second reading of the proposed amendment. The first and second readings shall occur at consecutive regular meetings. Such amendments shall not take effect until they are ratified as provided for in the ANS GSA constitution. The Executive Board must review this constitution and consider making revisions at least once every five years.

# ARTICLE V. BY-LAWS

# Section 1. Election of Officers

- A. The permanent offices shall be those of President, Vice-President, Secretary, Treasurer, UGSA Representative, Alternate UGSA Representative, and Graduate Education Committee Representative.
- B. The Executive Board shall consist of the President, Vice-President, Secretary, and Treasurer. The Executive Board is encouraged to meet in order to assist the President in developing agendas for ANS GSA meetings.
- C. Regular elections shall be held in April of each year at a regular meeting. These elections shall be announced by the presiding officer two meetings prior to the regular elections.

- D. Special elections shall be held whenever one of the permanent offices becomes vacant. All vacancies shall be announced by the presiding officer at the first possible meeting, and the election shall be held during the next regular meeting.
- E. A description of the officer positions shall be distributed to the membership prior to the opening of nominations.
- F. Each position will be elected individually using a sliding ballot in the order listed in Article V.1.A.
- G. Nominations
  - 1. Shall be opened by a majority vote two meetings prior to the regular elections and may not be closed for a period of at least three weeks
  - 2. Shall come from the membership, must be seconded, and may be declined without repercussions
  - Shall be made at a regular meeting, but may be submitted in writing to the presiding officer prior to a meeting during which nominations will be open
  - 4. Shall be posted at a specified place until the end of elections
  - 5. Shall be closed immediately prior to elections by a majority vote
- H. All elections shall be won by a simple majority of the votes present. If no person receives a majority of votes, the two candidates receiving the most votes shall have an immediate runoff. In the event of a tie, the presiding officer will vote to break the tie.

# Section 2. Removal of Officers

- A. An officer may resign by submitting a written or email notification to the Executive Board. Early notification of the intent to resign is strongly encouraged.
- B. An officer may be removed from office by a two-thirds majority of the votes present at the next regular meeting after the one at which the motion is introduced.

#### Section 3. Duties of Officers

- A. The President shall represent ANS GSA at ANS functions, prepare and distribute an agenda for all ANS GSA meetings, call and preside over ANS GSA meetings, appoint ANS GSA committees and their chairs, call ANS GSA elections whenever necessary, and prepare an annual activity report to be added to ANS GSA archival information.
- B. The Vice-President shall preside over ANS GSA meetings at the request or absence of the President, maintain the ANS GSA website, maintain the ANS GSA membership directory, and assist the Treasurer in preparation of the budget.
- C. The Secretary shall maintain minutes of the ANS GSA meetings and circulate copies to the members, maintain a roll of members and call the roll whenever a roll call is taken, maintain the ANS GSA bulletin board and calendar, and provide a reference copy of Robert's Rules of Order at each meeting.
- D. The Treasurer shall keep the ANS GSA financial records and prepare an annual budget prior to the first meeting of the fall semester with the assistance of the Vice-President.
- E. The UGSA Representative shall represent ANS GSA at all University Graduate Student Association meetings and functions, disseminate pertinent UGSA

information to the ANS GSA, and comply with all duties of the UGSA Representative as specified by the UGSA constitution. The UGSA representative is responsible for registering ANS GSA with the Student Organization Resource Center prior to October 1 of every year and for completing all other requirements for good standing in the UGSA as specified by the UGSA constitution.

F. The Alternate UGSA Representative shall take over all duties of the UGSA Representative should the UGSA Representative resign or be removed from office at which point an election may be held to elect a new Alternate UGSA Representative. The Alternate UGSA Representative will assist the UGSA representative in fulfilling his/her duties within the UGSA and may serve on a UGSA committee. The Alternate UGSA Representative may be an individual that concurrently holds any other office in ANS GSA except UGSA Representative.

G. The Graduate Education Committee Representative shall serve as a full voting member of the ANS Graduate Education Committee. The position must be filled by a Ph.D. student in good academic standing and may be an individual that concurrently

holds any other office in ANS GSA.

# Section 4. Quorum

A quorum shall consist of the membership present at a meeting.

Section 5. Voting

Each member shall have one vote. The President shall vote only to break a tie.

Section 6. Meetings

Regular meetings shall be held at least four times during the school year. The date of the next meeting shall be fixed at each meeting to suit the needs of the members present. The President shall call special meetings as needed. Meetings shall be conducted according to Robert's Rules of Order.
