#### Constitution

- ARTICLE I NAME AND PURPOSE:
- SECTION 1 This organization shall be known as Campus Advance.
  - SECTION 2 The purposes of this organization shall be:
- A. To help students pursue a saving relationship with God.
- B. To facilitate Christian relationships.
- C. To serve needs of students, faculty and staff of North Carolina State University for the betterment of same.

#### ARTICLE II MEMBERSHIP:

- SECTION 1 Elective officers of this organization shall be the president, vice president and activities coordinator.
- SECTION 2 Officers shall be nominated by campus minister and/or elders of the Brooks Avenue Church of Christ and elected by the organization by majority vote for term of one year beginning in September.
- ARTICLE IV DUES:

SECTION 1 Annual dues shall not be collected.

ARTICLE V AMENDING THE CONSTITUTION AND BY-LAWS:

- SECTION 1 Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the members present and voting shall be required.
- SECTION 2 All amendments to this constitution or by-laws shall be subject to the approval of the student government and the elders of the Brooks Avenue Church of Christ.

#### SECTION 3

Any article of this constitution or part thereof that is in direct violation of the student government constitution or by-laws shall be null and void and declared unconstitutional by the president of student government. Any differences of opinion between the organization and the president of student government shall be brought before the legislature, whose decision shall be final.

### ARTICLE VI MEETINGS:

SECTION 1 The club shall meet as a whole at regularly scheduled weekly activities including classes, devotionals, service and recreational activities.

#### ARTICLE VII COMMITTEES:

- ARTICLE 1 NAME AND PURPOSE:
  - SECTION 1 This organization shall be known as REACH

SECTION 2 The purpose of this organization shall be:

- A. REACH UP: Facilitate and encourage every student's commitment to and understanding of God.
- B. REACH OUT: Facilitate and encourage each student's love and commitment to their fellowman - especially to the university community. Provide service and education to the university commu nity for the beneficial growth of individual students.
- C. REACH FORWARD: Facilitate the development of each member spiritually, intellectually, emotionally and physi cally and encourage their - commitment to personal growth.
