## Chinese Club Constitution

### Article I. Name and Purpose.

**Section 1.** This organization shall be known as the Chinese Club.

**Section 2.** The purpose of the Chinese Club shall be to further acquaint students with Chinese language and culture as well as to expose the University at large to the same.

### Article II. Membership.

**Section 1.** Membership shall be open to all who are interested in Chinese language and culture.

**Section 2.** Membership shall be voluntary.

### Article III. Officers.

**Section 1.** The elective officers of the Chinese Club shall be the *President*, *Vice-President* and *Secretary*.

**Section 2.** The officers of the Chinese Club will be elected by the members of the Chinese Club to serve a term of one year which is to begin with the Fall semester of each academic year.

### Article IV. Dues.

**Section 1.** Dues shall be paid to attain membership.

**Section 2.** Dues shall be decided each academic year.

### Article V. Amendments and By-laws.

**Section 1.** Amendments to the constitution by by-laws shall be presented by members of the club in writing and read at a regular meeting, but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of two-thirds of the members present and voting shall be required.

**Section 2.** All amendments to the Chinese Club constitution shall be subject to the approval of the Student Government.

**Section 3.** Any article of this constitution or part thereof that is in direct violation of the Student Government constitution or by-laws shall be null and void and declared as unconstitutional by the President of Student Government. Any differences of opinion between the Chinese Club and the President of Student Government shall be brought before the Legislature whose decision shall be final.

**Article VI. Meetings.**

**Section 1.** The Chinese Club shall hold meetings as decided and declared by the Chinese Club members each semester.

**Article VII. Committees.**

**Section 1.** The President of the Chinese Club shall make provision for any standing committee(s) needed and/or for forming any special committee(s) when needed by submitting any such proposals to any given meeting of the Chinese Club, which shall be decided upon by majority rule.

**Section 2.** Membership to committees shall be voluntary.

### Constitution

- Article I     Name & Purpose  
Section 1     This organization shall be known as the Chinese Club  
Section 2     The purpose of this club shall be to expose all members and to any students interested in learning, the different aspects of Chinese culture. This club serves to help promote diversity and understanding to NC State.
- Article II     Membership  
Section 1     Membership shall be open to all students who are interested in becoming more culturally aware of China.  
Section 2     Anyone already enrolled in the FLC (Foreign Language Chinese) shall be automatically enrolled in the club. Any other students may also become members.
- Article III    Officers  
Section 1     The elective officers of this club shall be the President, Vice-President, Secretary, and Treasurer.  
Section 2     The officers shall be elected by the club member to serve a term of one year, beginning in the fall and ending at the end of the spring semester. All officers must be enrolled in a FLC class
- Article IV     Dues  
Section 1     Members of the Chinese Club will not be required to pay any dues.
- Article V     Amending the Constitution and By-laws  
Section 1     Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the members present and voting shall be required.
- Article VI     Meetings  
Section 1     Meeting will be announced during class, and through e-mail to all other students not enrolled in FLC class.

Article VII Committees  
Section 1

The club shall make provision for any standing committees needed and/or for forming any special committees when needed.
