B. THE CSO VICE-PRESIDENT WILL SUBSTITUTE AND FULFILL THE DUTIES OF THE PRESIDENT IN HIS/HER ABSENCE AND COORDINATE CAMPUS ACTIVITIES

C. THE CSO TREASURER WILL OVERSEE THE FINANCES OF THE CSO

D. THE CSO SECRETARY WILL TAKE MINUTES AT CSO MEETINGS AND MANAGE WRITTEN CORRESPONDENCE

E. THE CSO PUBLICITY COORDINATOR WILL COORDINATE THE ADVERTISING OF CSO CAMPUS EVENTS

THE OFFICERS SHALL BE ELECTED BY THE CSO TO SERVE A ONE-YEAR TERM. ELECTIONS WILL BE HELD AT THE END OF SPRING SEMESTER. THE CSO WILL APPOINT ONE FACULTY ADVISOR.
