Article I: Name

The name of the organization will be Christian Veterinary Mission Fellowship and may be referred to as CVF.

Article II: Objectives

Article IV: Executive Committee

EXECUTIVE OFFICERS:

All executive officers will be determined based on nominations. If two or more people are nominated for the same position, they are to discuss with each other who is best suited to lead the group. Section 2:

The officers and their dutics will be:

President - To call and preside over the organizational meetings as well as the executive officer meetings. To be the primary NCSU CVF contact person with Christian Veterinary Mission in Seattle. With the assistance of the vice president, to organize meetings, lead Bible studies, obtain speakers, and reserve meeting locations. To delegate someone to be in charge of service projects, social activities, and other events as needed.

Social Activity Committee Plan, organize, and announce activities involving CVF.

Treasurer - To keep the organization's bank account(s) in order. To oversee expenditures associated with CVF meetings. To prepare a proposed annual budget at the beginning of each academic school year.

Fund Raising Committee - Plan, organize, and announce fundraisers for CVF.

Secretary- To update the CVF bulletin board on a monthly basis. To maintain and update the CVF list serve, to record prayer request and posts for all CVF members. To announce upcoming CVF events to the school. To update the club constitution as needed.

Faculty Advisor - To guide the officers in their leadership roles. To mediate any conflicts within the group. To proved general assistance as needed by the officers.

**All officers will make announcements to their respective classes. A representative will be selected for any class which does not have an officer.

**Officers will be announced at the end of the Spring semester and representatives will be elected at the beginning of the Fall semester.

Article V: Meetings

A weakly hible study will be held. Members and non-members may attend.
