Article I. Name

Section 1.01 The name of this organization shall be The Golf Club at North Carolina State University.

Article II. Purpose and Mission

- Section 2.01 The game of golf is to be promoted as an international sport with no boundaries of age, race, gender, or religion, and it should be understood that the interest in this sport spans more than just the college level because it is a lifetime sport. The Golf Club at North Carolina State University intends to carry out any procedures of this organization with unfathomable integrity and camaraderie that will always represent the game of golf with high standards and honor it deserves.
- Section 2.02 The purpose of The Golf Club at North Carolina State University is to provide a competitive and recreational environment for Club members. Our goals should be to increase the presence of the sport on campus, learn new skills, improve existing skills, become more educated about fitness and health, engage in competition, gain leadership skills, and enjoy recreational and social fellowship.
- Section 2.03 The mission of The Golf Club at North Carolina State University is to create a competitive environment which allows individuals who are committed the tradition, history, and lore of the game an opportunity to interact and compete in both a national and regional setting.

Article III. Membership

- Section 3.01 Membership shall be open to any registered, full-time, undergraduate -or- graduate student of North Carolina State University, in good standing, with the exception of current members of the North Carolina State University Men's or Women's (NCAA) Collegiate Golf Teams.
- Section 3.02 In the event that complications occur, The Golf Club at North Carolina State University reserves all rights to limit or expand membership as necessary.

Article IV. Officers

Section 4.01 The officers of this organization shall be as follows: Captain (equivalent to President), Assistant Captain (equivalent to Vice President), Treasurer, Secretary, Public Relations Officer, Coordination Director, and Webmaster. These seven positions shall make up the Cabinet, which, upon unanimous vote, may create other positions within the club. Only current members of The Golf Club at North Carolina State University may hold positions in the Cabinet. If, at anytime, a tie should occur, the Captain will be responsible for breaking the tie.

Duties of the Officers:

(a) Section 1: General Orders

This section applies to all officers of the club. Holding a position as an officer is a distinguished position and should be held in high regard. All officers will be expected to show the utmost professionalism, sportsmanship and integrity. It is the duty of the officer to set the example for all other members to follow.

(b) Section 2: The Captain

The Captain is responsible for organizing meetings, monitoring progress of each event or activity, and seeing that each officer fulfills their duty. The Captain should also work creatively to develop ideas and programs to foster opportunities of competition for members of the Club.

(c) Section 3: The Assistant Captain

The Assistant Captain is not only responsible for aiding the efforts of the Captain in his/her duties as outlined in Section 4.01(b), but also, to act in the Captain's stead when he/she is unable to be present at any Club function (this includes, but is not limited to: meetings, practice, tournaments, and/or travel).

(d) Section 4: Treasurer

The Treasurer will maintain and monitor the organization's checking account as well as collect and deposit all sponsorship funds. All bills and expenses incurred by The Golf Club at North Carolina State University are to be paid by the Treasurer. The Treasurer is also responsible for preparing ongoing financial summaries to be presented at meetings.

(e) Section 5: Secretary

The Secretary is responsible for taking minutes at the meetings and for making them available to the entire association, for organizing and recording player and team statistics, and for keeping a history of the association. The Secretary should forward any pertinent information to the Web Master so proper action can be taken to update the website.

- (f) Section 6: Public Relations Officer
 - The Public Relations Officer is responsible for drawing public attention and creating recognition for The Golf Club at North Carolina State University. The Public Relations Officer is the project manager for any advertisement, recruiting and recognition projects.
- (g) Section 7: Coordination Director

The Coordination Director is responsible for making any and all arrangements to coordinate future tournaments and schedules and to see that they are organized in accordance with the regulations set forth by The Golf Club at North Carolina State University.

(h) Section 8: Webmaster

The Web master is responsible for maintaining the club's web site, and keeping it up to date.

Article V. Elections and Appointments

Section 5.01 Elections of the officers of the cabinet shall be made at the last scheduled spring meeting.

Section 5.02 Candidates must be nominated for a position.

Section 5.03 A majority vote from all members present at the meeting is needed to elect an official.

Section 5.04 If a position becomes vacant during the year, a meeting and an election will be held to fill said position.

Article VI. Meetings

Section 6.01 Meetings will be held at the Captain's discretion.

Section 6.02 All officers must be present at each meeting, unless a valid excuse, decided at the discretion of the Captain, is given to the Captain of the Club.

Article VII. Dues

Section 7.01 Dues are to be paid directly to treasury.

Section 7.02 The amount of dues will be decided on by the Cabinet.

Article VIII. Organization of Teams

Section 8.01 There shall be at least, but not limited to, two individual teams within The Golf Club at North Carolina State University.

- (a) The first team, or A-Team, will operate as a competition and traveling team. It will be comprised of fifteen members, as well as the seven officers of The Golf Club at North Carolina State University. The aforesaid twenty-two members shall qualify for individual spots prior to tournaments in which The Golf Club at North Carolina State University is represented. Qualifying formats, scores, and team numbers shall be outlined by the Captain and/or Assistant Captain. All decisions regarding team organization and representation rest solely with the Captain and Assistant Captain.
- (b) There will be at least one recreational team, or B-Team, of which all remaining members of The Golf Club at North Carolina State University will be affiliated. The purpose of this team is to allow individuals to participate in recreational golf outings, practices, and/or clinics arranged by The Golf Club at North Carolina State University Coordination Director.
- (c) The right to create tournament qualification exemptions for outstanding members of the recreational team(s) rests exclusively with the Captain and Assistant Captain, and will be evaluated/exercised, per their discretion, on a tournament-by-tournament basis.

Article IX. Annual Wolfpack Invitational Golf Tournament

- Section 9.01 The Wolfpack Invitational Golf Tournament will be held only once a season.
 - (a) The Wolfpack Invitational Golf Tournament shall be held in either April or May.
 - (b) Each Wolfpack Invitational Golf Tournament shall bear the current year and name of a paid corporate sponsor (e.g., The 2006 Cleveland Golf Wolfpack Invitational Golf Tournament), to be determined and publicly announced each year.
- Section 9.02 Once The Golf Club at North Carolina State University Coordination Director finalizes the plans for The Annual Wolfpack Invitational Golf Tournament, it is the Captain's duty to contact both the Southeastern Golf Club Association's Coordination Director, as well as the Collegiate Golf Alliance Tournament Director, to verify the time, date, and course where the tournament will be held.
- Section 9.03 Tournaments will consist of one, eighteen-hole, round of golf.
- Section 9.05 The type of play will always be stroke play in accordance with USGA rules and regulations.
- Section 9.06 Each team is allowed to bring up to 10 players; however, only the top 7 scores will count.
- Section 9.07 When play is finished, each player's scorecard is to be signed, dated, and attested, and then turned in to The Golf Club at North Carolina State University Secretary to be recorded. Failure to do so will result in disqualification.

Article X. Awards

Section 10.01 Tournament Awards

(a) Team Awards

- (i) The Team Score will be calculated by adding together the top 7 scores.
- (ii) Team awards will be given to the three teams with the lowest score.

(b) Individual Awards

- (i) Any ties for individual scores will be broken by going backwards on the score card, this is not taken into consideration when points are being awarded.
- (ii) Individual awards will be given to the three individuals with the lowest score.

Section 10.03 Closest to Pin and Long Drive awards are highly encouraged but not required at tournaments.

Article XI. Amendments

- Section 11.01 Amendments to this constitution may be submitted in writing to the Captain by any member of The Golf Club at North Carolina state University. The proposed amendment is to be read aloud to the cabinet, and open forum among officers and Club members shall follow.
- Section 11.02 After questions and concerns are heard regarding said amendment, voting shall take place. A unanimous vote of the Cabinet is required in order for an amendment to this constitution to pass.

Section 11.03 Ratification

(a) This constitution shall become effective upon ratification by a unanimous vote of the members of this meeting on Sunday, November 6^h, 2005.

Duties of Officers:

President: To lead meetings, report information to the assistant director of Club Sports, schedule events, and oversee the other officers.

Vice President: To assist in leading meetings, scheduling events, calling other members, and sitting in as President when and if the President is unavailable.

Secretary: To keep records of past meetings, events, and fill out paperwork of the club.

Treasurer: To open an account, collect club dues, budget money, and submit monthly budget to President.

Elections: Elections for officers are to be held at the beginning of each fall semester.

Dues: A fee of five dollars will be charged annually for each club member.
