Constitution Comedic Improvisation Alliance

Article I: Name and Purpose

- Section 1
 Section 2
 This organization shall be known as the Comedic Improvisation Alliance.
 This organization has no ties with other regional or national organizations, but is affiliated with Comedyworx, a local improv comedy club.
- Section 3 The purpose of this club shall be to build improvisational comedy and performing skills, develop friendships, and work towards performance.

Article II: Membership

Section 1
Section 2
Membership shall be open to all regularly enrolled students interested.
Anyone interested to participate in the club may do so and no auditions are to be held. The only case in which a student may be forced to leave is if all organizational officers agree it is necessary.

Article III: Officers

- The officers of this organization shall consist of four people. The Section 1 president, Philip Boyne, is expected to supervise the planning and coordinating of all club functions and also serve as the primary trainer/improv teacher. The vice president, Katie Roberts, shall assist the president in his responsibilities, taking on a similar role. The secretary, John Fowler, shall also help with these tasks and shall also serve as the primary webpage designer/editor. Finally, the liaison, James Murray, will communicate with the Student Organization Resource Center, but also help work with the rest of the governing body. All officers are expected to work together to manage any financial duties and to help teach the art of improv comedy. Officers are selected by the governing body or vote of all active members, though final approval is made by the President. However, if there is no president for the upcoming year, club members shall vote for all officers and the people with the most votes shall fulfill the positions they ran for.
- Section 2 There is no mandatory officer qualifications other than that the president must have significant experience performing and teaching improvisational comedy.
- Section 3 The term of office shall last for one school year. Officers may, however, run for more terms as long as they are NCSU students if the rest of the governing body accepts.
- Section 4 Any member of the governing body may initiate the process to remove officers; however, that person must resign only if all three other officers agree. Any officer may choose to resign himself if the case arises.

Article IV: Dues

Section 1 No initial dues are necessary, but students may agree to pay money to attend optional organizational events outside of the standard meetings.

Article V: Amending the Constitution and By-Laws

Section 1 The constitution may be amended by a vote of \(\frac{3}{2} \) of the club members present or by a unanimous vote from the governing body. Any addition or change to the constitution shall be made in this manner.

Article VI: Meetings

Section 1 Regular meetings of this organization shall be held weekly. The vice president of the club is expected to notify members by email if necessary, though the frequency of the club meetings does not require a great deal of notice to members used to the schedule.

Section 2 A quorum shall consist of five voting members must be present at each meeting to conduct the business of the organization. The procedure of the meetings shall be different every week, and it is up to the governing body and primarily the president to determine the activities each meeting. The president shall be the authority in deciding questions of parliamentary procedure.

Article VII: Committees

Section 1 The club shall make provisions for any standing committees needed and/or for forming any special committees when needed, though the governing body will make almost all of the legislative and procedural decisions.
