CYCLING CLUB

ARTICLE I. NAME

Section I. This organization shall be known as the Nest Cycling Club.

ARTICLE II. PURPOSE

Section I. The purpose of this Club will be:

A. to promote the development of the physical fitness components of cardiorespiratory capacity, flexibility, muscular strength, and muscular endurance.

B. to promote the development of basic cycling skills.

C. to offer a congenial, wholesome atmosphere for meeting others.

D. to provide for competition in the Eastern Collegiate Cycling Federation.

ARTICLE III. MEMBERSHIP

Section I. The membership of this organization shall be limited to full-time or part-time students, graduate students, faculty and staff in good standing with the university.

Section II. All individuals must comply with the university requirements as well as the Intramural-Recreational Sports Office requirements concerning health, insurance, and release and assumption of risk forms.

A. agree to abide by this Constitution and University rules which apply to campus organizations.

B. behave in a manner to bring credit to the Cycling Club, the Intramural-Recreational Sports Office, and North Carolina State University.

Section IV. After completion of all required forms, membership becomes effective upon payment of semester dues.

ARTICLE IV. DUES

Section I. Dues shall be determined by a majority vote of members present at the first business meeting of the fall semester in agreement with the Club Sports Coordinator.

ARTICLE V. OFFICERS

Section I. The officers of this organization shall be chosen from and by the active members of the Club to serve a term of one year beginning with the fall semester.

Section II. The officers shall be President, Vice President Receipt, Vice President Touring,
Secretary and Treasurer.

ARTICLE VI. CLUB ADVISOR

Section I. The club advisor will be a member or the faculty or staff of NCSU and will be selected by the members of the club.

Section II. The faculty advisor shall:

A. attend a minimum of 3 business meetings of the Club (preferably the first business meeting of the fall and spring semesters and the last meeting of the spring semester).

- B. approve all club functions.
- C. serve as an information source for providing guidance.

D, advise the memvbers in making their yearly budgets.

ARTICLE VII. DUTIES OF OFFICERS

Section I. The President shall:

- A. enforce all provisions of this Constitution.
- B. be responsible for reporting to the Club Sports Coordinator in the Intramural-Recreational Sports Office during the first two weeks of school.
- C. be responsible for submitting a club roster and medical, insurance, and release and assumption of risk forms to the Intramural-Recreational Sports Office.
- D. submit an inventory of all equipment which has been purchased for Club use by the Intramural-Recreational Sports Office or the Sports Club Authority.
- E. submit a statement of all Club funds on hand, both in checking and savings, at the end of each semester.
- F. be responsible for representing the club alt club sports functions.

Section II. The Vice President-Racing shall:

A. assume the duties of President during his or her absence.

B. be responsible for maintainance of the racing aspects of the club.

Section III The Vice President-Touring shall:

- A. assist the President as needed.
- B. be responsible for maintenance of the touring aspects of the club.

Secetion IV. The Secretary shall:

- A. be present to take minutes of meetings.
- B. conduct correspondence for the club and update the club roster.
- C. handle all publicity for club functions.
- D. assist the treasurer in collecting dues.

Section V. The Treasurer shall:

- A. keep an accurate record of all accounts and collect dues.
- B. assist the President in budget preparation.
- C. submit a statement of the total number of members and dues after each dues collection to the advisor.
- D. assist the secretary in roster preparation.
- E. submit a statement of all club funds on hand, both in checking and savings, at the end of each semester.

Section I. The coach must adhere to the guidelines as established by the club and approved by the Club Sports Coordinator.

ARTICLE IX. ELECTIONS

- Section I. The officers will be elected by a majority vote of the members present to vote provided that adequate publicity of the meeting is met through normal campus channels.
- Section II. The officers shall serve for two semesters with new officers being elected at the last business meeting of the spring semester and taking charge pending election.
- Section IIIDfficers may be removed fromoffice by a mojority vote of the members present to vote provided that adequate publicity of the meeting is met through normal campus channels.
- Section IV. Officers may succeed themselves as long as the members of the club elect them.

ARTICLE X. EXECUTIVE COMMITTEE

Section I. The Executive Committee shall consist of the President, Vice President-Racing, Vice President-Touring, Secretary, Treasurer, Faculty Advisor, and four at large members from the general membership, elected by a majority vote of those present at called meetings consisting of at least one half of the members present to vote provided that adequate publicity of the meeting is met through normal campus channels.

Section II. Powers

- A. make recommendations on policies and policy changes.
- B. make recommendations on puchases and expenditures.

C. carry out the constitution.

Section IV. The four at large committee members shall consist of 2 members representing racing and 2 members representing touring.

ARTICLE XI. ACTIVITIES

- Section I. Club activities will include club meetings, workshops, fund raising events, club rides and intercollegiate competion.
- Section II. There will be a minimum of two business metings of the club held per semester.
- Section IIIAll club activities are subject to approval of the Club Sports Coordinator.

ARTICLE XII.AMENDING THE CONSTITUTION AND BYLAWS

- Section I. The constitution can be amended by a majority vote of the members present to vote.
- Section II. All amendments to the constitution or bylaws shall be subject to approval of the Club Sports Coordinator.
- Section III Any article of this constitution or part thereof that is in direct violation of the Student Government constitution or by-laws shall be null and void and declared unconstitutional by the President of Student Government. Any differences of opinion between the club and the President of Student Government shall be brought before the Legislature, whose decision shall be final.

ARTICLE XIII. BYLAWS

- Section I. Policies and procedures will be approved by a majority vote of the members present to vote and the club sports coordinator.
- Section II.A member ixhibiting unsportsmanlike conduct may be voted out of the club by a majority vote of the members present to vote.

- Section IIIAll club activities must be in compliance with the guidelines of the Club Sports
 Program of the Intramural_Recreational Sports
 Office.
- Section IV. This constitution will be updated each year no later than March for the following year.
- Section V. Should the Cycling Club become inactive or disband and a new Cycling Club has not been formed within a period of one year, all property of he club shall become the property of the Intramural-Recreational Sports Of-
