## Dancing With Wolves

ARTICLE 1.	NAME	DANCING WITH WOLVES
	Section I.	This organization shall be known as Dancing With Wolves.
ARTICLE 2.	PURPOSE	
	Section I.	The purpose of this Club will be: A. to enhance the members' knowledge and appreciation for social and ballroom dancing.
		B. to offer a congenial, wholesome atmosphere for meeting others.
ARTICLE 3.	MEMBERSHIP	
	Section I.	The membership of this organization shall be limited to full-time or part-time students, faculty, and staff in good standing with the university.
	Section II.	All individuals must comply with the university requirements as well as the Intramural-Recreational Sports Office requirements concerning health, insurance, and release and assumption of risk forms.
	Section III.	<pre>All members shall: A. agree to abide by this Constitution and University rules which apply to campus organizations.</pre>
		B. behave in a manner to bring credit to this Club, the Intramural-Recreational Sports Office, and North Carolina State University.
	Section IV.	After completion of all required forms,

membership becomes effective upon payment of semester dues.

ARTICLE 4. OFFICERS

- Section I. The officers of this organization shall be chosen from and by the active members of the Club.
- Section II. The officers shall be President, Vice-President, Secretary, Treasurer and Faculty Advisor.

ARTICLE 5. DUTIES OF OFFICERS

> Section I. The President shall:

- Α. enforce all provisions of this Constitution.
- в. be responsible for reporting to the Club Sports Coordinator in the Intramural-Recreational Sports Office during the first two weeks of school.
- С. be responsible for submitting a Club roster and medical, insurance, and release and assumption of risk forms to the Intramural-Recreational Sports Office.
- submit an inventory of all equipment D. which has been purchased for Club use by the Intramural-Recreational Sports Office or the Sports Club Authority.
- Ε. submit a testament of all Club funds on hand, both in checking and savings, at the end of each semester.
- F. preside at Club meetings.
- G. responsible for representing the Club at Intramural-Recreational, and Student Government functions.

Section II. The Vice-President shall:

- A. assume duties of the President during his absence.
- B. assist the President when needed.
- C. handle all publicity for Club functions.

Section III. The Secretary shall:

- A. be present to take minutes of business meetings.
- B. conduct correspondence for the Club and update the Club roster.
- C. notify members of Club functions
- D. keep a proper record of equipment and maintain an accurate schedule of instructors.

Section IV. The Treasurer shall:

- A. keep an accurate record of all accounts and collect dues.
- B. assist the President in budget preparation.

Section V. The Faculty Advisor shall:

- A. attend a minimum of three business meetings of the Club.
- B. be first in line to approve all Club functions.
- C. serve as information source for providing guidance.

ARTICLE 6	ELECTIONS	
	Section I.	The officers will be elected by a 2/3 vote of at least 1/2 of the total membership.
	Section II.	The officers shall serve for one semester with

new officers being elected at the first business meeting of each semester and taking charge pending election.

- Section III. Officers may be removed from office by a 2/3 vote of all active members.
- Section IV. Officers may succeed themselves as long as the members of the Club elect them.

#### ARTICLE 7 EXECUTIVE COMMITTEE

Section I. The Executive Committee shall consist of the President, Vice-President, Secretary, Treasurer, Faculty Advisor, and 2 at large members from the general membership, elected by a 2/3 vote of at least 1/2 of the total membership.

#### Section II. Powers

- A. make recommendations on policies and policy changes.
- B. make recommendations on purchases and expenditures.
- D. form committees and appoint members for reasons deemed necessary.
- E. carry out constitution.

#### ARTICLE 8. DUES

Section I. Dues shall be determined by the Club membership and passed by a 2/3 vote of the entire membership in agreement with the Club Sports Coordinator.

#### ARTICLE 9. ACTIVITIES

Section I. Club activities will include Club meetings, workshops, fund raising events, and other related activities.

Section II. There will be a minimum of two business

meetings of the Club held per semester.

- Section III. All Club activities are subject to approval of the Club Sports Coordinator.
- ARTICLE 10. AMENDING THE CONSTITUTION AND BYLAWS
  - Section I. The constitution can be amended by a 2/3 majority vote of the total membership. Proposed amendments will be in accordance with university policy.
  - All amendments to the constitution or bylaws Section II. shall be subject to approval of the Club Sports Coordinator and the Student Government.
  - Section III. Any article of this constitution or part thereof that is in direct violation of the Student Government Constitution or bylaws shall be null and void and declared unconstitutional by the President of Student Government. Any differences of opinion between the club and the resident of Student Government shall be brought before the Legislature, whose decision shall be final.
- ARTICLE 11
- BYLAWS
  - Section I. Policies and procedures will be recommended by the Executive Committee and approved by a 2/3 majority of atleast 1/2 of the total membership and the Club Sports Coordinator.
  - Section II. A member exhibiting unsportsmanlike conduct may be voted out of the Club by a 2/3 majority of the total membership.
  - Section III. All Club activities must be in compliance with the guidelines of the Club Sports Program of the Intramural-Recreational Sports Office.
  - Section IV. This constitution will be updated each year, as needed, no later than the fifteenth of October.
  - Section V. Should Dancing With Wolves become inactive or

disband and a new dance club has not been formed within a period of one year, all property of the club shall become the property of the Intramural-Recreational Sports Office.
