Fitness Through Teamwork

Constitution Date: 10-July-2005

Article I Name & Purpose

Section 1

This organization shall be known as the Fitness through Teamwork (FTT). Section 2

The purpose(s) of this club shall (will) be, and not limited to:

- · Fitness Through Basketball
- Helping newcomers expand social boundaries
- Teach team cooperative skills
- · Building character and self-esteem
- (ASA) Eligibility in playing in Baby Blue Tournament of Chapel-Hill.

Article II Membership

Section 1

Membership shall be open to all regularly enrolled students who are interested in Fitness through Teamwork

Section 1a:

To be eligible for active membership, players must practice at least twice a week and attend monthly meetings. Must also include payment of fees.

Officers must make all meetings. General public must meet more than 75% of all meetings assigned.

Section 2

Means of selection of members include:

- · Prospective players for Baby Blue
- Must be coach-able and are willing to learn
- Must meet team's athletic and academic guidelines

Article III Officers

Section 1

The elective officers for this club shall be the:

- President = Coach
- Vice President = Team Manager
- Secretary = Statistics
- Social Chair = Scouting Agents / Recruiters
- Treasurer = Commissioner
- Advertising / Public Relations = 6th Man and Hype Man

Section 1a:

- President = Coach
 - o Playmaker, Organizing team roster, Maintain Team Play
- Vice President = Team Manager
 - o Physical trainer, Moral booster
- Secretary = Statistics
 - o Record and Organize individual player statistics
- Social Chair = Scouting Agents / Recruiters
 - o Scout for and Recruit prospective players to the team.
- Treasurer = Commissioner
 - Allocate money for supplies, assess for fees needed for tournaments, games, transportation.
- Advertising / Public Relations = 6th Man and Hype Man
 - o Bring out the HYPE, (girls and guys to cheer and watch), schedule games so our team plays other teams.

Section 2

The officers shall be elected by the club members to serve a term of one year, beginning immediately. End of 2nd semester elections will be held for each position.

Article JV Dues

Section 1

(To be filled in by the club according to its particular fees, to include amount, when assessed, etc.)

Dues for the club shall be \$5.00 per semester for each member of the club. (Entrance fee only fulfills club participation; active membership may include additional fees when needed. These fees will help buy:

- Team Jerseys, Shorts, Basketball, equipment, etc.
- · Transportation, fuel, etc.
- Sponsorship of eligible members
- · Entrance fees for tournaments

Article V Amending the Constitution and by-laws

Section 1

Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the active members present are eligible to vote. (Active members will be based on club's criteria)

Article VI Meetings

Section 1

The club shall meet frequently for officers (once a week, etc.) and less frequently for general body meetings as a whole. The meetings exclusive to officers will serve the purpose of brainstorming ideas and creating a basic structure for the general body meetings, where every member will be able to voice new ideas as well as vote on decisions that are presented. Officer meetings shall not exceed (1 hour), general body meetings will not exceed (1 hour).

Article VII Committees

Section 1

(The club shall make provision for any standing committees needed and/or for forming any special committees when needed by a 2/3 vote.)

Article VIII (Adding Articles)

Section 1

Additional articles may be added with 2/3 majority vote of present and active members. To take away an article must require a 100% vote by Top 3 Officers.

Article IX (Team Requirements)

Section 1

Must make 75% of all practices, be on time for scheduled practices, show good sportsmanship, be coach-able, be Team Players, and show enthusiasm to play.

Article IX (Academic Requirements)

Section 1:

Must meet standard NCSU requirements for passing and for promotion to next level. If one does not meet these requirement then team as a whole must determine their eligibility of membership.
