Article I. Name and Purpose

Section 1. This organization shall be known as the Functional Genomics Graduate Student Association; hereafter referred to as FG-GSA.

Section 2. The purpose of this organization shall be:

a. To represent the graduate student body in the Functional Genomics Program.

b. To provide a forum for graduate student opinion.

c. To voice graduate student opinion in all matters of mutual interest to graduate faculty and students.

d. To promote professional interest and fellowship among graduate students.

Article II. Membership

Section 1. Membership shall be concurrent with the enrollment in the following graduate programs of the Functional Genomics Program:

a. Master of Science in Functional Genomics

b. Ph.D. in Functional Genomics

Article III. Officers and GSA Representatives

Section 1. The elected officers of this organization shall be:

a. President

b. Vice-President

c. Secretary-Treasurer

d. Social Director

e. Research Symposium Coordinators

Section 2. Election of Officers

Officers shall be elected by secret ballot by the members of the organization to serve a term not exceeding one year. Election shall be determined by the plurality of the votes cast.

Section 3. Date of Elections

Elections shall be held during April and the terms of office shall begin at the end of the Spring semester. Any vacancies created by the early retirement of an officer shall be filled by presidential appointment or, at the request of the organization, by a special election.

Section 4. Duties of the Officers

a. The President shall call and preside over FG-GSA meetings and represent FG-GSA at University and Department functions.

b. The President shall also nominate representatives to such committees and organizations as considered appropriate and/or necessary. Such nominations will be subject to approval by a majority of FG-GSA members present at the meeting they are announced.

c. The Vice-President shall preside over FG-GSA meetings at the request or absence of the President and, at the President's request, substitute for the President at University and Department functions.

d. The Secretary-Treasurer shall take and maintain the minutes of FG-GSA

meetings and keep the financial records of FG-GSA.

f. The Research Seminar Coordinator shall be responsible for organizing speakers, securing a location, and providing food for the monthly research seminars.

g. The Research Symposium Coordinators (at least 2) shall be responsible for organizing the yearly Functional Genomics Graduate Student Research Symposium. These duties include, but are not limited to, organizing speakers, collecting abstracts for an abstract booklet, securing a location, and advertising the symposium.

Section 5. GSA Representatives

There will be one representative and one alternate to serve as members of the GSA Council. The representative and alternate will be nominated by at large nominations and will be approved by a majority vote at a FG-GSA meeting. The GSA representative must participate on one GSA committee per year and must attend seven of eleven monthly GSA meetings in order for FG-GSA to receive an annual rebate from the GSA.

Article IV. Committees

Article V. Amending the Constitution
