# Constitution

#### **Article I: Name and Purpose**

Section 1: This organization shall be known as the Golden Chain Honor Society.

Section 2: The purpose of this organization is to recognize the academic achievements, community service, great character and commitment to the University of a group of 10-12 rising seniors each year through an induction ceremony held each spring semester.

# Article II: Membership

Section 1: Applications for Golden Chain Honor Society are available in the spring to all juniors. Current members of the Golden Chain Honor Society will review the applications and determine the group of students will be become members of the organization.

Section 2: All accepted members are required to attend the meetings as announced.

# **Article III: Officers**

Section 1: The executive officer positions of this club shall be the Arch Regent, Regent, Treasurer and Scribe. Other officer positions can be created if need is demonstrated. The creation of a position must be approved by the executive officers and members will have a simple majority vote on the person to hold this new position. Section 2: Officers will be elected in a meeting following the induction ceremony arranged by the current executive board. Officers will be selected by a majority vote and will begin serving their term in August.

# **Article IV: Dues**

Section 1: N/A

#### Article V: Amending the Constitution and By-laws

Section 1: Amendments to the Constitution or by-laws shall be presented by members of

the organization in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member for the proposed amendments. A majority of 2/3 of the members present and voting shall be required for amendments to occur.

# **Article VI: Meetings**

Section 1: Meetings will be held as needed and will be called the executive board.

#### **Article VII: Committees**

Section 1: When standing or special committees need to be formed for temporary purposes, all officers will vote on the name and nature of this committee and all members will vote on the person to lead this committee.



Dear Mr. Younts,

The Golden Chain Society of North Carolina State University respectfully requests financial assistance from the University Alumni Association. We are requesting funds in the amount of \$750.00. This money would be spent on the annual induction banquet and on a project devoted to purchasing a quality work of art for the University's proposed art museum.

Golden Chain is the oldest and most prestigious honorary at North Carolina State University. Each year 12 "links" are added to the Chain. Student members excell both academically and in extracurricular activities. Traditionally, the juniors inducted are considered the top students of their class. In addition, outstanding faculty and administrators who have made significant contributions to North Carolina State may be nominated for membership.

The Society hopes to once again include the members of the University's Board of Trustees in the spring 1986 induction ceremony and banquet. The cost of the banquet will be covered in whole by new members. However, this money will not be collected until next semester and it has become necessary to make initial payments for reservation of facilities and payment of advance bills for food, certificates and Golden Chain pendants. These pendants require a down payment of \$100.00 in mid October. The current balance in our account is less than \$60.00.

It is the goal of the Society to purchase an art piece to be donated to the proposed University Art Gallery in Golden Chain's name. We have already consulted with Barbara Grubb, Assistant Curator of Art, and she has been very receptive to the idea. We feel this would be an appropriate gesture, to promote awareness of not only the Society, but also the intrinsic aesthetic beauty of art on a campus far too often geared only towards technology and research. OF

#### THE GOLDEN CHAIN

#### - Preamble -

The object of this society shall be to promote better citizenship at North Carolina State University by fostering existing traditions and creating new traditions which will tend to instill the highest ideals of life by promoting higher scholarship, better athletics, clearer self-expression and greater concern of duty in all campus activities.

#### - Name -

The officers of this society shall be an Arch-Regent, Regent, Scribe and Treasurer. These officers shall be elected once each academic year during the first meeting following the initiation of new members.

The duties of the Arch-Regent shall be to preside at all meetings, appoint all committees and serve in official capacity at all times.

The duty of the Regent shall be to preside in the absence of the Arch-Regent.


The duty of the Scribe shall be to keep a record of all meetings and attend to all correspondence.
