

**GOLDEN KEY NATIONAL HONOR SOCIETY,
North Carolina State University
Chapter By-laws**

Article I - Name

The name of this society shall be the Golden Key National Honor Society, North Carolina State University Chapter.

Article II - Purpose and Activities

Section A. The purposes NCSU's Chapter shall be:

1. To recognize and encourage scholastic achievement and excellence in all undergraduate fields of study.
2. To unite with collegiate faculties and administrators in developing and maintaining high standards of education.
3. To provide recognition to students who are superior academically without requiring individual participation of members.
4. To provide economic assistance to outstanding members by means of scholarships.

Section B. Activities of the NCSU chapter shall be:

1. Community Service Projects.
2. Educational/Academic Programs.
3. Other activities that are deemed necessary and worthwhile by the executive board.

Article III - Membership

Section A. Membership into the Society shall be based on the following criteria:

1. By invitation only to those undergraduates having attained a grade point average of greater than or equal to 3.4.
2. A prospective member must have successfully completed at least sixty semester hours, or achieved the status of junior or senior, of fifteen semester hours are completed at NCSU.
3. Before being considered a member of the Society, one must have paid, in full, the initiation and life membership fee.
4. Golden Key will not discriminate on the basis of sex, race, creed, sexual orientation, color or national origin.

Section B. Active Membership

Active membership shall be limited to persons officially connected with the university as faculty, staff or students.

Section C. Honorary Members

1. The chapter may select up to five honorary members for each reception. Individuals who are not undergraduate students and have distinguished themselves in their fields of endeavor are selected to receive full rights and privileges of membership in the Society.

Article IV - Officers

Section A. Members of the executive board of the chapter shall be president, vice-president, secretary, treasurer and any other office deemed necessary by the advisor and executive board.

Section B. The term of office shall be one year.

Section C. Any student who meets the membership criteria and is endorsed by the collegiate advisor is eligible to hold office.

Section D. Officers will be annually either elected by a democratic process, or appointed by the faculty advisor.

Section E. Voting rights are extended to the executive board members of each collegiate chapter.

Section F. Responsibilities of each officer are as follows:

I. PRESIDENT

- A. Organize, plan and work to ensure the continuation and overall success of the chapter.
- B. Call meetings of the officers and delegate responsibilities as needed.
- C. Call meetings of the chapter members.
- D. Manage the planning of the reception.
- E. Meet with the other members of the executive board and the chapter advisor to determine the honorary members.

II. VICE PRESIDENT

- A. Plan and organize the campus awareness process.
- B. Oversee the work of committees formed by the chapter.
- C. Assist the president in the completion of duties.

III. RECORDING SECRETARY

- A. Record the minutes of each executive board or chapter meeting and submit copies to each officer, advisor and the regional director.
- B. Mail to the national headquarters all of the member profiles and fees that were hand-delivered to the advisor's office no later than two days past the membership deadline
- C. Serve as chapter archivist with the assistance of the chapter advisor.

IV. CORRESPONDING SECRETARY

- A. Transact all chapter correspondence.
- B. Prepare and deliver the reception invitations to the administrators and faculty.
- C. Prepare and mail information to the national headquarters for publications such as *CONCEPTS* and *Key Notes*.
- D. Act as the liaison between the chapter and the national student representative.

V. TREASURER

- A. Manage all financial transactions of the chapter.
- B. Prepare a budget for the chapter.
- C. Receive and distribute chapter funds.
- D. Submit an annual financial summary of expenditures to the national headquarters.
- E. Assist the vice president with the campus awareness process.

ARTICLE V - Chapter Conduct

- Section A. The NCSU chapter of the Golden Key National Honor Society will adhere to the Student Guide as well as others laws, rules and regulations governing the local community and its students.
- Section B. The Golden Key National Honor Society does not condone "hazing" nor is "hazing" used in any form in the Society.
- Section C. Any executive board member who fails to meet his/her responsibilities as chapter officer shall have his/her position suspended as determined by a two-thirds vote of the executive board. Executive board members may be removed on the basis of a failure to fulfill the duties of their office as outlined and defined in the chapter constitution. An executive board member's removal must require the introduction of a motion to so move by a current executive board member and properly seconded, followed by a two-thirds vote approval to remove the officer from his/her designated office. Such a vote will be by secret ballot and given by members present at an executive board meeting called for such a purpose.

The executive board member in question shall have the opportunity to defend him/herself before the vote is taken.

ARTICLE VI - Advisor

- Section A. An outstanding member from the university faculty or staff is chosen to serve as the chapter advisor.
- Section B. The duration of the advisor's tenure is indefinite, as long as the advisor(s) is/are fulfilling their duties.
- Section C. Each Advisor is to be considered as a lifetime honorary member whose responsibilities include:
1. Assist in the preservation of the chapter.
 2. Obtain a list of prospective members including names and addresses that meet the predetermined membership criteria.
 3. Guide students in the distribution of the certificates that were not issued at the reception and all Golden Key activities.
 4. Complete the Honorary Member Profile Form and submit it to the national headquarters.

ARTICLE VII - Meetings

- Section A. General membership meetings shall be held at least three times during the academic year.
- Section B. Executive board meetings shall be held as needed.
- Section C. Non-participating honor society members are not required to attend any meeting, although they are encouraged to attend the reception as well as general membership meetings and Society functions.

ARTICLE VIII - Dues

- Section A. The initiation and life membership fee shall be fifty dollars, to be paid in full to the Golden Key National Honor Society. Nine dollars of the fee shall be forwarded to the chapter for operational expenses and an additional two shall be designated for student scholarships.
- Section B. In the event of dissolution of the chapter, funds in the chapter treasury will be placed on reserve for a period of one year. If after such a period, the

chapter has not been re-registered and formed as a student organization and active society, funds in the chapter treasury shall be forwarded to the national headquarters.

ARTICLE IX - Amendments

Amendments to the constitution or bylaws shall be presented by members of the chapter in writing and read at a regular meeting but shall not be voted upon until the next regular meeting and then only after informing each member of the proposed amendments. A majority of two-thirds of the members present and voting shall be required.

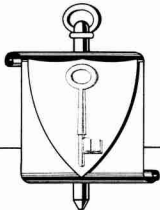

Admissions

The freshman application deadline for the fall semester and summer sessions is February 1; the transfer student deadline is April 1. Freshmen are encouraged to apply during the fall of the senior year in high school, as students will be accepted until the classes have been filled. All applicants for the School of Design must submit applications by January 1. Applications for the spring semester should be submitted prior to November 1. The School of Design does not admit students in the spring.

Each applicant must complete an application form which may be obtained from high school counselors or by writing to:

A nonrefundable \$35 fee must accompany the completed application.

FRESHMAN ADMISSION

Admission to the University is competitive, and it is possible to be admissible to some programs but not to all programs at NCSU. Applicants are asked to indicate their first, second and third choices for a curriculum, including undeclared majors within a college, or to indicate their choice of participating in the

University Undesignated Program. Applications which are not admissible in the first curriculum choice will be reviewed for admissibility in the alternate curriculum choices. Transfer between programs after a successful first year may be possible.

The admissions decision is based on the evaluation of the high school record, including the level and difficulty of the courses taken, the overall grade point average, rank in class, and scores on the Scholastic Aptitude Test (SAT) or the American College Testing Program (ACT). These factors are reviewed with the curriculum choice to determine admissibility as a freshman at NCSU. Any exceptions to University admissions requirements must be approved by the faculty members of the University Undergraduate Admissions Committee.

In addition, the Board of Governors of the University of North Carolina System has determined that the minimum undergraduate admissions requirements for all constituent institutions, including NCSU, shall be:

- A high school diploma or its equivalent
- English—four course units in English, emphasizing grammar, composition, and literature
- Mathematics—three course units in math, including algebra I, algebra II, and geometry, or a higher level math course for which Algebra II is a prerequisite
- Social Studies—two course units in social studies, including one unit in United States history
- Science—three course units in science, including at least one unit in a life or biological science; at least one unit in a physical science (for example, physical science, chemistry, or physics) and at least one laboratory course.

Further, it is recommended that prospective students complete at least two course units in one foreign language. *Beginning in the fall of 1994, two years of the same foreign language will be required of all incoming freshmen.* It is recommended that every student take one foreign language course and one mathematics course in the twelfth grade. *Any additional entrance requirements for admission to NCSU will be set forth in the Freshman Admissions Bulletin for that year.*


Applicants are accepted on either junior or senior test scores, although senior scores are recommended, especially if the applicant is also applying for financial aid or scholarships. An interview is not required and does not weigh in the admissions decision; a prospective student is always welcome to visit the Admissions Office, 112 Peele Hall. The Admissions Office conducts group information sessions every Monday, Wednesday, and Friday at 10:30 a.m. and on Tuesday and Thursday at 1:30 p.m. Campus tours led by students are conducted each weekday, weather permitting, at 12:15 p.m., starting at the Memorial Bell Tower.

The Chancellor's Commission on Scholarship met on April 5, 1984, to discuss our request to consider the need and appropriateness for adding honorary societies to those already in place at NCSU. Dr. Sawhney, Chairman of the Commission, informed us by letter dated April 24th that the Commission voted unanimously to recommend that Golden Key not be approved as a student organization. A copy of Dr. Sawhney's letter is attached.

Dr. Sawhney states in his letter that the Commission was of the opinion that existing academic honorary societies provide adequate opportunity for recognition of outstanding academic performance. Based upon this recommendation from the Chancellor's Commission on Scholarship, the request for Golden Key to be recognized as a campus organization is not approved.

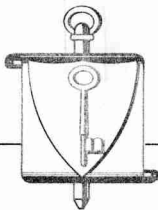

- A) The chapter may select up to five honorary members for each reception. Individuals who are not undergraduate students and have distinguished themselves in their fields of endeavor are selected to receive full rights and privileges of membership in the Society.
- B) Honorary members are welcome and encouraged to participate in all Society activities.

ARTICLE IV - Officers

Section I. Members of the executive board of each chapter shall be president, vice-president, secretary, treasurer, and any other office deemed necessary by the advisor and executive board.

Section II. The term of office will be one year.

Section III. Any student who meets the membership criteria and is endorsed by the collegiate advisor is eligible to hold office.

Section IV. Officers will be elected by a democratic process or appointed by the advisor each spring.

Section V. Responsibilities of each officer are as follows:

A) President

- 1) Responsible for the overall success of each chapter.
- 2) Call meetings of the officers and delegate responsibilities whenever needed.
- 3) In charge of the planning and programming of the reception and other chapter activities.
- 4) Together, with the other members of the executive board and advisor, determine the five honorary members.

C) Secretary

- 1) Responsible for all chapter communications.
- 2) Prepare and deliver the invitations to the reception for administrators and faculty.
- 3) Mail all the affirmations and dues that were hand delivered to the Advisor's office no later than two days past the affirmation deadline.
- 4) Record the minutes of all chapter meetings and submit a copy to the National Headquarters.

D) Treasurer

- 1) Take charge of all financial transactions of the chapter.
- 2) Receive and distribute chapter funds.
- 3) Assist the vice-president with the Campus Awareness Process.
- 4) Submit to National Headquarters a financial summary of reception expenditures.

 - D) Complete the Annual Chapter Schedule and submit it to the National Headquarters.

ARTICLE VII - Meetings

- Section I. General membership meetings shall be held twice per quarter during the academic year.
- Section II. Executive board meetings shall be held as needed.

ARTICLE VIII - Dues

- Section I. The initiation and life membership fee shall be \$40.00 to be paid in full to the Golden Key National Honor Society. Six dollars of the fee shall be forwarded to the chapter for operational expenses.
- Section II. In the event of dissolution of the chapter, funds in the chapter treasury will be placed on reserve for a period of one year. If after such period, the chapter has not been re-registered and formed as a student organization and active society, funds in the chapter treasury shall be forwarded to the National Headquarters.

ARTICLE IX - Amendments

- Section I. Amendments to the constitution or bylaws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the members present and voting shall be required.

Section II. All amendments to this constitution or by-laws shall be subject to the approval of the Student Government.

Section III. Any article of this constitution or part thereof that is in direct violation of the Student Government constitution or by-laws shall be null and void and declared unconstitutional by the President of Student Government. Any differences of opinion between the club and the President of Student Government shall be brought before the Legislature, whose decision shall be final.
