Article I Name

Section I This organization shall be known as the Handball Club at
NC State University.

Article II Purpose

Section I The purpose of this organization shall be:

- A. To promote the development of handball at NC State.
- B. To promote a healthy, team-oriented and safe environment for the attaining of fitness and handball skills.
- C. To adhere to the statutes of the United States Handball Association and act in accordance with the guidelines set forth by it.
- D. To plan and implement fundraising events as necessary to supplement the allocation of University funding to the Club.

Article I Name

Section I This organization shall be known as the Handball Club at NC State University.

Article II Purpose

Section I The purpose of this organization shall be:

- A. To promote the development of handball at NC State.
- B. To promote a healthy, team-oriented and safe environment for the attaining of fitness and handball skills.
- C. To adhere to the statutes of the United States Handball Association and act in accordance with the guidelines set forth by it.
- D. To plan and implement fundraising events as necessary to supplement the allocation of University funding to the Club.

Article III Membership

Section I Each person wishing to join the Club may do so by attending posted informational meetings or by contacting any of the Club members, officers, or faculty advisors.

Section II Membership into the Club is free to any enrolled student, faculty, or staff of NC State University.

Section III Each member may be required to pay dues or provide his/her own equipment as stipulated or needed later if such funding or equipment is not available from the University or Club itself.

Article IV Officers

Section I The officers of this organization will be President, Vice President, and Treasurer. Other officers may be instituted by the Club executives as they deem appropriate.

Section II The officers of this organization will be nominated by the members of the handball club and elected by its members. Any further implementation of officers should be directed to the Club faculty advisor.

Article V Officers' Duties

Section I The President of the Club will serve as the liaison between the Club Sports Council and other administrative divisions of Club Sports at NC State University.

Section II The Vice President of the Club will assist the President in fulfilling the duties of that position and will assume the position of President should the President become incapable of fulfilling those duties. In addition, the Vice President will assume the role of Secretary when necessary.

Section III The Treasurer of the Club will be responsible for financial transactions with the University and other entities.

Article VI Finances

Section I Dues will be determined by a majority vote of members present at the second business meeting of the fall semester and must be approved by the Club officers.

Section II No part of net earnings (dues, donations, fundraisers) will go to benefit any members, officer, trustee, or any private person except for reasonable compensation.

Section III Upon dissolution of the Club, all assets (current and capital) will revert to the Department of Intramural and Recreational Sports at NC State University.

Article VII Meetings

Section I Meetings will be held monthly or when deemed necessary by the Club officers.

Section II Meetings will be presided over by the Club President.

Article VIII Amendments

Section I Amendments to this document shall be presented by members of the organization in writing and read at a Club meeting, but shall not be voted upon until the next meeting, and then only after every member has been informed of the proposed amendment. A majority of two-thirds of the voting members present shall be required to approve an amendment.

Section II All amendments to this document will be in accordance with University policy and subject to approval by Student Government and the Club Sports Director.

Section III Any article of this document that is in direct violation of the Student Government Constitution or Bylaws is null and void and declared unconstitutional by the President of Student Government. Any differences of opinion between the Club and the Present of Student Government shall be brought before the legislature, whose decision shall be final.

Article I. Name

Section 1. This organization shall be known as the ~~North Carolina State University~~ Handball Club.

Article II. Purpose

Section 1. The purpose of this organization shall be:

- A. To promote the development of handball at North Carolina State University.
- B. To promote a healthy, team-oriented and safe environment for the attaining of fitness and handball skills.
- C. To adhere to the statutes of the United States Handball Association and act in accordance with the guidelines set forth by it.
- D. To plan and implement fundraising events as necessary to supplement the allocation of University funding to the handball club.

Article III. Membership

Section 1. Each person wishing to join the handball club may do so by attending posted informational meetings or by contacting any of the club members, officers or faculty advisors.

Section 2. Membership into the handball club is free to any enrolled student of North Carolina State University

Section 3. Each member may be required to pay dues or provide his/her own Equipment as stipulated or needed later if such funding or equipment is not available from the University or club itself

Article IV. Officers

- Section 1. The officers of this organization will be President, Vice President, Secretary, and Treasurer. Other officers may be instituted by the club executives as they deem necessary
- Section 2. The officers of this organization will be nominated by the members of the handball club and elected by its members. Any further implementation of officers should be directed to the handball club faculty advisor.

Article V.

- Section 1 The president of the handball club will serve as the liaison between the Club Sports Council and other administrative division of club sports at North Carolina State University
- Section 2. The Vice President will assist the President in fulfilling duties of that position and will assume the duties as President should the President become incapable of fulfilling the responsibilities.
- Section 3. The Secretary of the Handball Club will take minutes of the meetings of the Handball Club and conduct all correspondence.
- Section 4. The Treasurer of the Handball Club will be responsible for financial Transactions with the university and other sources.

Article VII. Finances

- Section 1. Dues will be determined by a majority vote of members present at the second business meeting of the fall semester and must be approved by the handball club officers.
- Section 2. No part of net earnings (dues, donations, fundraisers) will go to benefit any member, officer, trustee, or any private person except for reasonable compensation.
- Section 3. Upon dissolution of the Handball Club, all assets (current and capitol) will revert to the intramural-recreational sports program of the Department of Physical Education at North Carolina State University.

Article VIII. Meetings

- Section 1. Meetings will be held monthly or when deemed necessary by the Handball Club officers.
- Section 2. Meetings will be presided over by the President of the Handball Club. The vice-president will assume these responsibilities in the absence of the Club president

Article IX. Amending the Constitution and By-laws

- Section 1. Amendments to the Constitution or By-laws shall be presented by members of the organization in writing and read at a regular meeting, but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of two-thirds of the members present and voting shall be required.
- Section 2. All amendments to the Constitution and By-laws will be in accordance with university policy and subject to approval by Student Government and the club sports director.
- Section 3. Any article of this Constitution or part thereof that is in direct violation of the Student Government Constitution or By-laws is null and void and declared unconstitutional by the President of Student Government. Any differences of opinion between the Handball Club and the President of Student Government shall be brought before the legislature, whose decision shall be final.
