

Constitution of The Harvest Campus Ministry at North Carolina State University

Article I. Name

The official name of the organization is The Harvest Campus Ministry at North Carolina State University, hereto referred to as HCM.

Article II. Affiliations

- (a) HCM is affiliated with the Agapé Campus Ministries in Maryland and Pennsylvania.
- (b) HCM is subject to the rules stated here and the rules that govern the North Carolina State University.
- (c) HCM is a ministry of Agape Harvest Church in Durham, NC

Article III. Purpose and Objectives

HCM seeks to promote the moral and spiritual well being of the student body at North Carolina State University. It also aids in Christian maturity, the development of interpersonal skills and leadership potentials. Its programs are open to any student.

Article IV. Active Membership

- (a) Active voting membership is open to all undergraduates and active non-voting membership is open to all graduates and faculty of North Carolina State University.
- (b) Membership is established by consistent participation in our large group, weekly meeting and/or our small groups. Membership will be terminated only by voluntary withdrawal.
- (c) HCM does not discriminate on any basis, including with regards to race, color, religion, national origin, disability, age, veteran status, sexual orientation, or gender.

Article V. Advisor

- (a) The advisor must be staff or faculty at North Carolina State University or a pastor of a local Church.
- (b) The advisor will be familiar with the contents of the organization's constitution and ensure that HCM abides by these guidelines.

Article VI. Meetings

- (a) HCM will meet at least ten times a semester during the academic year at a time and date to be preset and determined by the Executive Committee and members.
- (b) Small groups will be set up in the beginning of the academic year and will meet on a weekly basis for the purposes of discipleship, Bible study, fellowship, and leadership training.
- (c) A quorum shall consist of 50% of the active members.

Article VII. Executive Committee

- (a) The Executive Committee shall consist of an active member who is willing to serve the ministry:
 - (1) President: A General Coordinator, who shall preside at all meetings and is involved in the day to day operation of the organization.
- (b) A vacancy on the Executive Committee will be filled at a general, large group, meeting by an election with at least 50% of the active members present.

Article VIII. Elections and Impeachment

- (a) Elections of the president shall be held annually at the end of the academic year. Nomination for this position is made by the active membership attending the meeting. The nominee may refuse nominations. This meeting must contain at least 50% of the active membership. At this time, a vote will be taken. A nominee will be considered elected if he/she receives a majority of the votes. The newly elected officer assumes duties in the beginning of the summer, annually. There are no limits on how many times an individual may hold office.
- (b) Only active members are eligible to hold office.
- (c) A member(s) can present their reason(s) for impeachment of an officer to the membership. The defendant, who is the notified, will present a defense, if any. Impeachment occurs with a written agreement of 85% of the active membership.

Article IX. Ratification

The president has the responsibility to approve the constitution on behalf of the members. This approval is officially ratified upon his/her signature.

Article X. Amendment Procedure

- (a) Amendments to this constitution may be proposed in writing by any member with the accompanying signatures of five percent of the membership.
- (b) The proposed amendment will become effective by the approval of the president and advisor.
- (c) All amendments are subject to the approval of the SOURCE
