

CONSTITUTION

OF ISLAM AND DIALOGUE STUDENT ASSOCIATION NORTH CAROLINA STATE UNIVERSITY AT RALEIGH

Article I – Name

The organization shall be known as Islam and Dialogue Student Association (IDSA).

Article II – Purpose

- To provide a forum to discuss and promote inter-faith dialogue and understanding.
- To allow interested students and faculty to learn more about religions in a respectful atmosphere.
- To exchange and broaden views on topics that integrates religion, society and science.

Article III – Membership

Section I: Membership is open to currently registered students (full-time or part-time), faculty, and staff of North Carolina State University.

Section II: Any student attending a higher learning in the Wake County area shall be eligible for membership.

Section III: Alumni membership shall have all the privileges of membership. Any alumni member that participates in any club activity will have to incur his/her own expenses unless otherwise stipulated by the association.

Section IV: Non-students are encouraged and welcomed to attend meetings.

Article IV – Officers

Section I: The officers of this organization shall be President, Vice-President, Advisor (which shall appointed by the President), Secretary, and Treasurer.

Section II: Officers will be elected by simple majority by secret ballot per year. At least two members or officers must be present.

Section III: If an officer is unable to complete his/her term of office, a new officer will be nominated and elected.

Article V – Dues

Dues for membership are determined by the costs incurred by the association activities and shall be determined by majority of vote. This amount shall be no more than \$20 per year.

Article VI: Amending the Constitution and Bylaws

Amendments to the Constitution or Bylaws must be presented in writing and read at a regular meeting by any member. The voting for the amendment shall be the next regular meeting with a 2/3-majority vote.

Article VII – Meetings

Section I: Regular meetings shall be held during the school year at least once a month. The day and time of these regular meetings shall be determined by the members upon majority of vote. At least two members or officers must be present at the time of the vote.

Section II: Members or officers of the organization may request a change of the meeting day and time due to schedule conflicts. Such changes may only be made by a majority of vote with at least three members of officer present.

Section III: Special meetings may be called by President and advertised by an electronic mailing list or other means.

Article VIII – Committees

If there becomes a need for a committee for certain activities or functions of the association, it shall be formed by officers or members that wish to be involved. The need of a committee and the number of individuals on a committee shall be determined according to needs and must be approved by the President and at least one other officer.

Article IX – Attendance

If an officer misses two consecutive meetings without sending prior notice or without sending an alternative, he/she will become considered for dismissal by other officers.

Article X – Additional Rules

Section I: Islam and Dialogue Student Association (IDSA) strictly adheres to the University drug and alcohol policies, and any member found violating these policies shall be considered for dismissal by the officers.

Section II: All members and officers must act and speak with respect to others' views and beliefs and must not be offensive. Any member or officer that does not observe these rules shall be considered for dismissal.

CONSTITUTION

Article I – Name


