JUDO CLUB AT NC STATE

Constitution

August 2003

Article I NAME

Section 1 This organization shall be known as the Judo Club at NC State. For convenience it may also be referred to as the Judo Club.

Section 2 The purpose of the Judo Club is to teach and promote the sport of judo within the NC State university community.

Article II MEMBERSHIP

- Section 1 Membership shall be open to NC State students and employees.
- Section 2 Judo Club officers may grant membership to qualified persons.
- Section 3 Membership may be revoked by Judo Club officers in cases where a member violates university policies, regulations, or rules, and also where a member's conduct is not in the best interests of the Judo Club.

Article III OFFICERS

- Section 1 Officers shall be chosen by majority vote of active members except as provided in Section 2 below. A member is "active" if he or she participates in practice sessions twice a month or more.
- Section 2 The first officer slate will be chosen by majority vote of the active judo players at NC State as of August 2003.
- Section 3 The officers shall be a President, Vice President, Secretary, and Treasurer.) They shall serve for a one-year term beginning each September.

Section 4 Officer duties shall be allocated by mutual agreement of the officers, with the President making the decision if they cannot agree. Duties shall include attending meetings, filing reports, and meeting other requirements established by the Intramural-Club Sports office and the Campus Activities and other Student Affairs offices, maintaining a club roster, maintaining club financial accounts, publicizing the club, obtaining practice space, notifying members of practice location and times, and other administrative duties as needed.

Article IV DUES

Section 1 The level of dues, if any, is to be determined by the Judo Club members at the beginning of each semester.

Article V AMENDING THE CONSTITUION AND BY-LAWS

Section 1 Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member for the proposed amendments. A majority of 2/3 for the members present and voting shall be required.

Article VI MEETINGS

Section 1 Business meetings shall be held in conjunction with practice sessions, as needed. In addition, there shall be a business meeting at the beginning of each semester.

ARTICLE IV. OFFICERS

- Section I. The officers of this organization shall be chosen from and by the active members of the club.
- Section II. The officers shall be President, Sensei-Session Advisor, Secretary-Treasurer, and Faculty Advisor.
- ARTICLE V. DUTIES OF OFFICERS

Section I. The President shall:

- (A) enforce all provisions of this constitution.
- (B) be responsible for reporting to the Club Sports Coordinator in the Intramural-Recreational Sports Office during the first two weeks of school.
- (C) be responsible for submitting a club roster and medical, insurance, and release and assumption of risk forms to the Intramural-Recreational Sports Office.
- (D) submit an inventory of all equipment which has been purchased for club use by the Intramural-Recreational Sports Office or the Sports Club Authority.
- (E) submit a statement of all club funds on hand, both in checking and savings, at the end of each semester.
- (F) submit a request for funds to the Student Senate each year during the Fall semester.
- (G) handle all publicity for club functions.
- Section II. The Sensei-Session Advisor shall:

- (A) advise members on proper Judo techniques during each session.
- (B) assume duties of President during his or her absence.
- (C) assist the President when needed.
- Section III. The Secretary-Treasurer shall:
 - (A) be present to take minutes of meetings.
 - (B) conduct correspondence for the club and update the club roster.
 - (C) notify members of club functions.
 - (D) keep a proper record of equipment.
 - (F) keep an accurate record of all accounts and collect dues.
 - (G) assist the President in budget preparation.
- Section IV. The Faculty Advisor shall:
 - (A) attend a minimum of 3 business meetings of the club (Preferably the first business meeting of the spring and fall semesters and the last meeting of the spring semester).
 - (B) be the first in line to approve all club functions.
 - (C) serve as information source for providing guidance.
 - (D) advise the members in making their yearly budgets.

ARTICLE VI. ELECTIONS

- Section I. The officers will be elected by a majority vote of at least 1/2 of the total membership.
- Section II. The officers shall serve for two semesters with new officers being elected at the last business meeting of the spring semester and taking charge

pending election.

- Section III. Officers may be removed from office by a majority vote of at least 1/2 of the total membership.
- Section IV. Officers may succeed themselves as long as the members of the club elect them.
- ARTICLE VII. EXECUTIVE COMMITTEE
 - Section I. The Executive Committee shall consist of the President, Sensei-Session Advisor, Secretary-Treasurer, Faculty Advisor, and two at large members from the general membership, elected by a majority vote of those present at called meetings consisting of at least 1/2 of the total membership.
 - Section II. (A) make recommendations on policies and policy changes.
 - (B) make recommendations on purchases and expenditures.
 - (C) carry out constitution.
- ARTICLE VII. DUES
 - Section I. Dues shall be determined by a majority vote of members present at the first business meeting of the fall semester in agreement with the Club Sports Coordinator.
- ARTICLE IX. ACTIVITIES
 - Section I. Membership recruitment.
 - Section II. Competition with other clubs and colleges in accordance with Intramural-Recreational Sports guidelines.
 - Section III. Competition within the club.
 - Section IV. Practice sessions.
 - Section V. Developmentt of Judo within the university.
 - Section VI. There will be a minimum of one business meeting of the club held per semester.

Section VII. All club activities are subject to approval of the Club Sports Coordinator.

ARTICLE X. AMENDING THE CONSTITUTION AND BY-LAWS

- Section I. The constitution can be amended by a majority vote of the active members in a meeting consisting of at least 1/2 the total membership.
- Section II. All amendments to the constitution or by-laws shall be subject to approval of the Club Sports Coordinator.
- Section III. Any article of this constitution or part thereof that is in direct violation of the Student Government constitution or by-laws shall be null and void and declared unconstitutional by the President of Student Government. Any differences of opinion between the club and the President of Student Government shall be brought before the Legislature, whose decision shall be final.
- ARTICLE XI. BY-LAWS
 - Section I. Policies and procedures will be approved by a majority vote of at least 1/2 the total membership and the Club Sports Coordinator.
 - Section II. A member exhibiting unsportsman-like conduct may be voted out of the club by a majority vote of at least 1/2 of the total membership.
 - Section III. All club activities must be in compliance with the guidelines of the Club Sports Program of the Intramural-Recreational Sports Office.
 - Section IV. This constitution will be updated each year no later than October 15.
 - Section V. Should the Judo Club become inactive or disband and a new Judo Club is not formed within the period of one year, all property of the club shall become the property of the Intramural-Recreational Sports Office.
