Bylaws

Under the authority of its charter granted by the Knight Commander on April 7, 1997, and pursuant to section 9-211 of Kappa Alpha Laws, Alpha Omega Chapter of Kappa Alpha Order, located at the University of North Carolina State, adopts theirs bylaws for its government.

Article 1-Chapter Meetings

- 1.1 <u>Regular Meetings</u>- Regular meeting of the Chapter shall be held in the Chapter House in the Chapter Room on each Sunday the University is in session. Subject to following the minimum requirements of Section 9-212, the No. 1, for cause such as examinations being in progress or a conflicting athletic, social or other university scheduled activity, may cancel any regular meeting.
- 1.2 <u>Special Meetings: Notice-</u> A special meeting may be held as prescribed in Section 9-213, except that the No. 1 may call a Special Meeting upon posting a six hour notice, provided that he shall, in any such case and prior to such meeting, cause each member of the Chapter who does not live on the Chapter House to be notified by telephone or otherwise.
- 1.3 <u>Attendance Required</u>; <u>Excused Absence</u>- Each member of the Chapter shall attend each and every regular or special meeting of the Chapter. Except when unavoidable circumstances (of which the No. I and the No. 7 shall be the judge) prevent, a member shall notify the No. 1 or the No. 7 in advance and state his reason when he knows that he will be absent from a meeting.
- 1.4 <u>Parliamentary Procedure</u>- Except as otherwise provided by the laws or customs of the Order, Robert's Rules of Order, Revised, shall govern the parliamentary procedure of the Chapter. Each member in meeting shall observe the parliamentary procedure and proper decorum at all times.
- 1.5 <u>Fines</u> may be imposed by the No. 7 on any member of the chapter that breaks any one of the rules. The fines will given at standards committee at the end of each meeting. All fines may be given to the No. 1 for an appeal.
- 1.6 Failure to pay fines Any member not paying outstanding fines shall go in front of Standards Committee to receive his punishment.

Article 2- Officers

- 2.1 <u>Responsibilities</u>- In addition to any responsibilities of officers imposed by any provision of the Kappa Alpha Laws, the officers of the Chapter shall be charged with the enforcement of the Kappa Alpha Laws, these bylaws and any rules and regulations of the Chapter made pursuant to these bylaws. The officers of the Chapter shall also see, to the best of their ability, that all applicable regulations of the University of North Carolina State, the Interfraternity Council, and any other person or entity having supervisory authority over the chapter are observed.
- 2.2 <u>Social Functions</u>- The No. 1, the No. 2 and the No. 3 and all other officers are expected to attend all functions of the Chapter and to discharge their respective duties while in attendance.
- 2.3 <u>Residence</u>- The No. 1 and the No. 6 are expected to live in the Chapter House during their term of office unless the chapter votes by 3/4 to allow otherwise.

- 2.4 <u>Summer Officers</u>- If the No. 1 does not expect to be in residence at the Chapter House during any period the Chapter House is occupied during the summer school session, he shall, at the end of the spring semester, appoint a summer president who shall be at summer school both sessions and whose duties shall be to supervise the operations of the house, including the kitchen, and the care of the vard.
- 2.5 <u>Interfraternity Council Representatives; Designation</u>- The No. 1, or such other member(s) of the chapter designated by him, shall represent the chapter in the Interfraternity Council of the University of North Carolina State representatives in order of priority shall be appointed by the No. 1.
- 2.6 <u>Province Council Representatives</u>- The No.1 and the No.2 shall be the official delegates of the chapter to Province Council. For casting the two votes of this Chapter in Province Council meetings, both votes shall be cast as the majority of the members of the Chapter present at any such meeting may determine by the two highest ranking officers present. In the event the members present are equally divided upon any question, one vote shall be cast on each side of the question being voted upon by the Council.
- 2.7 <u>Ritualist</u>- The No. 1 shall appoint a Ritualist for the Chapter who shall direct initiation and be in general charge of initiation equipment.
- 2.8 <u>Election of Officers</u>- The No. 1,2,3 shall be elected in accordance with <u>Kappa Alpha Laws</u>. The No. 6 is appointed by the No. 1. However, the No. 1 will ask for a vote on who would be the best candidate and makes his appointment accordingly. The No. 6 is in no way a legally elected chapter officer.

ARTICLE 3 - CHAPTER EMPLOYEES

- 3.1 <u>Termination of Chapter Employees</u>- For such actions as he may feel immediate steps are needed, the No.1 may hire and fire any employee of the Chapter except the CRA, without immediate permission of the Prudential Committee. Such action is subject to review by the Prudential Committee.
- 3.2 Other Employees- There shall be a cook. He or she shall cook three meals a day, Monday through Thursday and breakfast and lunch on Friday. He or she shall meet with the kitchen manager in ordering and preparing meals for the upcoming week.

ARTICLE 4 - COMMITTEES

- 4.1 <u>Committees; in General.</u> The No. I may change the personnel of any standing committee at any time. Each standing committee shall report of its activities to the Chapter each week or more often as requested by the No.1. Each standing committee may have such sub-committees as the committee itself may determine. A majority of any standing committee shall constitute a quorum for any meeting of the committee. Each committee of the Chapter shall make pertinent recommendations to the Chapter and shall act with respect to its respective purposes in such manner as the Chapter may direct.
- 4.2 <u>Special Committees.</u> Special committees shall be appointed or elected for such purposes as the No. I deems appropriate or as the chapter shall direct. A special committee shall not be established for any matter upon which there is a standing committee...
- 4.3 Executive Committee. The executive committee shall be composed of all officers of the Chapter and such committee chairmen and other members as may be designated by the No. 1. The executive committee shall meet once a week to advise the No. 1 concerning matters on which he requests advice. Although the executive committee, as a matter of course, vote on matters before it, its determinations are strictly advisory and are not in derogation of authority and responsibility of No. 1.
- 4.4 <u>Prudential Committee</u>- The Prudential Committee shall consist of the No.1, No. 2, and No. 3 of the chapter as provided in Section 9-225. The No. 6 shall not be a member of the Prudential Committee, but he shall meet with and advise the Prudential Committee as requested by the Committee. At least once a

month, the Prudential Committee shall review the report of the Chapter's CPA and compare expenditures against the budget. Furthermore the Prudential Committee shall satisfy itself that all expenditures have been properly made and properly classified. The No. 1 shall report the activities of the Prudential Committee at every Chapter meeting after which there has been an assembled meeting of the Prudential Committee.

- 4.5 <u>Standards Committee</u>- The Standards Committee shall consist of the No. 1, the No. 2, No. 3, and No. 7. The Standards Committee shall counsel in a fraternal spirit with active members of the Chapter so that the highest standards of the Kappa Alpha Order may be evident in the character and conduct of all members of the Chapter and in the activities of the Chapter.
- 4.6 <u>Rush Committee</u>- The Rush Committee shall carry on a year round rushing program, searching and recommending worthy candidates for membership and investigating persons recommended to the Chapter for membership. The Rush Committee shall also make a calendar of events for both fall and spring rush. They will be responsible for giving out bids to incoming rushees.
- 4.7 <u>Alumni Relations Committee</u>- The Alumni Relations Committee shall plan and carry out a consistent and annual program to inform the Alumni of the Chapter of the Chapter's activities, and to encourage the Alumni of the Chapter to participate in Chapter activities.
- 4.8 <u>Social Committee</u>- The Social Committee shall plan all social activities for the Chapter. He shall bring up all social events for approval in Chapter meetings. All events should be placed on the calendar in the foyer as soon as possible.
- 4.9 Pledge Education Committee- The No. 2 shall be the chairman of the Pledge Education Committee. The Pledge Education Committee shall encourage the members and the pledges of the Chapter to seek campus honors and shall directly require each freshman member or pledge to engage in such campus activities as the committee may determine. The Pledge educator shall administer the Pledge Education Program established by Kappa Alpha Order as supplemented in these bylaws and as further supplemented by action of the Chapter from time to time.
- 4.10 <u>Scholarship Committee</u>- The Scholarship committee shall encourage the scholarship of the members and the pledges of the Chapter, and shall directly require each freshman member or pledge to engage in such activities designed to improve his scholarship as the committee shall deem feasible.
- 4.11 <u>Ammen Award Committee</u>- The Ammen Award Committee shall prepare the Chapter's annual application for an Ammen Award and shall monitor Chapter activities so that sufficient activities will be engaged in so the Chapter will be eligible for an Ammen Award.
- 4.13 <u>Community Service Committee</u>- The Community Service Committee shall plan and supervise fund raising projects for MDA. It shall also organize and supervise other community service functions such as the "highway clean-up" and the carnival.
- 4.14 <u>Public Relations Committee</u>. The Public Relations shall cause press releases to be sent to appropriate newspapers and other media regarding activities of the Chapter or its members which are worthy of public notice.
- 4.15 <u>Old South Committee</u>- The Old South Committee shall be in charge of all responsibilities going towards Old South. The Chairman of the Old South Committee shall be selected by a majority vote of the active members of the chapter. The Chairmen will then select whom he wants to have on this committee.
- 4.16 <u>Magnolia Committee</u>- The Magnolia Committee shall be in charge of all responsibilities going towards Magnolia. The Chairman of the Magnolia Committee shall be selected by a majority vote of the

active members of the chapter. The Chairmen will then select whom he wants to have on this committee. The Chairman is also responsible for the witting of the letter to the parents explaining the events.

ARTICLE 5 - AFFILIATION, ALUMNI, STATUS AND RUSH

- 5.1 Rush; who may be voted upon- No name shall be brought before the chapter for election to membership during the time of formal rush except names of those individuals who have participated in at least three rush events.
- 5.2 <u>Voting During Rush</u>- People who are eligible to vote are: initiated members and people who have finished pledging and are awaiting initiation. Though if they are still pledging they are not allowed to vote under any circumstance.
- 5.3 Affiliation- The Chapter shall abide by all guideline established in the Laws concerning affiliation of a transferring initiated member. A transfer may not be eligible for affiliation during the period of formal rush. A transfer may visit the chapter and assist in the process of formal rush, but may not be voted upon for affiliation until such time as rush is over. A transfer shall not be eligible for affiliation until a membership requirement has been fulfilled; during this period he shall be required to show interest in the Chapter but will not have the privileges of an active member to vote in Chapter Meetings until his request for affiliation is approved.
- 5.4 <u>Alumni Status</u>- A member who receives Alumni Status from the Chapter pursuant to Section 8-213(c), must tell the chapter at the time he requests Alumni Status if he desires to continue to participate in social and other activities of the Chapter. A member who wishes to receive Alumni Status must have been a member of the Chapter for seven semesters. He must also inform the Chapter if he wishes to continue to eat meals in the Chapter House. A member who elects to participate in chapter activities or to eat meals in the Chapter House as an Alumnus must pay for meals and social assessments on the same scale as active members. A member placed on Alumni Status pursuant to Section 8-213(d) may not participate in any chapter activities without the permission of the Standards Committee and the Knight Commander or his designee who placed him on Alumni Status.
- 5.5 <u>Graduate and Professional School Students</u>- Graduate students and professional school students who remain active Members, shall be excused from fraternity meetings at their discretion.

ARTICLE 6 - FINANCES

- 6.1 <u>Dues</u>- Each member affiliated with the Chapter during any semester must pay the dues for that semester. The No. 1 will set a date at the beginning of each semester to the dues are to be paid. If a payment plan is in order, then the person or payment plan shall write a letter saying when and how much he will be paying each month. If a person does not submit a payment plan by the due date, then there will be a \$50 dollar fine added on to his bill.
- 6.3 Meals- All members living in the chapter house are required to be on the meal plan. People not living in the chapter house, who want to be on the meal plan shall tell the No. 6 and he will add it to their bills.
- 6.4 Failure to pay obligations owed to the Chapter- Any member (initiated or pledge) who fails to complete his full financial obligation by the date bills are due without having met with the Prudential Committee and made arrangements to pay at a later date by signing a promissory note, will be fined 25 dollars and suspended until the bill is paid or the member has met with Prudential Committee and worked out a plan of payment. If the Prudential Committee has no meeting between the first of the month and the date the bills are due, the member shall meet with the No. 1 and the No.6 to request arrangements to pay the bill. Holds will be put on them with NCSU.

- 6.5 <u>Special Assessments</u>- Any assessment pursuant to Section 9-222 upon members for any special purpose shall be uniform and shall be made only with the approval of a majority of all of the members of the Chapter. The proceeds from any assessment shall be segregated from other funds of the Chapter and shall be expended only for the special purpose for which the assessment was levied.
- 6.6 <u>Limitations on Assessments</u>are not covered by the Chapter's Budget. The total of all Special Assessments in any month shall not exceed 50 dollars. No Special Assessments may be voted upon which would be collected over a period of two months.
- 6.7 <u>Budget</u>- The Chapter shall operate under the guidelines of a budget which is prepared annually for the Chapter by the Prudential Committee and approved by the majority of the Chapter. The Budget
 - (a) shall specify the room rate rental in the Chapter House.
 - (b) shall outline the rates for meals for members.
- (c) shall specify all sources of income for Chapter members, including parlor fees, social assessments, and other charges the Chapter determines are necessary for normal Chapter operations.

The Budget may be amended from time to time upon recommendations of the Prudential Committee approved by a majority vote of all members of the Chapter or upon a two-thirds vote of all members of the Chapter.

- 6.8 Compensation of Officers- The No. 1 shall not be charged with any rent. The No. 6 shall receive 70 dollars a month. No other officers should be compensated for their services.
- 6.9 <u>Salaries of Other Employees</u>- The salaries of the cook shall be fixed by the Prudential Committee within budget allocations.
- 6.10 Failure to Pay- You house key and or room key will be taken if you are not current with your bill. (4-15-96)
- 6.11 <u>Doubling Up-</u> It is a set cost to live within the chapter house. The same amount of rent applies to each member regardless if he live with a roommate or not. (3-18-96)
- 6.12 <u>4 Semester Rule</u>. Each member is required to live in the chapter house for 4 semester to help keep the chapter house full and the cost of rent down. Two summer sessions can as one regular semester towards your 4 semesters. Exceptions can be made to this policy if there are extenuating circumstances by the Number 1. (1-15-96)

ARTICLE 7 - DISCIPLINARY RULES

- 7.1 Adoption of Chapter House Rules- The Chapter shall adopt, subject to change by it, a set of house rules shall provide for the promotion of study, the care of Chapter property, the maintenance of orderly conduct, the protection of lady guests in the House, and such other matters that the Chapter may deem advisable. In the case of emergency, the Prudential Committee may adopt any house rule which may be effective temporarily until the next meeting of the Chapter. All House rules in effect shall be posted on the house bulletin board.
- $7.2 \, \underline{\text{Purchase of Alcoholic Beverages}}$ The Chapter may not purchase alcohol for the purpose of consumption by its members or others.

- 7.3 Parking in the Cook's Place- There shall be a ten dollar fine for any member parking his car (a) in the cook's parking space (b) in or blocking the side driveway or (c) in or on the yard for an extended period of time.
- 7.4 <u>Anonymous damages to Chapter Property.</u> The cost of repairing any damage done to chapter property anonymously shall be assessed to the members of the Chapter over and above all other assessments, dues, and charges. Any member of the Chapter who damages Chapter property shall report such damage to the No. VII if it is apparent to him that the member committing the damage is not going to report himself.

ARTICLE 8-THE CHAPTER ROOM

- 8.2 <u>Users of the Chapter Room.</u> The Chapter Room shall be used for Chapter Meetings, Inductions, Initiations, Council of Honor Meetings, Committee Meetings, Meetings of the membership or Board of Directors of Alpha Omega Chapter House Corporation and other similar uses.
- 8.3 <u>Chapter Room Decorum</u>. In addition to any other rules the Chapter may adopt relating to the Chapter Room.
 - (a) There shall be no use of profanity of course language in the Chapter Room.
 - (b) There shall be no food consumed or carried into the Chapter Room.
 - (c) There shall be no beverage consumed or carried into the Chapter Room.
 - (d) There shall be no tobacco product consumed or carried into the Chapter Room during the meeting.

These rules relating to Chapter Room Decorum, and any others adopted by the Chapter, shall apply at all times and not only when a meeting is taken place. Exceptions can be made by the vote of 3/4 for each meeting.

ARTICLE 9-ACADEMIC STANDARDS; SOCIAL PROBATION

- 9.1 <u>Grade point Average below 2.00</u> Any initiated member who makes below a 2.00 Grade Point Average (GAP) for two consecutive regular semesters shall be placed on advisory probation until he at least makes a 2.0 (GPA) as a full time student in a regular semester.
- 9.2 <u>Definition of "regular semester"</u> A regular semester is either a fall or spring semester. Both sessions of summer constitute one regular semester.
- 9.3 Effect of Social Probation. A member placed on social probation by the Standards Committee, shall not attend any social event of the Chapter or for the Chapter.
- 9.4 <u>Violation of Advisory or Social Probation</u>. Any member on social probation who attends a social event when not authorized to do so shall be fined \$25.00 and suspended for a period of not less than one week, pursuant to sections 12-112(g) and 12-112(i) of Kappa Alpha Laws.

ARTICLE 10-PLEDGES

10.1 <u>Strike System.</u> A point and demerit system shall be instituted by the Pledge Education Committee, the details of which will be worked out by the Pledge Education Committee, but which shall provide that any pledge, who at anytime has amassed a number of three strikes shall be brought up for the termination of his pledgeship in accordance with KA Law 8-132.

- 10.2 Two semesters to make grades. Any pledge who at the end of two semesters, including the semester of pledging has not made grades sufficient to entitle him to initiation into the Chapter shall be automatically removed with the option to re-pledge.
- 10.3 <u>Study Hall</u>. Pledges are required to attend study hall four nights a week from 7 p.m. to 9 p.m. Monday through Thursday.

ARTICLE 11-SPECIAL AWARDS

- 11.1 The Best Pledge Award. An award shall be given to the best pledge each semester, who will be that pledge amassing the highest total of points at the end of a semester's work. The award is not to be based solely on the number of points, but that is to be one of the factors in determining the recipient of the award.
- 11.2 Most Improved Scholarship Award. The Most Improved Scholarship Award shall be given to the Active Chapter member with the most improvement over two consecutive regular semesters, during both of which he must be a full time student. The name of each winner of The Most Improved Scholarship Award shall be placed on a plaque in recognition thereof.
- 11.2 <u>Best Overall GPA Award.</u> The person who receives this award has earned the best overall GPA for two semesters.
 - 11.3 Highest GPA Award The brother with the highest GPA for two semesters.
- 11.4 <u>Most Improved Award</u> The brother that has had the largest increase in GPA for two semesters
- 11.5 <u>Highest GPA Pledge</u> The pledge that received the highest GPA either in the Spring or in the Fall.
- 11.6 <u>Carol Sims Award</u> The mother that the chapter views to have had the most amount of influence on them for the past year. Awarded at Magnolia Ball and given a personal plaque to commemorate her. This is awarded by a majority vote.
- 11.7 KA Rose Given to the woman that the chapter believes is a all around great person. This is awarded by a majority vote with nominations being taken before the vote.

ARTICLE 12-CHAPTER BYLAWS

- 12.1 <u>Recording of Bylaws</u>. The Bylaws, upon adoption, shall be duly recorded in the place provided for Active Chapter Bylaws in the copy of Kappa Alpha Laws furnished to this Chapter.
- 12.2 <u>Interpretation.</u> These bylaws shall be interpreted by the No. I, subject to an appeal to the Chapter, which may be sustained by a two-thirds vote.
- 12.3 Amendment. The bylaws may be amended by a majority vote of all the members of the Chapter present but an amendment shall not take effect until it is recorded and the record of the member is read and approved by the Chapter at a subsequent meeting. The record shall be made promptly by the No. III in the space provided for Active Chapter Bylaws in the copy of Kappa Alpha Laws furnished to this chapter.
- 12.4 <u>Repealing Clause</u>. All rules, regulations, resolutions, or bylaws heretofore adopted by this Chapter which are in conflict with these bylaws or with the provisions of Kappa Alpha Laws, are hereby repealed.

12.5 <u>Citations to Kappa Alpha Laws.</u> Citations of sections herein refer to the respective sections of <u>Kappa Alpha Laws.</u>

ARTICLE 13-RISK MANAGEMENT POLICY

Each brother has read, understands and will follow the pollicies below:

13.1 Alcohol and drugs.

- a. The possession, sale, use and/or consumption of alcoholic beverages while on chapter premises during an official fraternity event, or in any situation sponsored or endorsed by the chapter, or at any event an observer would associate with the fraternity, must be in compliance with any and all applicable laws of the state, province, county, city and institution of higher education.
- b. No alcoholic beverages may be purchased through the chapter treasury nor may the purchase of same for members or guests be undertaken or coordinated by any member in the name or on behalf of the chapter. The purchase and/or use of a bulk quantity of such alcoholic beverage, i.e., kegs, is prohibited.
- c. No chapter members, collectively or individually, shall purchase for, serve to, or sell alcoholic beverages to any minor (i.e., those under the legal "drinking age").
- d. The possession, sale and/or use of any illegal drugs or controlled substances at any chapter house, sponsored event or at any event that an observer would associate with the fraternity, is strictly prohibited.
- e. No chapter may co-sponsor an event with a distributor of alcohol, charitable organization or tavern (tavern defined as establishment generating more than half of its annual gross sales from alcohol) where alcohol is given away, sold or otherwise provided to those present.
- f. No chapter may co-sponsor or co-finance a function where alcohol is purchased by any of the host chapters, groups or organizations.
 - g. All rush activities associated with any chapter will be dry rush functions.
- h. Open parties, meaning those with unrestricted access by non-smokers of the fraternity without specific invitation where alcohol is present shall be prohibited.
 - i. No member shall permit, tolerate, encourage or participate in "drinking games".
- j. No alcohol shall be present at any pledge/associate member/ novice program or activity of the chapter.
- 13.2 <u>Hazing.</u> No chapter shall conduct hazing actives. Hazing activities are defined has: "Any action taken or situation created, intentionally, whether on off fraternity premises, to produce mental or physical discomfort, embarrassment, harassment, or ridicule. Such activities may include, but are not limited to, the following: use of alcohol; paddling in any form; creation of excessive fatigue; physical and psychological shocks; quests, treasure hunts, scavenger hunts, road trips or any other such activities carried on outside or inside the confines of the chapter house; wearing of public apparel which is conspicuous and not normally in good taste; engaging in public stunts and buffoonery; morally degrading or humiliating games and activities; and any other activities which are not consistent with fraternal law, ritual or policy or the regulations and policies of the educational institution."
- 13.3 <u>Sexual Abuse</u>. The fraternity shall not tolerate or condone any form of sexually abusive behavior on the part of its members whether physical, mental or emotional. This is to include any actions which are demeaning to women and/or men, including but not limited to, date rape, gang rape, or verbal harassment.

13.3 Fire, Health, and Safety:

a. All chapter houses shall, prior to, during and following occupancy, meet all locl fire and health codes and standards.

- b. All chapters must have posted by common phones emergency numbers for fire, police, and ambulance and must have posted evacuation routes from chapter houses, common areas and sleeping rooms posted in said areas and sleeping rooms posted in said areas on the back of the door of each sleeping room.
- All chapters shall comply with engineering recommendations as reported by the insurance company.
- d. The possession and/or use of firearms or explosive devices of any kind within the confines and premises of the chapter house is expressly forbidden.
- 13.4 Education. Each student member, associate member, and pledge shall be instructed annually on the Risk Management policy

Constitution

Article I. Name and Purpose

Section 1. This organization shall be known as the Alpha Omega

Chapter of Kappa Alpha Order.

Section 2. The purpose of this club shall be the uniting in fraternal bonds men that share common ideals and

interests.

Article II. Membership

Section 1. Membership shall be open to all students which possess the character traits necessary to attain the goals of

the chapter.

Section 2. Members will be selected in two stages. First they will be given an invitation to join (commonly, referred to as a "bid") after they have received a unanimous vote of approval by the active members. Then, after a period of pledgeship, they will be voted on once again by the active brotherhood. Upon passing this vote

by a 2/3 majority they shall be initiated as full members.

Article III. Officers

Section 1. The elected officers of this club shall be the President, Vice-President, and Recording Secretary. All other

Vice-President, and Recording Secretary. All other officers shall be appointed by the President.

Section 2. They officers shall be elected by the club members

to serve a term of one year, beginning the second Monday

in the month of March.

Article IV. Dues

Section 1. There are no dues as such required by this organization, However, there is a pledge fee of thirty dollars, an initiation fee of sixty five dollars and an annual

fee of twelve dollars per pledge and brother all of which

are paid to Kappa Alpha Order, National.

Article V. Amending the Constitution and By-Laws

Section 1. Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after in-

forming each member of the propsed amendments. A majority of 2/3 of the members present and voting shall be

required.

Section 2. All amendments to this constitution or by-laws shall

be subject to the approval of the Student Government. Section 3. Any article of this constitution or part thereof

Section 3. Any article of this constitution or part thereof that is in direct violation of the Student Government Constitution or By-laws shall be null and void and declared unconstitutional by the President of Student Government. Any differences of opinion between the

club and the President of the Student Government shall be brought before the Legislature, whose

decision shall be final.

Article VI.

Meetings

Section L There shall be a regular chapter meeting at a designated time mutually agreed upon by the members. When conditions warrant, the President may postpone or cancel the regular meeting. Also, the President has the power to call a meeting at his discretion.

Article VII.

Committees

Section 1. The President shall create a committee at his discretion or when dictated by a two thirds vote taken from the brotherhood. The purpose, goals, and power of such committees shall be clear before a vote is taken on their formation.

By-Laws

- No illegal drugs shall be possessed or used in the chapter house and chapter premises.
- 2. All active members are required to attend initiation proceedings.
- 3. All active members are required to attend rush meetings and bid sessions.
- 4. All active members must wear proper attire to formal chapter functions.
- All active members and pledges are required to promptly meet their financial obligations to the chapter.
- All active members and pledges are required to attend regular meetings, except when excused by the President.
- All active members are required to attend any other meeting which is deemed necessary by the President.
- 8. All active members are required to conduct themselves in a gentlemanly and orderly way and uphold the teachings and ideals of Kappa Alpha Order.
