Article VII. Amending the Constitution and By-laws

Section 1. Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the members present and voting shall be required.

Section 2. All amendments to this constitution or by-laws shall be subject to the approval of the Student Government.

Section 3. Any article of this constitution or part thereof that is in direct violation of the Student Government Constitution or By-laws shall be null or voidand declared unconstitutional by the President of Student Government. Any differences of opinion between the club and the President of the Student Government shall be brought before the Legislature, whose decision shall be final.

Article VIII. Board of Directors

Section 1. The Board of Directors shall have the power to set policy on club matters, and these policies shall be in accordance with Student Government policies.

Section 2. The Board shall consist of the following members the President of the club, and two duly elected non-officers from the body of the club.

Section 3. The Board shall have a term of one year with a maximum tenure of two years.

## GB # 88-05: Illegal Interest Groups & Activities

### Policy

No chapter of Kappa Alpha Psi Fraternity Inc. shall maintain, endorse or affiliate with any male interest group, such as *Men interested in Kappa* [MIKs] or *Those inclined Kappa* [TIKs].

No chapter of Kappa Alpha Psi Fraternity Inc. shall maintain, endorse or affiliate with any female support group, such as *Kappa Kittens*.

No chapter of Kappa Alpha Psi Fraternity Inc. shall encourage the independent formation of a male or female interest group as defined above.

No chapter of Kappa Alpha rsi Fraternity Inc. shall engage in any activities that may be interpreted as pledge activities other than activities that are consistent with the Membership Intake Program adopted by the Grand Board.

Failure to comply with any provision herein may result in disciplinary action including the recalling of a chapter charter.

### Rationale

The Policy is an editorial revision of previous policies adopted 11 Feb. 1978. It has been expanded to include pledge activities and the unofficial pledging of sweetheart courts.

Dean Talley has referred your letter of November 6 requesting information regarding the procedure for establishing social fraternities on campus to me. At present there are no specific written guidelines for such a process, however, we do adhere to the following structure:

- Students interested in establishing a social fraternity are required to petition the Office of Student Development to be chartered as a student organization.
- 2. Once they have been established as a student organization, they may charter as a fraternity under a national fraternity's name provided they have the sanction of that fraternity, or they may be designated by a national fraternity as a colony of that fraternity. As a third option, they may choose to be a local fraternity with no national fraternity affiliation.

This procedure as you can see can be quite varied. If you have specific questions regarding the establishment and chartering of a social fraternity on this campus, please do not hesitate to contact me. I hope this has answered your inquiry.

PREDGING PROCEDURES

The three enclosed documents are for your special attention:

- 1. Pledge Indemnification Agreement
- 2. Chapter Pledge and Indemnification Agreement
- 3. Pronouncement on Disciplinary Procedures for Hazing

The Pledge Indemnification Agreement must be read and signed by each pledge at the time of pledging. He shall sign two (2) copies and his signature must be witnessed by the chapter's Keeper of Records. The original copy must accompany his pledge registration fee; the copy is retained by him.

The chapter pledge and Indemnification Agreement must be signed at the beginning of each fraternity year and mailed to National Headquarters. However, should there be a change in officers, a new agreement must be signed and forwarded to this office.

The last document, "Pronouncement on Disciplinary Procedures for Hazing" should be read and discussed at your chapter's meeting and filed for future reference.

Each chapter will be supplied with the required number of copies of the "Pledge Indemnification Agreement" when they are notified that their petitions seeking authorization to pledge and initiate men have been approved.

Remember, alumni pledges will not be registered with this office unless we have received a copy of the Pledge Indemnification Agreement signed by each pledge and the chapter's Pledge and Indemnification Agreement properly signed by its officers.

## KAPPA ALPHA PSI FRATERNITY, INC. PRONOUNCEMENT ON DISCIPLINARY PROCEDURE FOR HAZING

It has been the policy of Kappa Alpha Psi Fraternity, declared in 1949, that hazing in any form is illegal. Any member, pledge or probate participating in hazing is subject to disciplinary action.

It is further the policy of the Fraternity that interest groups, Scroller Clubs and other groups of persons aspiring to membership in the Fraternity are designed for the sole purpose of creating harmony and fellowship among the persons so involved and instructing them in the principals of the Fraternity found in its Constitution, Statutes, history and traditions.

Pursuant to the authority given in Article V, Section I of the Constitution, the Board of Directors makes the following pronouncement relating to the Fraternity's policy:

### A. Definitions

- 1. The word <u>hazing</u> is any action taken or situation created however communicated, involving or resulting in abusive physical contact or mental harrassment to a pledge, whether on or off the fraternity premises, campus or place where chapters or pledge clubs or interest groups meet, designed to or the result of which is to produce mental or physical discomfort, embarrassment, harassment or ridicule. Such activities and situations include but are not limited to paddling in any form; creation of excessive fatigue; physical and psychological shocks; quests, treasure hunts, road trips; wearing apparel which is conspicuous and not normally in good taste; engaging in public stunts and buffoonery; morally degrading or humiliating games and activities; late work sessions which interfere with scholastic activities; and any other activities which are not consistent with either fraternal law, or the regulations and policies of any educational institution or state or federal law.
- The word <u>participants</u> includes those members or chapters who take part in hazing, those who sanction or give prior approval to hazing, and observers.

- 3. The word <u>observers</u> includes those who know or come to know of the hazing by personal knowledge, investigation, or by being told of the hazing by those who actually took part in hazing, and who fail to report the same to the National Headquarters of the Fraternity, 2320 North Broad Street, Philadelphia, Pennsylvania 19132
- 4. The word <u>pledge</u> for purposes of this document includes, in addition to those members of "interest groups", and persons who have declared their desire to become members of the Fraternity but have not been duly initiated into the Scrollers' Club, Scrollers, whether active or inactive.
- 5. The word members includes all men who have been initiated into the Fraternity.
- The word <u>chapter</u> for purposes of this document, includes all chartered units
  of the Fraternity.
- The word officer shall include all officers of the chapter, as defined in Article XXVIII, Section 1 of the Constitution whether elected or appointed.
- 8. The word <u>report</u> means to direct communication by whatever means expedient, within 48 hours of any occurrence or discovery of hazing, places, times, activity constituting hazing, name and address of participants and pledges, and injuries suffered, if any. All communication of hazing shall be confirmed in writing within five days of the initial communication in the same detail as provided in this paragraph 7.
- 9. The word <u>probation</u> means that members of the Chapter shall retain control over the affairs of the Chapter but under strict supervision of the Province Polemarch, or his designee. In case of probation and restrictive probation as defined in paragraph 10, the Province Polemarch or his designee shall, for the purposes of rehabilitating the offending chapter and its members, conduct two local periodic training sessions or seminars and shall direct the attendance of delegates of any Chapter under probation or restrictive probation at Province meetings, and may take other measures designated to rehabilitate the Chapter and its members putting particular emphasis on the illegality of hazing in the conduct of the affairs of the Chapter.
  - a. Attendance at local seminars and periodic training sessions shall be manditory for all officers, participants not under suspension and not less than seven undergraduate members, and in the case of an alumni chapter all officers, participants not under suspension and not less than ten members.

- 10. The words restrictive probation means that members of the Chapter shall, have no authority to carry out any function of the Chapter without the prior written approval of the Province Polemarch and under the strict personal supervision of the Province Polemarch or his designee. These functions specifically include, but are not limited to, rushing, pledging, initiations, qualifying persons for initiation into the Fraternity, and meetings of the Chapter and Scrollers Club, and interest groups, if any. The conditions of probation as set forth under paragraph 9 hereof shall apply also in cases of restrictive probation.
- B. Penalties Applicable to Members and Pledges.
  - 1. Being a participant in acts of hazing,
    - a. Fine in an amount not less than \$100, nor more than \$500 and suspension for a period not less than one year, nor more than 15 years, or in extreme cases, expulsion.
  - 2. Being a participant in hazing when under suspension.
    - a. Fine of \$500 and suspension for a period not less than 10 years consecutive with any current suspension.
  - 3. Being a participant in hazing while an officer of a chapter.
    - a. Fine of not less than \$200 nor more than \$600 and suspension for a period of not less than two, nor more than 15 years, or in extreme cases, expulsion.
  - 4. While an officer of a chapter, permitting any member under suspension for hazing to take part in any activities of the chapter as if he were a member in good standing, the officer having knowledge of the same.
    - a. Fine of \$200.
  - While a pledge, Failing to report incidents of hazing to the National Headquarters Office of Kappa Alpha Psi Fraternity, Inc.
    - a. Fine of not less than \$25.00
- C. Penalties Applicable to Chapters.
  - Whenever it is determined that hazing is a permitted activity of a chapter the following sanction is applicable:
    - a. Fine of \$300, or the Chapter to be placed on probation or restricted probation for not less than three years, or both, or in extreme cases, suspension or recall of the charter.

- Whenever hazing has occurred and the individual members who took part in the hazing are not identified and reported to the National Headquarters' Office as required herein;
  - a. The Chapter shall be fined \$500, and
  - b. each member shall be fined \$50.
  - c. Probation under supervision of the Province Folemarch for not less than two years.
- Second offenses or offenses of bazing committed while under probation, or restrictive probation.
  - a. fine of not less than \$500 and suspension for not less than three years, or recall of the Charter.

#### D. General Provisions

- In all cases where fines are imposed, suspension is automatic until the fine is paid in full.
- 2. In cases of Probation or Restrictive Probation, the Frovince Polemarch with the prior written approval of the Grand Board of Directors may delegate his duties to a specific individual or individuals within his province

### PLEDGE INDEMNIFICATION - AGREEMENT

I, , understand and agree that submission to HAZING is not a requirement of the pledge program of Kappa Alpha Psi Praternity and that HAZING, WHICH CONFLICTS WITH THE RULES AND RECULATIONS OF A COLLEGE OR UNIVERSITY OR WHICH IS IN THE FORM OF PADDLING, STROKING, BEATING, AND ALL INDECENT ACTS OR ACTS WHICH ENDANGER THE LIFE OR HEALTH OF A FLEIGE OR INTER-FERES WITH HIS SCHOLASTIC WORK, ACTS OF PERSONAL SERVITUDE OR PSYCHOLOGICAL HAZING, are specifically prohibited by Article XXIV, Section 11 of the Constitution, and Statute 21, Sections 3, 4 and 16 of the Statutes of the Fraternity; and further that should I, while a pledge or member of the Fraternity submit myself to, approve directly or indirectly, or participate in HAZING, I am in violation of the Constitutional and Statutory prohibition and I may be fined, suspended from the Fraternity for a period of months, years, or for life, or expelled from membership in the Fraternity.

Further, I understand and agree that it is my solemn duty, should I be submitted to, participate in, or come to know of hazing being imposed on others, I shall report the same in writing, listing dates, place, time, and persons involved to the National Headquarters of Kappa Alpha Psi Fraternity, Inc., 2320 North Broad Street, Philadelphia, Pennsylvania 19132.

FURTHER, I AGREE TO HOLD AND SAVE HARMLESS AND INDEMNIFY AND KEEP INDEMNIFIED KAPPA ALPHA PSI FRATERNITY, INC., AGAINST ANY AND ALL LIABILITY FOR LOSSES AND/OR EXPENSES OF WHATSOEVER KIND OR NATURE WHICH KAPPA ALPHA PSI FRATERNITY, INC., MAY SUSTAIN AND INCUR BY REASON OF SUCH VIOLATION OF THE CONSTITUTIONAL OR STATUTORY PROVISION PRCHIBITING HAZING.

I FURTHER UNDERSTAND THAT I AM NOT WAIVING ANY RIGHT AGAINST ANY INDIVIDUAL WHICH I MAY HAVE OR OBTAIN AS A RESULT OF ANY INJURY TO MYSELF OR MY PERSON AS A RESULT OF HAZING.

I FURTHER UNDERSTAND THAT I WILL NOT BE PENALIZED OR DISCIPLINED IN ANY WAY
BY KAPPA ALPHA PSI FRATERNITY, INC. FOR HAVING REPORTED INCIDENTS OF HAZING AS REQUIRED BY THIS AGREEMENT; AND FURTHER THAT IF AFTER INVESTIGATION AND CONFIRMATION BY
KAPPA ALPHA PSI FRATERNITY, INC., THAT HAZING HAS IN FACT OCCURRED, I UNDERSTAND
THAT THOSE MEMBERS INVOLVED IN HAZING WILL BE DISCIPLINED BY KAPPA ALPHA PSI FRATEI
MITY, INC.

I FURTHER CERTIFY THAT I HAVE READ AND UNDERSTAND THIS AGREEMENT FULLY, HAVE RECEIVED A COPY OF THE SAME BEARING MY SIGNATURE, AND I AGREE THAT THIS AGREEMENT SHALL BE BINDING AND FULLY EFFECTIVE AGAINST MY HEIRS AND SUCCESSORS AND ASSIGNS.
