

Constitution of the  
North Carolina State University  
Intramural-Recreational Sports  
Men's Soccer Club

Article I - Name

The name of this organization shall be: "Soccer Club At North Carolina State."

Article II - Purpose

The purpose of this organization shall be:

1. To further the interest of North Carolina State University students, faculty and staff in the sport of soccer.
2. To develop skill and adeptness in the sport of soccer.
3. To compete in a sportsmanlike manner with other soccer clubs.
4. To provide an opportunity for those students, faculty, and staff at North Carolina State University who wish to participate in this sport.
5. To provide a better understanding of the sport of soccer among the general student body.
6. To promote friendship among the members.

Article III - Members

1. Membership shall be open to all currently enrolled North Carolina State male students, faculty, and staff members who are interested in the activities of this Club.
2. A team of intercollegiate competition shall be formed consisting of a maximum of 25 players, those members chosen by the existing Club board members within the first two weeks of the fall semester.
3. Another roster shall be made and called the General Club Roster. This roster will include any eligible individuals who are duly selected by the Club's board members to participate in Club activities.

4. Those prospective members not assigned to the intercollegiate team are welcome to practice and scrimmage with the intercollegiate team, provided they are added to the General Club Roster and abide by all of the Club's rules and regulations. The removal of a player for any reason must be agreed upon by the Club's board members.

5. The Club's board members reserve all rights to create subsequent teams to accommodate the needs of members exceeding the maximum limit of the existing roster.

6. A practice roster including all persons shall be published and updated bimonthly at the board member's assembly, with new practice members removed or added accordingly.

7. No new additions may be added to the final Club intercollegiate roster after the first two weeks of the fall semester until the first two weeks of the spring semester unless deemed necessary by a unanimous decision of the current board members.

8. Members of the intercollegiate roster may be dismissed according to the regulations stated within the By-Laws.

9. Dues of members involved with Club Soccer shall be \$60.00 per year, payable to a Club board member within the first three weeks of the fall semester. Any member delinquent in dues shall be placed on game suspension until dues are paid in full. Additions to the roster during the spring semester shall pay a \$30.00 membership due.

10. All members officially on the roster shall be eligible to vote.

11. All members must try out every year for the intercollegiate teams: board members elected in the spring are automatically on the Club's team for the following school year.

12. Sufficient additional funds may be collected by the board members to accommodate the needs of the club with the approval of a two-thirds (2/3) majority of all members.

#### Article IV - Board Members

1. The board members shall consist of five members with one member elected amongst the board assuming the responsibilities of Chairman.

2. Any vacancy within the elected board occurring between annual elections other than the Chairman shall be filled by an eligible member elected at a special meeting called by the Chairman. Should a vacancy arrive in the position of the Chairman, an eligible existing board member will be appointed by the board to assume all of the duties of the Chairman.

3. The three captains of the intercollegiate team shall be appointed by the board from the existing board members with the Chairman automatically fulfilling the duties of one of the captain roles.

4. Any board member may be removed from his position through impeachment proceedings and a unanimous decision by the other four board members who are not in question.
5. All board members shall be elected once annually, on the third Wednesday in the month of April by a majority vote of the general Club assembly consisting of all due paying members, provided a quorum is present.
6. Newly elected board members will begin their terms a week after elections: on the fourth Wednesday of April.
7. Fifty percent (50%) of the Club's membership constitutes a quorum in general assembly.
8. Any member of the faculty of North Carolina State University selected by the Club shall be the faculty advisor, upon his or her consent and approved by the Assistant Director, Club Sports.
9. Any problems that cannot be solved by the team board members shall be carried to the faculty advisor, and if problems continue they will be carried to the Assistant Director, Club Sports.

#### Article V - Duties of Board Members

1. The Chairman shall be the Chief Executive and representative of the Club. He shall preside over all meetings, and provide a meeting place. He shall appoint all committees deemed necessary, and oversee the coordination of all activities with the assistance of the other board members. He shall be the "Ex Officio" member of all committees. Should it be deemed necessary, the Chairman shall have the right to convene all members to special meetings. The Chairman shall be held jointly responsible with the faculty advisor, for any and all activities of the Club. He shall attend all Sports Club Council meetings, and if unable to do so should appoint an appropriate member of the Club to attend. He is also in charge of appointing specific duties to the other members of the board, with their consent. He shall be responsible for upholding the Constitution.
2. The duties of the other four board members consist of the following:
  - a) coordinate intercollegiate team activities
  - b) schedule all games and related activities, upon final approval of the Chairman
  - c) provide all members with a complete schedule of games in a timely manner
  - d) verify and receive directions to all games

- e) receive and dispose all funds with an unanimous approval, as overseen by the Chairman
- f) maintain a careful record of the financial conditions of the Club, and make a financial report at each meeting
- g) maintain an accurate record of dues paid
- h) keep the Club check book balanced and in order
- I) keep an accurate role book, accounting for all meetings and practices
- j) register new members according to the laws on membership
- k) provide all Club members with a roster of Club participants
- l) complete and turn in all paperwork required by the North Carolina State University intramural-Recreational Sports Office
- m) publicize the work and activities of the Club
- n) establish relations with other soccer organizations that will benefit the Club
- o) advertise events of the Club, including games, meetings, and special events
- p) reserve field space on campus for practices, games, and special events
- q) create a practice schedule for the General Club Roster
- r) organize practice games on campus between Club participants, particularly those not involved in intercollegiate play

#### Article VI - Meetings

1. The entire Club team general assembly shall meet three (3) times a semester on a date and time decided upon and specified by the Chairman.
2. All board members shall meet briefly bimonthly, the time and day will be decided upon by a majority of the board members.

#### Article VII - Amendments

1. An Amendment to the Constitution may be proposed by any voting member at any regular meeting of the Club general assembly. The proposed Amendment shall be tabled until the next regular meeting, at which two-thirds (2/3) majority of those present will be

required for its adoption, provided that there is a quorum present. When an Amendment is passed it becomes effective immediately.

By-Laws of the

North Carolina State University

Men's Soccer Club

I. Attendance:

All Club members are required to attend all practices, games, and meetings unless otherwise excused by a board member. A schedule of academic commitments must be provided by each member. Any member not attending a practice or meeting must inform a board member at least one hour prior to his absence. Any member not attending a game must inform a board member at least three days prior to the game of absence.

II. Suspension:

Any member of the Club may be placed on suspension due to a flagrant violation to the Attendance Policy, disorderly conduct, or poor attitude. Any member on suspension shall not play in any games until off suspension. The removal of a suspension on a member is by the decision of the board members and approval from the Assistant Director, Club Sports.

III. Respect:

All members must respect the decisions of the Board members, the captains, faculty advisor, and athletic officials. The captains are to be given the same respect as a coach because of their leadership role among the team.

IV. Rosters:

Both the intercollegiate roster and the General Club Roster are decided upon by the members of the Board with the criteria of attendance, attitude, work ethic, ability, and desire.

V. Playing Time:

The appointed captains will decide the amount of playing time for each member on his own discretion. They will be in charge of substitutions, unless otherwise specified, throughout each game.

#### VI. Removal from the Team/Roster:

Any player who is thought, by the board members, to be upholding the morals of the Club in a poor manner may be removed from the roster with approval of the Assistant Director, Club Sports. Whoever has been removed may be replaced at the board members discretion. Any member who has flagrantly violated and laws written by this Club, North Carolina State University, or any other higher governing power is subject to losing membership with this Club without a refund, and he is not eligible to become a member again until the next school year with approval of the Assistant Director, Club Sports.

#### VII. Activities:

All Club activities must be in compliance with the guidelines of the Club Sports division within Intramural-Recreational Sports.

#### VIII. Constitution Revisions:

This Constitution will be updated each year if necessary.

NCSU Boy's Soccer Club  
Constitution

Article I (Name and Purpose)

- Section 1 This organization shall be known as the NCSU Boy's Soccer Club
- Section 2 The purpose(s) of the club shall (will) be the active participation in collegiate club soccer against: any established University or College, any association or league affiliated with the game or sport.

Article II (Membership)

- Section 1 Membership shall be open to all regulary enrolled students who are interested in active participation in the sport of Soccer where travel is a necessity.
- Section 2 Means of selection of members. Tryouts are held at the beginning of every Fall semester. Tryouts in the Spring semester are based upon the need of members for at particular season. The number of tryouts will be determined by the club's officers.

Article III (Officers)

- Section 1 The elective members of the club shall be: President- Chris Tonelli  
Vice-President- Ian Barkley

Secretary- Micheal Herring  
Treasurer- Micheal Klett
- Section 2 The officers shall be elected by the club members to serve a term of one year, beginning each fall semester of every school year.

Article IV (Dues)

- Section 1 Dues for the club shall be set by the Officers of the NCSU Boy's Soccer club prior to tryouts.

Article V (Amending the Constitution and By-laws)

- Section 1 Amendments to the Constitution or by-laws shall be presented by members of the NCSU Boy's Soccer Club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the clubs members and voting
