Men's Volleyball Club Constitution

ARTICLE I Name and Purpose

Section 1

This organization shall be known as the Men's Volleyball Club.

Section 2

The purpose of this club shall be to provide a team to represent the University in 6-man indoor volleyball. The club shall conduct practices and endeavor to participate in interscholastic competitions at the club level.

ARTICLE II Membership

Section 1

Membership shall be open to all regularly enrolled students who are interested in the activities of the club, as broadly described in ARTICLE I – Section 2.

Section 2

Members of the club shall be determined through tryouts. The schedule and specific regulations regarding the tryouts shall be determined by the current club officers. Tryouts shall occur at least once per semester (Fall/Spring). A member of the club may be dismissed as a result of disorderly conduct or violation of rules set forth by the current club officers. Such a dismissal shall require a majority vote among the club officers.

ARTICLE III Officers

Section 1

The elective officers for this club shall be the President, Vice-President, Secretary, and Treasurer. The President shall oversee the management of the club and act as liaison with University staff. The Vice-President shall assist the President in these duties. The Secretary shall oversee the management of the club's webpage and the creation of any club documents or postings. The Treasurer shall oversee the club's financial account and the organization of fundraising events. All officers shall contribute to decisions on rules and scheduling for the club. Any change to club rules shall require a majority vote among the club officers.

Section 2

The officers shall be elected by the club members to serve a term of one year, beginning in May and ending the following May. The exact date of the election and the specifics of election procedure shall be determined by the current officers.

In the event that an officer must resign, an election for his position will occur immediately following his notice of intent to resign. The newly elected officer will serve until the upcoming May.

ARTICLE IV Dues

Section 1

The dues for the club shall be \$30.00 per semester (Fall/Spring). This fee must be paid within 2 weeks following the end of the tryouts. A payment plan may be determined on an individual basis, and this payment plan shall be approved by a majority of the club officers.

ARTICLE V Amending the Constitution

Section 1

Amendments to the constitution can be presented by any member of the club in writing and read at a regular meeting. Any member not present at the time of the reading shall be informed of the proposed amendment. The amendment shall be voted upon at the next regular meeting. A majority of 2/3 of the members present and voting shall be required for acceptance of the proposed amendment.

ARTICLE VI Meetings

Section 1

The club shall meet for practices and competitions and for other reasons deemed necessary by the club officers. The schedule for club meetings shall be determined by the club officers.

ARTICLE I. NAME

Section I. The name of this organization shall be the North Carolina State University Volleyball Club.

ARTICLE II. PURPOSE

Section I. The purpose of this club will be:

- A. To promote good sportsmanship and team play in the game of volleyball by providing members an opportunity for informal and extra-mural competition.
- B. To promote the development of volleyball skills by providing members with instructional training sessions.

ARTICLE III. MEMBERSHIP

- Section I. The membership of this organization shall be limited to full-time or part-time students, graduate students, faculty and staff in good standing with the university.
- Section II. All individuals must comply with the university requirements as well as the Intramural-Recreational Sports Office requirements concerning health insurance, and release and assumption of risk forms.
- Section III. All members must abide by the rules set forth in the by-laws of this constitution.

ARTICLE IV. OFFICERS

- Section I. Officers of the club shall consist of a president, a vice president, a secretary/treasurer, and a faculty advisor (s).
- Section II. The officers of the organization shall be chosen from and by the active members of the club.

ARTICLE V. DUTIES OF OFFICERS

Section I. President

- A. To preside at all club meetings.
- B. To appoint committees for reasons deemed necessary by him.
- C. To represent the club in official functions.
- D. To enforce all provisions of this constitution.
- E. Responsible for reporting to the Club Sports Coordinator in the Intramural-Recreational Sports Office during the first two weeks of school.
- F. Responsible for submitting a club roster to the Intramural-Recreational Sports Office and for keeping it updated.
- G. Responsible for submitting medical, insurance, and release and assumption of risk forms to the Intramural-Recreational Sports Office.
- H. Responsible for submitting a tentative schedule of activities for the year both on and off campus including dates which a state vehicle will be needed.
- Submit a list of all club members who are eligible to drive state vehicles.
- J. Submit an inventory of all equipment which has been purchased for club use by the Intramural-Recreational Sports Office or the Sports Club Authority.
- K. Submit a statement of all club funds on hand, both in checking and savings, at the end of each semester.
- L. Responsible for submitting a request for funds to the Sports Club Authority each semester.

Section II. Vice President

- A. To preside at all club meetings to which the president is unable to attend.
- B. To keep account of all non-monetary possessions and equipment of the club.
- C. To handle all publicity for the club.

Section III. Secretary/Treasurer

- A. To preside at all club meetings to which the president and vice-president cannot attend.
- B. To keep records of all meetings.
- C. To keep all members informed of all club functions.
- D. To keep an accurate roster of active club members.
- E. To handle all necessary financial arrangements.
- F. To keep accurate records of all dues and fees.
- G. To be in charge of all approved purchases.

Section IV. Faculty Advisor

- A. To be first in line of approval for all club activities and expenditures.
- B. To attend a minimum of three business meetings of the club (Preferably the first business meeting of the fall and spring semesters and the last meeting of the spring semester).
- C. To accompany the club on outings whenever possible.
- D. To serve as an information source for providing guidance.
- E. To advise the club in making its yearly budget.

ARTICLE VI. ACTIVITIES

- Section I. Membership recruitment drives.
- Section II. Competition on accordance with the United States
 Volleyball Association (U.S.V.B.A.) rules and regulations.
- Section III. Clinics on individual play, team play, and rules.
- Section IV. Participation in club practice sessions as set forth in the by-laws of this constitution.
- Section V. Fund raising projects in accordance with the university policies to help fund equipment and supply purchases as well as travel.

Section VI. There shall be at least two business meetings per semester, the first to be held within the first three weeks of the beginning of the semester and the last, before the last week of classes of the semester.

ARTICLE VII. ELECTIONS

Section I. The officers shall be elected by a majority vote of at least 1/2 of the total membership.

Section II. The officers shall serve for two semesters with new officers being elected at one of the last business meetings of the semester and taking charge pending election.

Section III. Officers may be removed from office by 2/3 vote of at least 1/2 of the total membership providing all members have been notified of the impeachment proceedings.

Section IV. Officers may succeed themselves as long as the members of the club elect them.

ARTICLE VIII. DUES

Section I. Dues shall be recommended by the officers, determined by a majority vote of at least half the total club membership, and approved by the Club Sports Coordinator.

ARTICLE IX. AMENDMENTS TO THE CONSTITUTION

Section I. The Constitution can be amended by a majority vote of least one half the total membership. Proposed amendments will be in accordance with University policy and approved by the Club Sports Coordinator.

ARTICLE X. BY-LAWS

Section I. Rules will be recommended by the officers and approved by a majority vote of at least one half the total membership, and approved by the Club Sports Coordinator.

Section II. A member may be voted out of the club by a two-thirds vote of at least one half the total membership and the approval of both the faculty advisor and the Club Sports Coordinator.

Section III. This Constitution will be updated each year no later than October 15.

Section IV. Should the Volleyball Club become inactive or disband and a new volleyball club has not been formed within a period of one year, all property of the club shall become the property of the Intramural-Recreational Sports Office.

Section V. All club activities must be in compliance with the guidelines of the Club Sports Program of the Intramural-Recreational Sports Office.
