

Mind's Eye Theater Club

Constitution

Article I Name and Purpose

Section 1

This organization shall be known as the Mind's Eye Theater Club.

Section 2

The purpose of this organization will be to get together for improvisational interactive theater. This activity is of interest to two companies in the triangle that wants to see these kinds of activities grow and prosper.

Article II Membership

Section 1

Membership shall be open to all regularly enrolled students who are interested in participating in Mind's Eye Theater. Non-students are welcome to participate as associate members.

Section 2

Means of selection of members. Anyone who wishes to participate can become a member. Once dues are paid, that person is considered a full member of the organization.

Article III Officers

Section 1

The elective officers of this club shall be: President, who shall organize and guide club activities and day to day business; Seneschal, who shall assist the President and take on that role in the President's absence; Sheriff, who shall act as liaison to any sponsors and student organizations; and the Keeper of Elysium, who shall act as club secretary. Duties of the treasurer shall fall upon the President, who is handling club affairs.

Section 2

The officers shall be elected by the club members to serve a term of one year, beginning January 1st until the end of the calendar year. A simple majority vote shall determine this.

Article IV

Dues

Dues for the club are determined by the costs incurred by club activities. This amount shall be no more than \$10 per year. A majority vote is necessary for an amount to be determined. This vote will take place at the first meeting of the year.

Article V

Amending the Constitution and Bylaws

Amendments to the Constitution or bylaws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority 2/3 of the members present and voting shall be required.

Article VI

Meetings

The club shall meet bi-monthly, on the second and fourth Friday of each month. If there is a schedule conflict with a certain Friday, a make-up date may be decided upon by club officers. Members of the club are also encouraged to participate in non-club events of the same type, as will be advertised during regular meeting hours.

Article VII

Committees

If there is a need for a temporary or standing committee, such an organization shall be formed by the officers and made up of those members that wish to be involved. The number in the committee shall be determined by the needs requiring such a committee.

Article VIII

Additional Rules and Addendum

Section 1

The Mind's Eye Theater Club strictly adheres to University drug and alcohol policies, and any member found violating these policies would be summarily dismissed by the Sheriff.

Section 2

The Mind's Eye Theater Club is affiliated with two external organizations here in Raleigh. The first is Black Rose Productions, a company specializing in interactive entertainment and improvisational theater. The second is Eighth Wonder Games, a computer company dealing with online interactive entertainment. These are the addresses of the respective companies and the club contact people.
