### NORTH CAROLINA STATE UNIVERSITY NATIONAL STUDENT EXCHANGE PROGRAM

#### Constitution

### Article I. Purpose Section 1

The purpose of the NSE program is to facilitate an opportunity in which students may go to another educational institution and observe and participate in another environment setting. This program will also provide for new cultural experiences, greater independence and strengthening of ones self-concept.

#### Article II. Membership and Selection

Section 1 Membership is open to all students whose GPA is 2.5, and have interest in exploring a different geographical location in the United States.

Section 2 Selections - Each host institution has applications and procedures for evaluation that meet the NSE requirements. Students wishing to exchange to another institution must have a minimum 2.5 GPA, and must be enrolled in their home institution as a matriculated student for two consecutive semesters.

#### Article III. Officers Section 1

- A. President act as university spokesperson, promote programming ideas and concepts, preside and call all meetings, and plan itineraries
- B. Treasurer collection and distribution of funds. Draw up funding requests.
- C. Vice-President & Social Chairperson assists the President and plans and implements social gatherings
- E. Secretary present at all meetings, records all policies and orders of business

# Section 2 Officers will be elected at the beginning of each semester, and must be here two consecutive semesters. The President and Social Chairperson may currently be on exchange at NCSU. At least one officer should be a current student enrolled at NCSU not on exchange.

## Article IV. Dues Section 1

Activity fees may be assessed as needed, by majority vote of the membership. Membership fees will not be assessed.

Article V. Amendments

Section 1

Any article of this constitution or part thereof that is in direct violation of the Student Government constitution or by-laws shall be null and void and declared unconstitutional by the President of Student Government. Any differences of opinion between the club and the President of Student Government shall be brought before the Legislature, whose decision shall be final.

Article VI. Meetings Section 1

Meetings shall be held once a month.

Article VII. Committees Section 1

Special committees - publicity committee to inform people of the NSE program
