BYLAWS
OF
THE NORTH CAROLINA STATE UNIVERSITY CHAPTER OF
THE HONOR SOCIETY OF PHI KAPPA PHI

PREAMBLE

The North Carolina State University Chapter of The Honor Society of Phi Kappa Phi is a unit of The National Honor Society of Phi Kappa Phi and shall operate within the framework of the Constitution of The National Society. The Bylaws under which the local Chapter shall be operated are contained in this Document. These Bylaws, when approved by the local Chapter and by The National Society, shall supersede and nullify all previous Constitutions and Bylaws, with amendments, of this Chapter.

ARTICLE I

Name and Organization

Section 1. Name.

The name of this Society shall be the North Carolina State University Chapter of The Honor Society of Phi Kappa Phi.

Section 2. The North Carolina State University Chapter is a unit of The National Honor Society of Phi Kappa Phi and membership in the local Chapter shall constitute membership in The National Society. Members of other chapters of The National Society residing in the Raleigh area may affiliate with the North Carolina State University Chapter.

ARTICLE II

Objective and Purpose

Section 1. Objective.

The object of the Chapter is to promote the pursuit of excellence in all fields of higher education.

Section 2. Purpose.

The purpose of the Chapter shall be to recognize and honor those who have attained academic excellence. Such recognition and honor may be through election to membership and/or the presentation of special certificates or awards.

ARTICLE III

Membership

Section 1. Eligibility for Membership.

The following may be eligible for membership provided they have demonstrated a sense of responsibility, are of sound character, and meet the qualifications as set forth in Section 2 of this Article: Second semester Juniors, Seniors, Graduate Students, Faculty, Alumni, and those eligible for Honorary Membership.

Section 2. Qualifications for Membership.

A. Undergraduates.

The total number of undergraduate students (Juniors and Seniors) elected in any year shall not exceed 10% of those who will be candidates for graduation in that year. These may be selected from second semester Juniors and from Seniors.

(1) Juniors.

To qualify for election to membership Juniors must:

- a. Have been registered at North Carolina State University for at least two semesters (or equivalent) in a program of at least four years;
- b. Have earned by the beginning of the second semester of the junior year a minimum of 75 credit-hours, of which at least 30 shall have been earned at North Carolina State University;
- c. Rank in scholarship within the highest 3% of their class;
- d. Have a cumulative grade-point average of at least 3.5 on all work completed at North Carolina State University.

(2) Non-transfer Seniors.

To qualify for election Non-transfer Seniors must:

- a. Have completed a minimum of 100 credit-hours at North Carolina State University;
- b. Rank in scholarship within the highest 6% of their class;
- c. Have a cumulative grade-point average of at least 3.25 on all work completed at North Carolina State University.

(3) Transfer Seniors.

To qualify for election to membership Transfer Seniors must:

- a. Have been registered at North Carolina State University for three semesters (or equivalent) or more in a

program of at least four years;

- b. Have completed a minimum of 100 credit-hours of which at least 45 shall have been completed at North Carolina State University;
- c. Rank in scholarship within the highest 6% of their class;
- d. Have a cumulative grade-point average on all graded work completed at North Carolina State University that conforms to the following scale:

<u>Number of credit-hours completed at North Carolina State University prior to nomination:</u>	<u>Grade-point average on North Carolina State University work completed must be at least:</u>
75 or more	3.25
60 to 74	3.30
45 to 59	3.50

B. Graduate Students.

The number of graduate students nominated during any calendar year shall not exceed 10% of the number of advanced degrees awarded in the previous 12 months. The 10% limit may be extended to permit nomination of all students whose grade-point averages are equal when computed to three significant figures.

(1) Graduate Students in Residence.

To qualify for election to membership a Graduate Student in residence must:

- a. Be actively pursuing an advanced degree at North Carolina State University (rather than being registered as a Graduate student unclassified);
 - b. Have completed at least 18 hours of letter-grade graduate credit at North Carolina State University;
 - c. Have an accumulative grade-point average of 3.8 or above.
- (2) Graduate students who have been awarded an advanced degree by North Carolina State University subsequent to the last election of members to the Chapter, may be elected provided they meet the qualifications set forth immediately above under "b" and "c".

C. Faculty.

- (1) To qualify for election to membership a Faculty member must satisfy all of the following four requirements:
- a. Be a full-time member of the administrative, teaching, research, or extension staff of North Carolina State University;
 - b. Have held such position in residence for two or more years prior to his nomination;
 - c. Be an alumnus of North Carolina State University or a graduate of at least a four year course in a collegiate institution of recognized standing;

- d. Have had a scholastic record as an undergraduate that would have rendered him eligible for membership, or have attained a position of distinction in his field of work.
- (2) In addition to the qualifications specified immediately above, due weight shall be given to the following considerations:
 - a. Accomplishments of the candidate or nominee since graduation;
 - b. Length of service with the University;
 - c. Interest in scholarship and in the purpose of the Society;
 - d. An equitable distribution of members among the various divisions of the University.
 - (3) A member of the faculty who does not hold an academic degree may be elected to membership only with the prior consent of the National Society Executive Council.
(National Constitution, Article II, Section 2-d.)
 - (4) Not more than 1% of the roster of the voting faculty, including those who are already members of Phi Kappa Phi, may be elected in any one year.
- D. Alumni.
- (1) To qualify for election to membership an Alumnus must:
 - a. Have been graduated for five or more years;
 - b. Have been of high scholastic standing as a student;
 - c. Have made outstanding achievements since graduation,

with achievements becoming relatively more important the longer the term since graduation.

(National Constitution, Article II, Section 3-c.)

- (2) Alumni who are members of the faculty shall be considered for faculty membership and are not eligible for alumni membership.
- (3) The number of alumni elected in any one year may not exceed 5% of the number of students, both undergraduate and graduate, elected in that year.

E. Honorary Members.

- (1) The North Carolina State University Chapter may elect one person to honorary membership each year. (National Constitution, Article II, Section 2-g.)
- (2) To qualify for election as an Honorary Member the individual must:
 - a. Have no official connection with North Carolina State University; and
 - b. Have been graduated ten or more years from an institution of recognized collegiate rank; and
 - c. Have attained eminence in some field of creative endeavor.
- (3) The consent of the National Society Executive Council must be obtained before such a person may be elected.
- (4) The North Carolina State University Chapter may not

elect to honorary membership a graduate of an institution in which a chapter of Phi Kappa Phi exists without first obtaining consent of that chapter.

Section 3. Nomination and Election of Members.

A. Nomination for membership shall be by a selection committee. Each of the several selection committees shall prepare a list of nominees and present it at the annual election business meeting. The responsibilities of the selection committees are set forth in Article IV, Section 3, below. It shall be the responsibility of each selection committee to determine that each nominee meets the qualifications for membership as set forth in Article III, Section 2, above.

B. Election of Members.

- (1) There shall be a business meeting early in the second (spring) semester.
- (2) At that meeting each selection committee shall present a list of nominees and certify that, insofar as it was possible to ascertain, each nominee meets the qualifications for membership as set forth in Article III, Section 2, above.
- (3) All elections to membership shall be by ballot, cast either in an election meeting or by mail as determined by the Executive Committee.
 - a. At an election meeting, to be elected a nominee must

receive the affirmative votes of at least three-fourths of the active faculty and student members present and voting.

- b. In an election conducted by mail, to be elected a nominee must receive the affirmative votes of at least three-fourths of the active faculty and student members of the chapter.

C. Initiation.

- (1) Initiation of the newly elected members shall be in the spring semester at a time and place designated by the President, with the approval of the Executive Committee.
- (2) The initiation shall be performed as prescribed by the ritual of The National Society.
- (3) Members-elect shall attend and participate in the initiation ceremony and shall not be considered as members of the chapter unless (a) they participate in the initiation ceremony or (b) they are excused under the conditions specified in Paragraph (4) immediately following.
- (4) A member-elect, upon approval of his written request to the Secretary, may be excused from participating in the initiation if it is determined by the Executive Committee that compelling circumstances would make it impractical for the member-elect to be present. If the candidate is

excused, the President and the Secretary may certify him as a member in good standing and authorize the award of symbols of membership.

Section 4. Classification of Members.

There shall be four classes of members as follows:

A. Active Members.

Active members are those who have paid current annual dues.

(Life members are considered as active members.) Phi

Kappa Phi members elected by other chapters who reside in

the Raleigh area may become active members of the North

Carolina State University Chapter by payment of annual dues.

B. Inactive Members.

Inactive members are those members of Phi Kappa Phi who

failed to pay annual dues during the past academic year and

prior to the beginning of the fall semester. Inactive members

may not vote, hold office, serve on committees, make

nominations for membership or for any of the several awards,

or in any other way participate in the business affairs of the

Chapter. They may become active upon payment of the annual

dues.

C. Active Members for Life.

(1) Any member of the Chapter may be accorded the status of

Active Member for Life on payment of a life membership

fee as specified by the National Society.

(2) With the approval of the Chapter an active member may upon retirement from professional duties and upon payment of the fee specified by the National Society, be designated as an Active Member for Life and have all further payment of National Society and Chapter dues waived.

(3) Active Members for Life shall have all the privileges of other active members.

D. Honorary Members.

Honorary Members are persons who have been accorded this status by the Chapter with the approval of the National Executive Council.

ARTICLE IV

Government, Officers, Committees, and Meetings

Section 1. Government.

The government of the Chapter shall be vested in (A) the active members of the Chapter and (B) the Executive Committee.

A. All major items of business shall be conducted by the active members in duly convened meetings. These matters of business shall include, but not be limited to, the election of officers and of new members.

B. The Executive Committee shall act for the Chapter on such matters as arranging for time and place of meetings and shall

perform such other duties as may be delegated to it.

(See Article IV, Section 3-A, below.)

Section 2. Officers: Duties, Election, and Filling of Vacancies.

A. Officers.

The officers of the Chapter shall be a President, a President-Elect, a Vice-President, a Secretary-Treasurer, and a Public Relations Officer.

B. Duties of Officers.

(1) The President shall:

- a. Preside at meetings of the Chapter and at meetings of the Executive Committee, and in general supervise the affairs of the Chapter;
- b. With the assistance of the Executive Committee, appoint all committees except the Executive Committee;
- c. Notify newly elected faculty and alumni members of their election;
- d. Notify those chosen to receive awards of their selection;
- e. Inform all candidates for election to office of the election results.

(2) The President-Elect shall:

- a. At the request of or in the absence of the President

- represent the President in the performance of duties that pertain to the office of President;
- b. Serve as Chairman of the Committee on Organization and Coordination;
 - c. Be custodian of the Bylaws and of the Rules of Procedure;
 - d. Succeed to the presidency at the end of his term as President-Elect, or earlier if the office of President should become vacant.
- (3) The Vice-President shall:
- a. Serve as Chairman of the Advisory Committee of student chapter members;
 - b. Lead the Advisory Committee in the study of problems common to the students, the Chapter, and the University in the quest for more effective means of advancing the aims of the Society;
 - c. Communicate to the President and to the Chairmen of appropriate committees the views of the student members of the Chapter.
- (4) The Secretary-Treasurer shall:
- a. Keep the records of the Chapter including minutes of the meetings of the Chapter and of the Executive Committee;

- b. Notify active members of Chapter meetings;
- c. Notify newly elected Undergraduate and Graduate members of their election;
- d. Collect and assemble new member personnel forms and transmit the necessary information concerning new members to the Executive Director of The National Society.
- e. Order certificates and jewelry for newly elected members and certificates for those selected to receive special awards, and a certificate for the Vice-President;
- f. Receive the initiation fees of new members;
- g. Transmit to the Executive Director of The National Society on or about January 1 of each year a list of all active members together with their annual national dues;
- h. Submit an annual report of Chapter activities during the year to the Executive Director of The National Society;
- i. Keep the financial records of the Chapter;
- j. Receive all funds and pay all expenses incurred by the Chapter;
- k. Make investments or otherwise manage the money as

authorized by the Executive Committee;

1. Perform such other duties as may be appropriate to the office or as may be delegated to him.

(5) The Public Relations Officer shall:

- a. Serve as Chairman of the Committee on Speakers and Publicity;
- b. Report to the Editor of the Phi Kappa Phi Journal on activities of the Chapter and items of interest about Chapter members;
- c. Be responsible for local publicity on such matters as: election of officers, new members, special awards, and other matters as appropriate.
- d. Perform such other duties as may be appropriate or as may be delegated to the office.

C. Nomination and Election of Officers.

(1) Nominations.

The Committee on Nomination of Chapter officers shall prepare a slate of nominees and present it at a regular or special business meeting of the Chapter. Additional nominations may be made from the floor.

(2) Qualifications of Nominees for Office.

- a. Nominees for elective offices of the Chapter shall meet the following requirements:

- i. Each nominee shall have maintained active membership in the Chapter for at least 1 1/2 years prior to the submission of his nomination.
- ii. Each nominee for office of President-Elect and each nominee for office of Secretary-Treasurer shall have held an office or a committee membership, or both, during his active membership in the Chapter.
- iii. Each nominee for an elective office shall give his consent to the nomination.
- iv. Each nomination shall be accompanied by a record of the nominee's activities as a member of the Chapter and of the University Faculty.
- v. All nominations made from the floor must meet the qualifications outlined immediately above.
- v. The office of Vice-President shall be filled by that most recently elected Junior who has the highest accumulative grade-point average and who is otherwise qualified.

(3) Term of Office.

Officers shall assume their duties upon installation at the annual banquet, and shall serve for terms as designated in Paragraphs "a" through "g", following.

- a. The office of President is filled by succession of the President-Elect for a period of one year.
- b. The President-Elect shall serve for a term of one year and then shall succeed to the Presidency.
- c. The Vice-President shall serve for a term of one year.
- d. The Secretary-Treasurer shall serve for a term of two years beginning in even-numbered years.
- e. The Public Relations Officer shall serve for a term of two years beginning in ^{odd} even-numbered years. (*Approved*
10-19-75)
- f. If, at the expiration of his normal term, an officer's successor shall not have been duly elected and qualified, such officer shall continue to serve until his successor is elected and qualified.

(4) Voting.

- a. Voting for all officers, except the Vice-President, shall be by mail ballot. The slate of nominees as established at a duly constituted business meeting shall be mailed by the Secretary-Treasurer to all active members of the Chapter. The ballot shall be returned by a specified date to the Chairman of the Committee on Nomination of Chapter Officers. The Committee shall count the ballots and report the results to the Chapter President.

- b. If the succession occurs after the first major business meeting in the spring semester and after the election of new officers the President-Elect shall succeed to the Presidency and shall serve as President for the remainder of the year and during the next academic year.
 - (2) If the office of President-Elect becomes vacant it shall be filled as follows:
 - a. If the vacancy occurs prior to the first major business meeting in the spring semester a special election shall be held to fill the office. The person elected shall perform the duties of President-Elect for the remainder of the academic year and shall succeed to the Presidency for the following year.
 - b. If the vacancy occurs late in the second semester after new officers have been elected for the following year the office shall remain vacant until the new officers are installed.
 - (3) If the office of Vice-President becomes vacant it shall be filled by that member of the most recently elected Juniors with the highest accumulative grade-point average and who otherwise is qualified.
 - (4) If the office of Secretary-Treasurer, Public Relations

Officer, or member of the Executive Committee, becomes vacant the remaining members of the Executive Committee shall be empowered to fill the vacancy for the duration of the term.

Section 3. Committees.

A. Executive Committee.

- (1) The Executive Committee shall consist of the President, the President-Elect, the Vice-President, the Secretary-Treasurer, the Public Relations Officer, and the immediate past President.
- (2) A quorum of the Executive Committee shall consist of a majority of its members.
- (3) The President shall be Chairman and all members shall be eligible to vote.
- (4) The Executive Committee shall have authority to:
 - a. Act on routine business items and other matters that may be referred to it;
 - b. Fill vacancies on the Executive Committee as specified under Article IV, Section 2-D, above;
 - c. Recommend changes in fees and dues;
 - d. Authorize special meetings and special elections; and
 - e. Make recommendations for any changes deemed valuable to the good of the Chapter.

B. Committee on Organization and Coordination.

- (1) This committee shall consist of the President-Elect as Chairman, the Secretary-Treasurer, the Vice-President, and two faculty and two student members to be appointed.
- (2) It shall be the responsibility of this committee to:
 - a. Review and make recommendations for changes in the Chapter Bylaws;
 - b. Determine that the Chapter Bylaws are in accord with the National Constitution and Bylaws;
 - c. Assist in all ways possible in coordinating the work of the various Chapter committees and in coordinating the affairs of the Chapter with The National Society.

C. Committee on Selection of Undergraduate Student Nominees.

- (1) This committee shall consist of equal numbers of faculty and student members, with at least three of each.
- (2) It shall be the responsibility of this committee to:
 - a. Prepare a list of student nominees who meet the qualifications for membership described in Article III, Section 2, above.
 - b. Present the list of nominees at a designated business meeting of the Chapter and in a form suitable for use as a ballot.

D. Committee on Selection of Graduate Student Nominees.

(1) This committee shall consist of at least three faculty members.

(2) It shall be the responsibility of this committee to:

- a. Prepare a list of Graduate Student Nominees who meet the qualifications for membership as set forth in Article III, Section 2-B, above;
- b. Check the list of nominees with the Chapter Secretary-Treasurer and/or with the department heads to determine whether the nominee is already a member of this or another chapter of Phi Kappa Phi;
- c. Present the list of nominees at the designated business meeting in a form to be used as a ballot.

E. Committee on Selection of Faculty Nominees.

(1) This committee shall consist of at least three faculty members.

(2) It shall be the responsibility of this committee to:

- a. Prepare a list of faculty nominees who meet the qualifications for membership as set forth in Article III, Section 2-C;
- b. Determine that each nominee is not already a member of Phi Kappa Phi;
- c. Present the list at a designated business meeting in a form to be used as a ballot.

F. Committee on Selection of Alumni and Honorary Nominees.

- (1) This committee shall consist of at least three faculty members.
- (2) It shall be the responsibility of this committee to:
 - a. Prepare a slate of nominees who meet the qualifications for membership as set forth in Article III, Section 2-D and 2-E;
 - b. Determine that each nominee is not already a member of Phi Kappa Phi;
 - c. Present the list of nominees at the designated business meeting as a form suitable for use as a ballot.

G. Committee on Selection of Candidate for National Society Fellowships.

- (1) This committee shall consist of at least three faculty members.
- (2) It shall be the responsibility of this committee to:
 - a. Make one nomination for the National Fellowships as set forth under Article VII, Section 9. The committee may solicit nominations from active faculty members or they may make nominations on their own initiative;
 - b. Present the name and qualifications of the nominee to the Executive Committee for approval.
- (3) After approval of one nomination by the Executive Committee,

the Secretary-Treasurer shall transmit it to the National Committee on Society Fellowships.

H. Committee on Student Honors and Awards.

- (1) This committee shall consist of equal members of faculty and students, at least three of each.
- (2) It shall be the responsibility of this committee to:
 - a. Select nominees for the awards as provided for in Article VII, Sections 3, 4, 5, 6, and 7;
 - b. To present the list of nominees, together with a summary of their qualifications, at a designated business meeting of the Chapter.

I. Committee on Nomination of Chapter Officers.

- (1) This committee shall consist of the three most recent Chapter Presidents and three student members. The most recent past President shall serve as chairman.
- (2) It shall be the responsibility of this committee to prepare a slate of nominees for each of the following offices:
President-Elect; Secretary-Treasurer, in even-numbered years; Public Relations Officer, in even-numbered years.
(The office of President and of Vice-President are filled as specified in Article IV, Section 2-C.)
- (3) Present the slate of nominees at a specified business meeting of the Chapter.

J. Committee on Annual Banquet and Initiation.

- (1) This committee shall consist of as many faculty and student members as deemed necessary by the President, with the approval of the Executive Committee.
- (2) It shall be the responsibility of this committee to:
 - a. Make all the necessary arrangements for the annual initiation and banquet including selection of the place, seating order at the initiation and at the banquet, selection of the menu for the banquet, arranging for decorations; and, perform such other duties as may be necessary in organizing and conducting the initiation and banquet.

K. Committee on Speakers and Publicity.

- (1) This committee shall consist of at least three faculty and at least three student members, with the Public Relations Officer as Chairman.
- (2) It shall be the responsibility of this committee to arrange for a speaker at the annual banquet and for such other occasions as may arise, and to assist the Public Relations Officer in the performance of his duties.

L. Auditing Committee.

- (1) This committee shall consist of two faculty members.
- (2) It shall be the responsibility of this committee to audit

the accounts of the Secretary-Treasurer annually and especially at the time of transfer of the Secretary-Treasurer's records to the succeeding Secretary-Treasurer.

- (3) This committee shall report to the Chapter at a designated business meeting.

M. Advisory Committee of Chapter Student Members.

- (1) This committee shall consist of the Vice-President as Chairman, and seven or more other student members.
- (2) It shall be the responsibility of this committee to:
 - a. Encourage scholarly achievement among students in the University;
 - b. Study problems common to students, the Chapter, and the University;
 - c. Be alert to more effective means of advancing the aims of the Society;
 - d. Present to the Chapter ideas and recommendations pertaining to Paragraphs "a" through "c", above.

N. Liaison Committee.

- (1) This committee shall consist of the past President as chairman, the President-Elect as Secretary, and the chairmen of the following committees: Committee on Selection of Undergraduate Student Nominees; Committee

on Selection of Graduate Student Nominees; Committee on Selection of Faculty Nominees; Committee on Selection of Alumni and Honorary Nominees; Committee on Student Honors and Awards; and, Committee on Selection of Candidate for National Society Fellowships.

- (2) The purpose of this committee is to provide communication among the various committees constituting the framework of the Chapter.

O. Other Committees.

The President, with the concurrence of the Executive Committee, may appoint such other committees as he may deem necessary to expedite the business of the Chapter.

Section 4. Meetings.

A. There shall be a business meeting early in the spring semester for the purpose of:

- (1) Receiving selection committee reports and electing new members;
- (2) Receiving the report of the Committee on Nomination of Chapter Officers;
- (3) Transacting other necessary business.

B. There shall be an initiation banquet meeting later in the spring semester for the purpose of:

- (1) Initiating new members;

- (2) Announcing the recipients of awards and presenting the awards;
 - (3) Enjoying the fellowship of fellow members at the banquet.
- C. Other meetings shall be held during the year as deemed necessary:
- (1) By the President with the approval of the Executive Committee;
 - (2) When one-third of the active members of the Chapter petition for such meeting.
- D. A quorum for transaction of business at any duly called meeting shall consist of at least 15 active resident members.
- E. A three-fourths majority vote of the members present shall be necessary for electing new members.
- F. Notices of all meetings of the Chapter shall be mailed to active student and faculty members. It shall be the responsibility of individual members to inform the Secretary-Treasurer of any change of address.
- G. **Parliamentary Rules.**
- All business meetings of the Chapter shall be conducted in accordance with Robert's Rules of Order.
- H. **General Convention.**
- (1) The general convention of the Society meets biennially.
- The Chapter is entitled to one delegate to be chosen from

its active members in residence. The appointment of the delegate shall be certified by the Chapter Secretary-Treasurer to the National Executive Director at least ten days prior to the opening of the convention.

- (2) The Chapter shall, on demand of the National Executive Director, pay a reasonable assessment as its share of the convention fund to be applied toward expenses of the delegate at the convention.

ARTICLE V

Finances

Section 1. Initiation Fees.

- A. The Chapter shall collect from each new member an initiation fee to pay for:
 - (1) Lifetime membership in The National Society;
 - (2) Annual dues in the local Chapter for the year following initiation;
 - (3) A membership certificate;
 - (4) A Society insignia (standard key or pin; various other insignia are available at extra cost);
 - (5) One ticket to the annual initiation banquet.
- B. The initiation fee shall be established each year by the Executive Committee. It may change from year to year depending upon economic conditions.

Section 2. Annual Dues.

- A. Annual dues for the year beginning September 1 shall be set by the Executive Committee upon recommendation by the President.
- B. Any member of the Chapter may become a Life Member by payment of a life membership fee as specified by The National Society.
- C. Chapter members who have retired from active professional duties may, upon payment of a fee as specified by The National Society, be designated as active members for life without further payment of Chapter or National dues.
- D. The membership fee for an honorary nominee shall be paid by the North Carolina State University Chapter.
- E. Honorary and Life Members in residence shall be exempt from payment of local Chapter dues.

ARTICLE VI

Official Insignia

Section 1. The initiation fee includes the standard official insignia (key or pin) of the Society. The form of the insignia must be selected by the new member, in consultation with the Chapter Secretary-Treasurer, and recorded on the personnel form to be filled out by all new members. In addition to the standard insignia, others are available at extra cost.

ARTICLE VII

Honors and Awards

Section 1. Membership Certificate.

Each newly initiated member shall receive at his initiation a membership certificate appropriately inscribed, embossed with the official seal of the Chapter, and signed by the President.

Section 2. Freshmen Recognition.

A certificate or letter from the Chapter President shall be presented to all Sophomores who during the two semesters of their Freshman year earned honors or high honors in scholarship.

Section 3. Sophomore Certificate.

Each year a certificate is given to the Sophomore who had the highest cumulative grade-point average in his class at the end of the fall semester. To be eligible for this certificate, the student shall have been enrolled for both semesters of the Freshman year and the fall semester of the Sophomore year at North Carolina State University.

Section 4. Junior Certificate.

Each year the Chapter presents a certificate to the Junior who had the highest cumulative grade-point average in his class at the end of the fall semester. To be eligible for this award a transfer student shall have earned at least half of his total credits at North Carolina State University and shall have been a full time student at

North Carolina State University for a minimum of three consecutive semesters or the equivalent.

Section 5. Senior Certificate.

Each year the Chapter presents a certificate to the Senior who had the highest cumulative grade-point average in his class at the end of the fall semester. To be eligible for this certificate a transfer student shall have earned at least half of his total credits at North Carolina State University and shall have been a full time student at North Carolina State University for a minimum of four consecutive semesters or the equivalent.

Section 6. Master's Certificate.

The Chapter shall present each year one or more certificates to Master's degree candidates in recognition of superior intellectual achievement. To be eligible a candidate shall have been in residence for at least three consecutive semesters and shall be in the process of completing the requirements for his Master's degree within the

current academic year. *To be eligible for selection, a candidate either must be a member of Phi Kappa Phi or have a current invitation to membership.*

Section 7. Doctor's Certificate.

The Chapter shall award each year one or more certificates to doctoral degree candidates in recognition of superior intellectual attainment and achievement in research. To be eligible a candidate shall have been in residence for at least three consecutive semesters

Section 8.

Vice-President's Certificate, *to be eligible for election, a candidate either must be a member of Phi Kappa Phi or have a current invitation to membership*

Each year the Chapter presents a certificate to the student who

has served as Vice-President of the Chapter.

Section 9. National Society Fellowship Award.

The Chapter may select each year an applicant for a National

Society Fellowship Award, following the procedures and

regulations prescribed by the Committee on Fellowships of

The National Society.

Section 10. Other Awards.

Other awards may be presented from time to time by the Executive

Committee with approval of the Chapter. These may be awards

in recognition of outstanding service, or certificates to past

officers of the Society, or such other recognition as may be

deemed appropriate.

ARTICLE VIII

Amendments

Section 1. These Bylaws may be amended by a three-fourths majority vote of

the members present at a duly called meeting at which a quorum

is present, provided that the proposed amendments have been

submitted to the active membership in writing at least ten days

prior to the time of the meeting.

Section 2. The Bylaws of the North Carolina State University Chapter shall be in harmony with the Constitution and Bylaws of The National Society and when changed a certified revised copy shall be filed with the Executive Director of The National Society.

Dr. Mahmoud A. Ayoub, Professor Industrial Engineering

RICH RED CLAY, BATON AND SILENCE:

NCSU's Second 100 Years

A bronzed laurel oak leaf fluttered down out of the bright blue February sky and was engulfed by the winter-swollen, red water Neuse River. The silence of vast broad expanses of the Carolina coastal plain's bottomland hardwoods was broken occasionally by the thumping of oars in flat bottom boats, the chugging of an outboard motor, the cries of the small group of students, and the voice of the professor. Above the group with the white, sharp-lighted winter sun at their backs, a pair of red-tailed hawks kept silent, wary eyes on the intruders.

A stand of river birch, cypress and tupelo in a remote slough of a red water river is the result of a century of growth, of many centuries of life. Investigating the secrets of these bottomland hardwoods, the professor afforded his proteges a view of nature of which few are privy. He dipped a net into the slurry of organic matter that had accumulated, as if magnetized, around a limb that was in the river's slack water. Seeds of water tupelo, overcup oak, cottonwood. Embryos of next century's forest, the beginning of many centuries of life. Rich fertile red clays silently laid down. Downstream, the future rolled up into the vision of the students. Blood red maples, among Carolina's

first flowers of the year, were soothsayers of seasons to come. Further ahead, beyond the silent expanses of the coastal plain, past the sounds and banks, was the roaring of eternity, the ocean wellspring.

Only in the mind of humankind is there a past, present, and future. The bronzed leaf left no monument to mark its brief existence in time. The hawks did not gouge cuneiform into the bright blue ethereal air. The very river into which the leaf was swallowed played no Requiem mass. Only the descendants of humankind are naming nature, defining its vastness, specifying its forms, writing poetry about its stark beauty.

At once a curse, and yet also a treasure, the mind of humankind is that fathoming measure which studies the past, observes the present, and looks into the future, separating the silence from the roaring. It is this ability to discern harmony and discord that is called education. Education tunes the multifarious instruments in this mysterious symphony of life. The moment is the music.

But the song of humankind (in spite of the sound of many of its sonatas) is no perpetual improvisation left entirely to happenstance. If such were true, its music would be unbearable, and there would be little to differentiate humankind from any number of primates. There are rhythms underlying humankind's song -- red river waters that swell and recede, planting rich fertile organic mats of life-to-be in the silence, dragging off senescent debris to the roaring, and laying down, beneath it all, rich red clays much like the bricks beneath the seasonal floods of footfalls of the students here at NCSU.

* * * *

An education is a series of silences and roarings, of growing seeds of thought from sediments of study into ideas that form in the future. It is doubtful that, in the century of human time which has passed since NCSU first opened its doors for the education of North Carolina's citizenry, this basic precept has changed. And it is doubtful that, as another century passes, principles which guide the growth of ideas will much change.

There are still towering oldgrowth professors that insist that periods be properly placed, that proper Latin be properly used, that attendance is indeed required, and that a grade is a hard fastball, not a sliding curve. They cast the credibility of an education at NCSU.

These professors, these relics of the past, are primeval. Men and women like them were present at the dawn of human time, when the Earth was roamed by tribal assemblages of humankind. Stout, stern, gnarled, shouting, storm-tested, oak-hearted maestros of education. A hundred years has not changed that, nor will a hundred years hence.

This song of humankind has been passed forward across earth-encompassing glacial ice. It has whispered up out from dark ages. Through revolutions and tranquility, despair and jubilation, this melody has been passed until it is now sounding notes beyond the confines of bright blue ethereal air. And so long as there are inquiring minds beneath the cowlicks and bobby pins of young North Carolinians, so long as there are discerning ears and stout strong hearts, red river waters will still swell and recede bringing new seed from the old. Humankind's song will play yet unheard melodies upon the staff. A hundred years forward will not change that.

* * * *

In the red brick tower of D. H. Hill Library, one may walk by volumes of periodicals, texts, and congressional records from a century ago and hear the silence. Reach up and pull a book from a shelf. Hear it ripple its friction against its neighboring volumes and finally pop free of the confines of the shelf. There is a rhythm here, and music.

Start at the bottom floor of the tower and walk up to the top to survey the horizons, to imagine a hundred years hence. Imagine each stairstep to be a millstone and questions to be kernels of raw grain. There are answers here, and from here can be taken the meal, the flour, the manna whose roots are nourished in silence. These answers gotten from education are priceless. Some of them are saving graces. Some of them are just plain fun.

A century has gone into acquiring this tower's treasury of education. It is full of rich dusty volumes with their Latin footnotes, or of glossy colored photographs in the most recent periodicals with their Latin footnotes. And there is shelf space still.

From the silent sanctuary of the library's stacks, one can easily hear the rapping, rumbling, roaring birth of yet another tower to be filled with yet another century of music. It is the beginning of the second century, NCSU time. From the foundations being hammered into rich red clay to the bright blue ethereal air into which the tower will stretch, the seeds of thought are beginning to form into the future.

Still, new challenges lurk in uncharted red waters, and new Theban sphinxes still demand taming. New treasures will still be acquired. The campus groundskeeper will still be hard pressed to keep up with students' shortcuts. Young discerning ears will still turn red as the maestro's baton wood hammers a clanging correction upon the podium. And

NCSU will build up and nurture, as it always has, brick by rich red brick, the young minds that will play the song of humankind, in key, in tune, in time, silently roaring: there stands, ever cherished, N.C. State, firmly, strong and true.

A century passes. Rich red clays are laid down. In a remote slough of a winter swollen red water river in the silence of vast, broad expanses of Carolina's coastal plain hardwoods, the professor asks a challenging question as his hand points up toward a cottonwood. The maestro lifts the baton. The music is waiting.

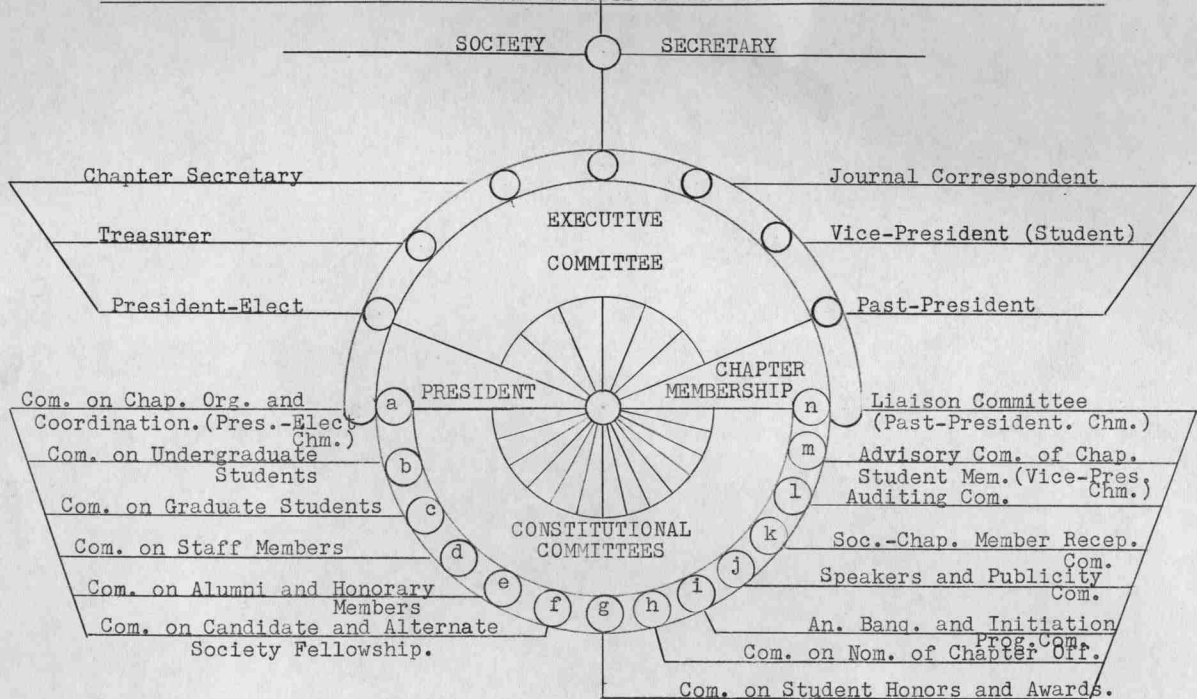


DIAGRAM OF CHAPTER ORGANIZATION

HONOR SOCIETY OF PHI KAPPA PHI

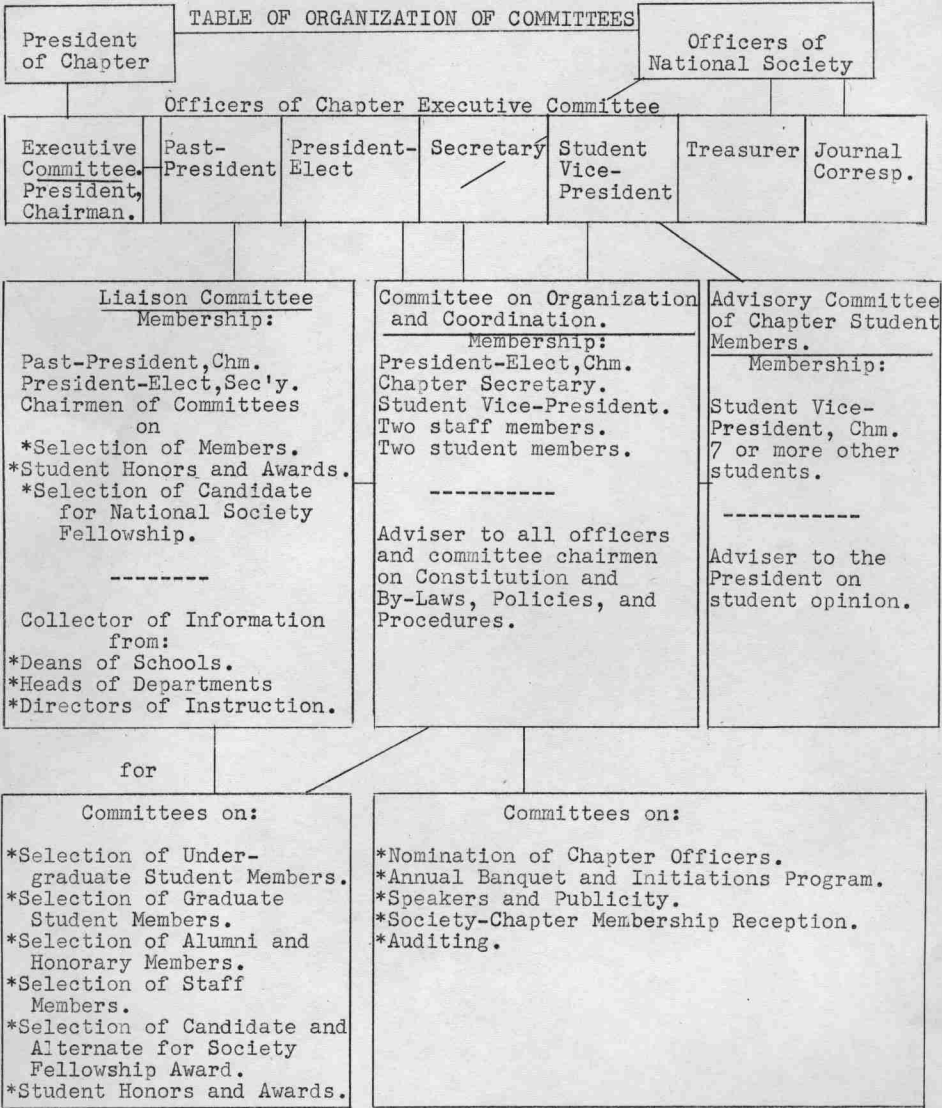


DIAGRAM OF COMMITTEE ORGANIZATION

THE NORTH CAROLINA STATE COLLEGE
CHAPTER OF THE HONOR SOCIETY OF
PHI KAPPA PHI CONSTITUTION (Revised 1954)

ARTICLE I

Name and Purposes

Section 1. The name of this organization shall be the North Carolina State College Chapter of the Honor Society of Phi Kappa Phi.

Section 2. The principal purposes of this Society and Chapter are to encourage sound scholarship, to recognize and honor good character, and to stress the obligation which the scholar owes to society. (See the Constitution of the National Society, Article I.)

ARTICLE II

Officers: Qualifications, Election and Installation, Duties (The Constitution of the National Society as cited throughout this Chapter Constitution was published in the Phi Kappa Phi Journal for March 1952.)

Section 1. The officers of this Chapter shall be a President, a President-Elect, a Secretary, a Treasurer, a Journal Correspondent, and a Student Honorary Vice-President. The Honorary Vice-Presidency is the only office that may be held by a student member. (National Article II, Section 5.)

Section 2. In the selection of nominees for elective offices of the Chapter, the following requirements shall be fulfilled:

(a) A nominee shall have maintained an active membership in the Chapter for at least one and one half years prior to the submission of his nomination.

(b) Each nominee for the office of President-Elect and each nominee for the office of Secretary shall also have held an office or a committee membership or both during his active membership in the Chapter.

(c) A nominee for any elective office shall have given his consent to the nomination.

(d) For each nominee, a record of activities as a member of the Chapter and of the College staff shall be compiled and presented with the nomination.

(e) The President or presiding officer shall present the opportunity to the members to make nominations. The names of any such nominees shall be placed on the ballot, provided that in the judgment of the members present or of the Committee on Nomination of Officers, the requirements for the selection of the nominees as given in (a), (b), (c), and (d) of this section have been met.

Section 3. The Presidency shall be filled as follows: a President-Elect shall be elected annually, to serve one year as President-Elect, and the following year as President. (In 1954 both a President and a President-Elect shall be elected.)

Section 4. The Secretary shall be elected in each even-numbered year (as 1954) for a term of two years.

Section 5. The Treasurer shall be elected in each odd-numbered year (as 1955) for a term of two years.

Section 6. The Journal Correspondent shall be elected in each even-numbered year (as 1954) for a term of two years.

Section 7. Officers, with the exception of the Honorary Vice-President, shall be elected by the active staff and student members

in residence, in the spring semester by mail ballot. A time for the close of balloting shall be announced by the committee charged with conducting the election, and only those ballots shall be counted that shall have been received by the time specified. For each office, that person shall be declared elected who receives a majority of the votes cast for that office.

Section 8. Elective officers shall hold office as specified in Sections 3, 4, 5, and 6 of this Article, or until their successors shall be elected and qualified. Officers-elect shall be installed at the Annual Banquet, and shall immediately assume the duties of their respective offices.

Section 9. The student having the highest average grade among the junior student members elected in the spring semester shall be designated as Honorary Vice-President. He shall be installed at the Annual Banquet.

In the event that the Honorary Vice-Presidency is not filled in the spring semester, the senior having the highest average grade among the student members elected in the following fall semester shall be designated as Honorary Vice-President.

Section 10. If the Presidency should be vacated prior to the expiration of the term for which the President was elected, the President-Elect shall assume the office for the remainder of the unexpired term, and shall continue in office to serve the term as President for which he had been elected.

Section 11. If the office of President-Elect should be vacated otherwise than by the elevation of the President-Elect to the Presidency, the office may be filled by a special election, or allowed

to remain vacant until the next regular election, whichever a majority of the Staff members of the Executive Committee may deem advisable.

Section 12. If in any office a vacancy should occur for which no other provision is made, the office shall be filled, until such time as an election is held (special or regular), by majority vote of the staff members of the Executive Committee.

Section 13. The duties of the President, the President-Elect, the Secretary, and the Treasurer shall be such as usually pertain to these offices, together with such other duties as the Chapter Constitution and By-Laws may prescribe.

Section 14. (a) When called upon, the President-Elect shall represent the President in the performance of duties that pertain to the office of President.

(b) The President-Elect shall serve as Chairman of the Committee on Organization and Coordination, and shall be the Custodian of the Constitution and By-Laws, the Rules of Procedure, the Booklet of Information of the Chapter, and the records of the Committees of the President.

Section 15. Besides such other duties as the Chapter Constitution and By-Laws may prescribe, it shall be the duty of the Journal Correspondent to report to the Editor on the activities of the Chapter, to supply him with items of interest about the members, and in general to cooperate with him in collecting suitable and interesting material for publication in the Phi Kappa Phi Journal. (National Article II, Section 6.)

Section 16. (a) The Honorary Vice-President shall serve as Chairman of the Advisory Committee of Chapter Student Members. As an officer and as Chairman of the Advisory Committee, he will be expected to communicate to the President and to chairmen of appropriate committees, the views of the Committee and of the Chapter student members regarding the effectiveness of the efforts of the Chapter to encourage scholarly achievement among the students of the College. He will be expected to lead the Advisory Committee in the study of problems common to students, Chapter, and College; and in the quest for more effective means of advancing the aims of the Society.

(b) The Honorary Vice-President shall perform his part in the ritual of initiation.

Section 17. As to the appointment of members for the Advisory Committee of Chapter Student Members, the President shall confer with the Honorary Vice-President as to the number of, and qualifications of, its members; and as to distribution of representation of its membership among the schools and divisions of the College.

Section 18. Upon being informed by the Committee on Nomination of Chapter Officers that an elective office has not been filled because no nominee for that office has received a majority of the votes cast, the President, upon authorization of the Executive Committee, shall instruct the Secretary to call a special election meeting. Notice shall be sent to all active staff and student members in residence at least five days prior to the election meeting. The two nominees who received the greater number of votes in the

previous balloting shall be voted upon at the election meeting, and that nominee shall be declared elected who receives a majority of the votes cast. The President shall refrain from voting at this election meeting, except in the event of a tie; whereupon the President shall cast the deciding vote.

ARTICLE III

COMMITTEES

Section 1. The management of the Chapter shall be vested in an Executive Committee composed of the officers of the Chapter, the immediate past President, and the Honorary Vice-President. With the consent of at least two other elected officers, the President may appoint additional members to the Executive Committee. A quorum of the Executive Committee shall be four members. The President shall be chairman, and all members shall have full voting powers.

Section 2. The President, as soon as practicable after taking office, shall appoint committees charged with the following activities:

- (a) Committee on Organization and Coordination. (President-Elect as Chairman, Chapter Secretary, Vice-President, two other staff and two other students.)
- (b) Selection of Undergraduate Student Members. (Three staff and three students.)
- (c) Selection of Graduate Student Members. (Three staff.)
- (d) Selection of Staff members. (Three staff.)
- (e) Selection of Alumni and Honorary Members. (Three staff.)
- (f) Selection of Candidate and Alternate for National Society Fellowship. (Three staff.)

- (g) Student Honors and Awards. (Three staff and three students.)
- (h) Nomination of Chapter Officers. (Three staff and three students.)
- (i) Annual Banquet and Initiations Program. (Two staff and two students.)
- (j) Speakers and Publicity. (Three staff and three students.)
- (k) Society-Chapter Membership Reception. (Three staff and three students.)
- (l) Auditing. (Two staff.)
- (m) Advisory Committee of Chapter Student Members. (Vice-President as Chairman and seven or more other students.)
- (n) Liaison. (Past-President as Chairman, President-Elect as Secretary, Chairmen of Committees on Selection of Members, Student Honors and Awards, Selection of Candidate and Alternate for Society Fellowship Award, as members.)

Section 3. The four committees on the selection of candidates for membership shall obtain the necessary information and submit the names of their nominees to the Chapter for approval and election at the meetings specified or by mail. (For Reports of Election of Members, see National Constitution, By-Laws and Rules of Procedure, Section 4.)

Section 4. The President, with the advice of the Executive Committee, is authorized to appoint to committees either more members or fewer members than the numbers specified in Section 2 of the Article; and to appoint other committees as needs for them may arise.

Section 5. The Executive Committee is empowered to authorize, by a majority vote of staff members, special elections; and in like manner to fill vacancies in office pending the outcome of elections.

Section 6. Further duties of committees are set forth in the By-Laws. Duties not specifically outlined, of all committees, shall be such as usually pertain to those committees.

Section 7. Committees shall serve for one year or until the appointment of their successors.

ARTICLE IV

Meetings

Section 1. (a) During the year the Chapter shall have two or more stated meetings, at one of which an address should be delivered. (National Article II, Section 7.)

(b) Mail notices of all meetings of the Chapter shall be sent to all active student and staff members.

Section 2. The election of honorary, alumni, or student candidates for membership may be held at any regular election meeting. The election of staff candidates shall be conducted by mail ballot in the spring semester.

Section 3. Senior Candidates. Those students who are seniors at the beginning of the fall semester, and who are eligible for election into membership, shall be considered for election at a meeting in the fall semester; and those students who are seniors at the beginning of the spring semester, and who are eligible for election, shall be considered for election at a meeting in the spring semester.

Section 4. Junior Candidates. Those students who are juniors at the beginning of the spring semester, and who are eligible for election into membership, shall be considered for election at a meeting in the spring semester.

Section 5. Quorum. For purposes of voting and transacting business, the quorum at any meeting shall be one-third of the active membership of the chapter, or fifteen if the number of active members is greater than forty-five. (National Article II, Section 7.)

Section 6. Special meetings may be called by the President at his discretion, or shall be called by the President upon the written request of five active members.

Section 7. Parliamentary Rules. Except when in conflict with the Constitution and By-Laws of the Chapter, Robert's Rules of Order Revised (copyright 1943) shall constitute the rules of procedure applicable to all meetings of the Chapter and if its committees.

ARTICLE V

Qualifications for Membership

Section 1. The active membership of the Chapter shall comprise each year those members who have paid the dues of the Chapter for that year. All other members shall be considered as inactive. (National Article III, Section 2.)

If a member's dues remain unpaid for one semester after the Secretary has notified the member that payment has fallen due, then the Secretary shall place the name of the member upon the inactive list.

The Secretary will place the name of an active member upon the inactive list at the request of that member.

Only an active member in residence may vote, hold office, serve on any committee, or serve as a Chapter delegate at any convention of the Society. (National Article III, Section 2.)

Section 2. Definitions. The word staff includes anyone in residence who is an active member of the teaching, administrative, research, or extension staff of North Carolina State College. The phrase in residence shall apply to any person who is officially connected with North Carolina State College, either as a regularly enrolled student, or as an active member of the teaching, administrative, research or extension staff, whose appointment thereto is not in an ex officio capacity. Members in residence are expected to maintain an active membership in the Society. (National Article III, Section 2.)

A transfer student is a student who has entered State College with credits from another institution of collegiate standing, exclusive of credits earned in the Armed Services.

A student who has become eligible for election into membership in the Chapter shall be considered an eligible candidate up to the time of his graduation; that is, his continued residence on the campus is not to be considered as a prerequisite to election.

Section 3. Graduate Student. Any graduate student of sound character who is a candidate for an advanced degree, who has been registered as a graduate student for at least one year, and who has made a noteworthy record in his graduate work, shall be eligible for election, except that a candidate for a master's degree who has not completed a full year's residence shall be eligible for election within one month prior to the scheduled completion of requirements for his degree, and except further, that any former graduate student who has been awarded an advanced degree subsequent to the latest previous election of members in the Chapter shall be eligible

for election. The number of graduate students elected in any year shall not exceed one-tenth of the number of such students subject to consideration during that year; and furthermore, within this tenth only those graduate students shall be eligible for election who have a scholastic average equivalent to that required of the undergraduate senior, non-transfer members. (National Article III, Section 3(b).)

Section 4. Non-transfer Seniors. Non-transfer students of sound character of the senior class who rank in scholarship within the highest eighth of their class, are eligible for election; provided, however, that such students have a minimum of 100 credit-hours and a scholastic average of at least 3.25, and that the number of undergraduate students elected in any year shall not exceed ten percent of those who will be candidates for graduation.

Section 5. Transfer Seniors. Transfer students of sound character of the senior class, who have been registered at State College for three semesters or more, who are registered in a course of at least four years, and who rank in scholarship within the highest eighth of their class, are eligible for election; provided, however, that such students have a minimum of 100 credit-hours, that the number of undergraduate students elected in any year shall not exceed ten percent of those who will be candidates for graduation, and that for all work completed at State College they have minimum scholastic averages conforming to the following scale:

Section 6. Juniors. Undergraduate students (non-transfer and transfer) of sound character of the junior class, who have been registered at State College for at least one year in a course of not less than four years, and who rank in scholarship within the highest five percent of their class, are eligible for election, provided that the total number of undergraduate students elected in any year shall not exceed ten percent of those who will be candidates for graduation, and provided further, that they have earned by the beginning of the second semester of the junior year a minimum of 85 credit-hours, and have a scholastic average of at least 3.5 on all work completed at State College.

Section 7. Staff. Anyone in residence, two or more years prior to his nomination, who is an active member of the teaching, administrative, research, or extension staff of North Carolina State College; who is an alumnus of North Carolina State College; who is a graduate of at least a four-year course in a collegiate institution of recognized standing and whose scholastic record as an undergraduate would have rendered him eligible to membership; or who has attained a position of distinction in his field of work, is eligible for election into membership. If the Chapter desires to elect to membership a member of the college staff who does not hold a collegiate

degree, the unanimous consent of the National Society Executive Council must be obtained before he may be elected. (National Article III, Section 3 (c).)

Due weight shall be given to the following considerations, as well as to others specified by the Society:

- (a) Accomplishments of the candidate or nominee since graduation.
- (b) Length of service with the College.
- (c) Interest in scholarship and in the purposes of the Society.
- (d) An equitable distribution of members among the various divisions of the College.

Section 8. Alumni. The Chapter may elect to membership alumni from any class of five or more years' standing. The number of such alumni elected in any year may not exceed ten percent of the number of students, both undergraduate and graduate, elected for that year.

The selection for membership of an alumnus not in residence shall be made on the bases of outstanding achievements since graduation and of a high scholastic record while in college, with an increasing emphasis upon the former as the period after graduation becomes longer. (National Article III, Section 3 (d).)(For alumni who are staff members see Section 7 of this Article.)

Section 9. Honorary Members. The Chapter may each year elect to honorary membership one person who has no official connection with North Carolina State College. The unanimous consent of the

National Society Executive Council must be obtained before such a person may be elected.

A person elected to honorary membership shall be a graduate of ten or more years' standing from an institution of recognized collegiate rank, and shall have attained eminence in some field of creative endeavor. The Chapter may not elect under this classification a graduate of an institution in which a chapter of Phi Kappa Phi exists without first obtaining the consent of that chapter. (National Article III, Section 3 (e).)

Section 10. The Chapter may, at its discretion, invite nearby members of Phi Kappa Phi who are not actively connected with North Carolina State College to maintain the status of "Active Member in Residence." (National Article III, Section 3 (f).)

Section 11. Life Membership. Any member of the Society may be accorded the status of an active member for life by payment of life membership fee of twenty-five dollars in a single payment, or thirty dollars in three annual installments. Life members shall be exempt from the payment of National dues and assessments, and shall be entitled to receive, free for life, the Phi Kappa Phi Journal and the Society catalog. (National Article III, Section 6.) Life members shall be exempt from payment of Chapter active membership dues.

ARTICLE VI

Election to Membership

Section 1. All elections to membership shall be by ballot, cast either in an election meeting or by mail.

Section 2. (a) At an election meeting any person elected must

receive the affirmative votes of at least three-fourths of the active staff and student members present and voting.

(b) In an election conducted by mail, any person elected must receive the affirmative votes of at least three-fourths of the active staff and student members voting.

(c) The committee arranging an election by mail shall announce a time for the close of balloting, and only those ballots shall be counted that shall have been received by the time specified.

Section 3. Prior to the distribution of ballots for voting by mail, the Committee on Selection of Staff Members shall submit the list of nominees, with pertinent data, to the staff membership of the Chapter.

Section 4. Each undergraduate and each graduate candidate for membership must be endorsed by at least one active staff member of the Chapter.

Section 5. The lists of undergraduate and graduate candidates for membership must be submitted for inspection by the Dean of Students, to ascertain whether disciplinary action has been recorded which would disqualify any candidate.

Section 6. In voting upon candidates for staff membership, only active resident staff members of the North Carolina State College Chapter are eligible to vote. (National Article III, Section 3 (c).)

Section 7. The Committee on Selection of Staff Members shall

nominate not fewer than three and not more than five persons, and from the persons nominated the staff members eligible to vote shall elect not more than three.

ARTICLE VII

Initiation

Section 1. The initiation of candidates elected into membership shall be performed as prescribed by the Ritual of the Society, at a time and place designated by the President.

Section 2. When it has been determined by the President that an elected candidate has graduated, that by reason of compelling circumstances he has been prevented from appearing for initiation, and that his future attendance would seem to be impracticable or long delayed -- then the President may recommend to the Chapter or to the Executive Committee that the uninitiated candidate be declared a member in good standing and be awarded the symbols of membership.

Thereupon the Chapter or its Executive Committee, on recommendation of the President, may by affirmative three-fourths vote of the active members present, or by affirmative three-fourths vote of the staff membership of the Executive Committee, declare the uninitiated candidate a member in good standing and award him the symbols of membership of the Society and the Chapter.

ARTICLE VIII

Fees and Dues

Section 1. The membership fee of a member-elect shall be \$12. Seven dollars and fifty cents of this fee is to be paid to

the National Society Treasurer. From that portion of the fee to be paid to the National Society, each new member receives a certificate of membership, the standard badge, one year's active membership dues in the Society, and one year's subscription to the Phi Kappa Phi Journal. Parts of the payment to the National Society are allocated to the Fellowship Award Fund, to the Current Publication Fund, and to Operation of the Society.

Section 2. Annual membership dues of \$2.50 shall be assessed each active member. From this sum, one dollar is to be paid as annual dues to the National Society. The portion of the dues remaining with the Chapter is expended upon such objects as secretarial supplies, Chapter scholarship awards, banquet costs of the initiates and guests, lecturer's fee, Society assessment for the Convention Fund, and the like.

Section 3. The candidate-membership fee of an elected undergraduate, graduate, staff, alumnus, or honorary member shall be considered to include the Chapter membership dues for that member for two semesters subsequent to the semester in which that member was elected, summer school excluded.

Section 4. The candidate-membership fee of an honorary candidate shall be paid by the Chapter.

Section 5. Alumni, honorary, and life members in residence shall be exempt from payment of Chapter dues.

ARTICLE IX

Honors and Awards

(The Executive Committee must exercise its discretion as to when the features in Article IX of the Constitution adopted in 1950,

relative to student honors and awards, are to be superseded by the features described in this article.)

Section 1. The State College Chapter offers annually the following certificates:

(a) A certificate to the student who has served as Honorary Vice-President of the Chapter.

(b) A certificate to a graduate student completing the requirements for a Doctor's degree within the current academic year, in recognition of superior intellectual attainment and achievement in research.

(c) A certificate to a graduate student completing the requirements for a Master's degree within the current academic year, in recognition of superior intellectual attainment and achievement in research.

(d) A certificate to the senior with the highest average grade in his class for the junior year.

(e) A certificate to the junior with the highest average grade in his class for the sophomore year.

(f) A certificate to the sophomore with the highest average grade in his class for the freshman year.

(g) A certificate in recognition of meritorious scholastic achievement for each student who earned honors or high honors in scholarship for the two semesters of his freshman year.

Section 2. Honorary Vice-President Certificate.

(a) In recognition of his scholarly attainments and of his service as an officer of the Chapter, a certificate shall be presented to the Honorary Vice-President at the close of his term in office.

- (b) "The Committee on Student Honors and Awards shall have the certificate appropriately inscribed, embossed with the official seal of the Chapter, signed by the President and Secretary and ready for presentation at the Annual Banquet by the retiring President of the Chapter."

Section 3. National Society Fellowship Award

The Chapter shall select each year from among the eligible applicants, the one applicant who is considered most worth of receiving a National Society Fellowship Award. The Society has adopted the following regulations regarding its fellowships:

(1) The fellowships shall be awarded each year to members of Phi Kappa Phi, each of whom wishes to enroll as a candidate for an advanced degree in a recognized graduate school preferably in some American college or university. A student registering in a professional school such as law or medicine shall not be eligible. Within these requirements no restriction shall be placed upon the field of work.

(2) Eligibility and selection of applicants for these fellowships shall be based primarily upon these considerations:

(a) Those persons and only those persons shall be eligible to apply for one of these fellowships who during the twelve months preceding the initiation of the proposed graduate study shall have received a baccalaureate degree; that is, these fellowships shall be to assist in graduate study immediately following graduation and at no other time.

(b) In selecting the most worthy applicant, each Chapter as well as the Fellowship Committee of the Society, shall give primary

consideration to the applicant's promise of success in graduate work as revealed by previous scholastic record, testimonials from teachers, and merit of excellence of proposed plan of graduate study.

(3) The Chapter secretary shall forward the application of the person selected, with supporting evidence, to reach the office of the Secretary of the Society on or before April 1. (Refer to National By-Laws, Section 8 (2c).)

Section 4. Scholastic and Research Achievement Certificates.

(a) Graduate Certificate. (Candidate for Doctor's degree).

Upon recommendation of the Committee on Student Honors and Awards, the Chapter shall award each year a certificate to a candidate for a Doctor's degree, in recognition of superior intellectual attainment and achievement in research. This student shall have been in residence for at least three consecutive semesters, and shall be in the process of completing the requirements for his Doctor's degree within the current academic year.

(b) Graduate Certificate. (Candidate for Master's degree).

Upon recommendation of the Committee on Student Honors and Awards, the Chapter shall award each year a certificate to a candidate for a Master's degree, in recognition of superior intellectual attainment and achievement in research. This student shall have been in residence for at least three consecutive semesters, and shall be in the process of completing the requirements for his Master's degree within the current academic year.

Section 5. Senior, Junior, and Sophomores Scholastic Achievement Certificates. Upon recommendation of the Committee on Student Honors and Awards, the Chapter shall award each year a certificate in recognition of meritorious scholastic achievement to the senior, the

junior, and the sophomore, respectively, who made the highest average grades in their respective classes the preceding year.

Section 6. Freshman Scholastic Achievement Certificates.

Upon the recommendation of the Committee on Student Honors and Awards, the Chapter shall award each year a certificate in recognition of meritorious scholastic achievement to each student who earned honors or high honors in scholarship for the two semesters of his freshman year.

Section 7. These certificates appropriately inscribed, embossed with the official seal of the Chapter, and signed by the President and Secretary shall be made ready by the Committee for presentation to the recipients at a time and place determined by the Chapter.

ARTICLE X

Chapter Organization

Section 1. The Constitution and By-Laws of the Chapter shall be in harmony with the Constitution and By-Laws of the Society. Upon adoption or revision, a certified copy of the Chapter Constitution and By-Laws shall be filed with the Secretary of the Society. (National Article II, Section 8.)

Section 2. The Chapter Constitution may be revised or amended by an affirmative three-fourths vote of the membership present, provided that any proposed revision or amendment be submitted in writing to each active member at least ten days before the meeting at which the vote is to be taken.

Section 3. The Constitution and By-Laws and related procedures of the Chapter shall be examined periodically to determine whether in operation they best foster the purposes of the Chapter and Society.

When such an examination indicates revision or amendment to be wise and needful, the President shall instruct The Committee on Chapter Organization and Coordination to perform the task required, and to report its recommendations to the Chapter.

Section 4. The Chapter may establish such By-Laws and Rules of Procedure, not in conflict with the Constitution of the Society, as may be necessary for the proper government of the Chapter. Such By-Laws and Rules of Procedure shall become operative when adopted by a majority vote of the active resident members present. (National Article XI.)

ARTICLE XI

Chapter Participation in General Convention

Section 1. Delegate to General Convention. The General Convention of the Society meets once in two years. The Chapter is entitled to one delegate to be chosen from its active members in residence. The appointment of the delegate shall be certified by the Chapter Secretary to the Secretary of the Society at least ten days prior to the opening of the Convention.

Section 2. Payment into Convention Fund. The Chapter shall pay fifteen dollars every two years to the National Society Treasurer, as its share of the Convention Fund to be applied toward expenses of the delegates at the Convention.

Attached please find five important items: 1) the timetable for activities of our Chapter during the coming year; 2) the committee-teams necessary to conduct our business--especially that of selecting and recognizing outstanding students, faculty, and alumni this year; 3) a report from our Secretary-Treasurer about the financial affairs of our Chapter; 4) a list of the building representatives from whom we all can obtain tickets for our banquet next April 4 and other information in the meantime; and 5) a proposal for a faculty development project for our Chapter this year.

Please note the time of our business meetings--October 11, 1977. February 9, 1978 as well as the dates on which Committee reports and other activities are due this year.

We are all grateful for the dedicated persons who have agreed to chair our various Committees. By this letter the Executive Committee and I are asking that many of you assist with the work of one or more of these Committees. Please check for your name and if you prefer not to serve or to serve on another Committee for which you have not been appointed, please let me know.

Please note especially, the proposed faculty development project outlined below. This idea will be discussed at our Business Meeting on October 11. Your reactions to and ideas about this will be most welcome.

A Faculty Development Project for Phi Kappa Phi

The major purpose of Phi Kappa Phi is to encourage and recognize the achievement of excellence in scholarly work by students and faculty. Off-Campus Scholarly Assignments are an extremely valuable means by which individual faculty members can maintain and further develop their competence as professional scientists, scholars, educators, and advisory service personnel. Regrettably, however, relatively few faculty members at NCSU have taken full advantage of this important fringe benefit. This is due in part to incomplete understanding of the values of such assignments and the personal and administrative arrangements that are involved.

To encourage wider understanding of these matters it is proposed:

- 1) that a special Committee of Phi Kappa Phi develop a roster of faculty members and administrators who have taken Off-Campus Scholarly Assignments during the past 10 years. Our hope is that these persons will be willing to describe their experience upon invitation by groups of faculty and/or students;
- 2) that faculty and student members of Phi Kappa Phi encourage their Department and school leaders to provide opportunities at faculty meetings or other suitable occasions for discussion of Off-Campus Scholarly Assignments by those who have taken such assignments; and
- 3) that we seek to publicize the value of Off-Campus Scholarly Assignments during the 1977-78 Academic Year. One means to do this would be to seek a speaker for our banquet next spring who will address the relationship between faculty development planning and the achievement of excellence in university education, research, and public service.

2. Alumni who are members of the faculty shall be considered for faculty membership and are not eligible for alumni membership.
3. The number of alumni elected in any one year may not exceed five percent of the number of students, both undergraduate and graduate, elected in that year.

B. Honorary Members

1. The North Carolina State University Chapter may elect one person to Honorary Membership each year.
2. To qualify for election as an Honorary member, the individual must:
 - (a) Have no official connection with North Carolina State University
 - (b) Have been graduated 10 or more years from an institution of recognized collegiate rank
 - (c) Have attained eminence in some field of creative endeavor.
3. The consent of the National Society Executive Council must be obtained before such a person may be elected.
4. The North Carolina State University Chapter may not elect to Honorary membership a graduate of an institution in which a chapter of Phi Kappa Phi exists without first obtaining consent of that chapter.

BYLAWS
OF
THE NORTH CAROLINA STATE UNIVERSITY CHAPTER OF THE
HONOR SOCIETY OF PHI KAPPA PHI

PREAMBLE

The North Carolina State University Chapter of The Honor Society of Phi Kappa Phi is a unit of The National Honor Society of Phi Kappa Phi and shall operate within the framework of the Constitution of The National Society. The Bylaws under which the local Chapter shall be operated are contained in this Document. These Bylaws, when approved by the local Chapter and by The National Society, shall supersede and nullify all previous Constitutions and Bylaws, with amendments, of this Chapter.

ARTICLE I

Name and Organization

Section 1. Name.

The name of this Society shall be the North Carolina State University Chapter of The Honor Society of Phi Kappa Phi.

Section 2. The North Carolina State University Chapter is a unit of The National Honor Society of Phi Kappa Phi and membership in the local Chapter shall constitute membership in The National Society. Members of other chapters of The National Society residing in the Raleigh area may affiliate with the North Carolina State University Chapter.

ARTICLE II

Objective and Purpose

Section 1. Objective.

The object of the Chapter is to promote the pursuit of excellence in all fields of higher education.

Section 2. Purpose.

The purpose of the Chapter shall be to recognize and honor those who have attained academic excellence. Such recognition and honor may be through election to membership and/or the presentation of special certificates or awards.

ARTICLE III

Membership

Section 1. Eligibility for Membership.

The following may be eligible for membership provided they have demonstrated a sense of responsibility, are of sound character, and meet the qualifications as set forth in Section 2 of this Article: Second semester Juniors, Seniors, Graduate Students, Faculty, Alumni, and those eligible for Honorary Membership.

Section 2. Qualifications for Membership.

A. Undergraduates.

The total number of undergraduate students (Juniors and Seniors) elected in any year shall not exceed 10% of those who will be candidates for graduation in that year. These may be selected from second semester Juniors and from Seniors.

(1) Juniors.

To qualify for election to membership Juniors must:

- a. Have been registered at North Carolina State University for at least two semesters (or equivalent) in a program of at least four years;
- b. Have earned by the beginning of the second semester of the junior year a minimum of 75 credit-hours, of which at least 30 shall have been earned at North Carolina State University;
- c. Rank in scholarship within the highest 5% of their class;
- d. Have a cumulative grade-point average of at least 3.5 on all work completed at North Carolina State University.

(2) Non-transfer Seniors.

To qualify for election Non-transfer Seniors must:

- a. Have completed a minimum of 100 credit-hours at North Carolina State University;
- b. Rank in scholarship within the highest 10% of their class;
- c. Have a cumulative grade-point average of at least 3.25 on all work completed at North Carolina State University.

(3) Transfer Seniors.

To qualify for election to membership Transfer Seniors must:

- a. Have been registered at North Carolina State University for three semesters (or equivalent) or more in a program of at least four years;
- b. Have completed a minimum of 100 credit-hours of which at least 45 shall have been completed at North Carolina State University;
- c. Rank in scholarship within the highest 10% of their class;
- d. Have a cumulative grade-point average on all graded work completed at North Carolina State University that conforms to the following scale:

<u>Number of credit-hours completed at North Carolina State University prior to nomination:</u>	<u>Grade-point average on North Carolina State University work completed must be at least:</u>
75 or more	3.25
60 to 74	3.30
45 to 59	3.50

B. Graduate Students.

The number of graduate students nominated during any calendar year shall not exceed 10% of the number of advanced degrees awarded in the previous 12 months. The 10% limit may be extended to permit nomination of all students whose grade-point averages are equal when computed to three significant figures.

(1) Graduate Students in Residence.

To qualify for election to membership a Graduate Student in residence must:

- a. Be actively pursuing an advanced degree at North Carolina State University (rather than being registered as a Graduate student unclassified);
- b. Have completed at least 18 hours of letter-grade graduate credit at North Carolina State University;
- c. Have an accumulative grade-point average of 3.8 or above.

(2) Graduate students who have been awarded an advanced degree by North Carolina State University subsequent to the last election of members to the Chapter, may be elected provided they meet the qualifications set forth immediately above under "b" and "c".

C. Faculty.

- (1) To qualify for election to membership a Faculty member must satisfy all of the following four requirements:
 - a. Be a full-time member of the administrative, teaching, research, or extension staff of North Carolina State University;
 - b. Have held such position in residence for two or more years prior to his nomination;
 - c. Be an alumnus of North Carolina State University or a graduate of at least a four year course in a collegiate institution of recognized standing;
 - d. Have had a scholastic record as an undergraduate that would have rendered him eligible for

membership, or have attained a position of distinction in his field of work.

(2) In addition to the qualifications specified immediately above, due weight shall be given to the following considerations:

- a. Accomplishments of the candidate or nominee since graduation;
- b. Length of service with the University;
- c. Interest in scholarship and in the purpose of the Society;
- d. An equitable distribution of members among the various divisions of the University.

(3) A member of the faculty who does not hold an academic degree may be elected to membership only with the prior consent of the National Society Executive Council. (National Constitution, Article II, Section 2-d).

(4) Not more than 1% of the roster of the voting faculty, including those who are already members of Phi Kappa Phi, may be elected in any one year.

D. Alumni.

(1) To qualify for election to membership an Alumnus must:

- a. Have been graduated for five or more years;
- b. Have been of high scholastic standing as a student;
- c. Have made outstanding achievements since graduation, with achievements becoming relatively more important the longer the term since graduation.

(National Constitution, Article II, Section 3-c.)

- (2) Alumni who are members of the faculty shall be considered for faculty membership and are not eligible for alumni membership.
- (3) The number of alumni elected in any one year may not exceed $\frac{5}{100}$ of the number of students, both undergraduate and graduate, elected in that year.

E. Honorary Members.

- (1) The North Carolina State University Chapter may elect one person to honorary membership each year. (National Constitution, Article II, Section 2-g.)
- (2) To qualify for election as an Honorary Member the individual must:
 - a. Have no official connection with North Carolina State University; and
 - b. Have been graduated ten or more years from an institution of recognized collegiate rank; and
 - c. Have attained eminence in some field of creative endeavor.
- (3) The consent of the National Society Executive Council must be obtained before such a person may be elected.
- (4) The North Carolina State University Chapter may not elect to honorary membership a graduate of an institution in which a chapter of Phi Kappa Phi exists without first obtaining consent of that chapter.

Section 3. Nomination and Election of Members.

A. Nominations.

Nomination for membership shall be by a selection committee. Each of the several selection committees shall prepare a list of nominees and present it at the annual election business meeting. The responsibilities of the selection committees are set forth in Article IV, Section 3, below. It shall be the responsibility of each selection committee to determine that each nominee meets the qualifications for membership as set forth in Article III, Section 2, above.

B. Election of Members.

- (1) There shall be a business meeting early in the second (spring) semester.
- (2) At that meeting each selection committee shall present a list of nominees and certify that, insofar as it was possible to ascertain, each nominee meets the qualifications for membership as set forth in Article III, Section 2, above.
- (3) All elections to membership shall be by ballot, cast either in an election meeting or by mail as determined by the Executive Committee.
 - a. At an election meeting, to be elected a nominee must receive the affirmative votes of at least three-fourths of the active faculty and student members present and voting.

- b. In an election conducted by mail, to be elected a nominee must receive the affirmative votes of at least three-fourths of the active faculty and student members of the chapter.

C. Initiation.

- (1) Initiation of the newly elected members shall be in the spring semester at a time and place designated by the President, with the approval of the Executive Committee.
- (2) The initiation shall be performed as prescribed by the ritual of The National Society.
- (3) Members-elect shall attend and participate in the initiation ceremony and shall not be considered as members of the chapter unless (a) they participate in the initiation ceremony or (b) they are excused under the conditions specified in Paragraph (4) immediately following.
- (4) A member-elect, upon approval of his written request to the Secretary, may be excused from participating in the initiation if it is determined by the Executive Committee that compelling circumstances would make it impractical for the member-elect to be present. If the candidate is excused, the President and the Secretary may certify him as a member in good standing and authorize the award of symbols of membership.

Section 4. Classification of Members.

There shall be four classes of members as follows:

A. Active Members.

Active members are those who have paid current annual dues. (Life members are considered as active members.) Phi Kappa Phi members elected by other chapters who reside in the Raleigh area may become active members of the North Carolina State University Chapter by payment of annual dues.

B. Inactive Members.

Inactive members are those members of Phi Kappa Phi who failed to pay annual dues during the past academic year and prior to the beginning of the fall semester. Inactive members may not vote, hold office, serve on committees, make nominations for membership or for any of the several awards, or in any other way participate in the business affairs of the Chapter. They may become active upon payment of the annual dues.

C. Active Members for Life.

- (1) Any member of the Chapter may be accorded the status of Active Member for Life on payment of a life membership fee as specified by the National Society.
- (2) With the approval of the Chapter an active member may upon retirement from professional duties and upon payment of the fee specified by the National Society, be designated as an Active Member for Life and have

all further payment of National Society and Chapter dues waived.

(3) Active Members for Life shall have all the privileges of other active members.

D. Honorary Members.

Honorary Members are persons who have been accorded this status by the Chapter with the approval of the National Executive Council.

ARTICLE IV

Government, Officers, Committees, and Meetings

Section 1. Government.

The government of the Chapter shall be vested in (A) the active members of the Chapter and (B) the Executive Committee.

A. All major items of business shall be conducted by the active members in duly convened meetings. These matters of business shall include, but not be limited to, the election of officers and of new members.

B. The Executive Committee shall act for the Chapter on such matters as arranging for time and place of meetings and shall perform such other duties as may be delegated to it.

(See Article IV, Section 3-A, below.)

Section 2. Officers: Duties, Election, and Filling of Vacancies.

A. Officers.

The officers of the Chapter shall be a President, a President-Elect, a Vice-President, a Secretary, a Treasurer, and a Public Relations Officer.

B. Duties of Officers.

(1) The President shall:

- a. Preside at meetings of the Chapter and at meetings of the Executive Committee, and in general supervise the affairs of the Chapter;
- b. With the assistance of the Executive Committee, appoint all committees except the Executive Committee;
- c. Notify newly elected faculty and alumni members of their election;
- d. Notify those chosen to receive awards of their selection;
- e. Inform all candidates for election to office of the election results.

(2) The President-Elect shall:

- a. At the request of or in the absence of the President represent the President in the performance of duties that pertain to the office of President;
- b. Serve as Chairman of the Committee on Organization and Coordination;
- c. Be custodian of the Bylaws and of the Rules of Procedure;
- d. Succeed to the presidency at the end of his term as President-Elect, or earlier if the office of President should become vacant.

- (3) The Vice-President shall:
- a. Serve as Chairman of the Advisory Committee of student chapter members;
 - b. Lead the Advisory Committee in the study of problems common to the students, the Chapter, and the University in the quest for more effective means of advancing the aims of the Society;
 - c. Communicate to the President and to the Chairmen of appropriate committees the views of the student members of the Chapter.
- (4) The Secretary shall:
- a. Keep the records of the Chapter including minutes of the meetings of the Chapter and of the Executive Committee;
 - b. Notify active members of Chapter meetings;
 - c. Notify newly elected Undergraduate and Graduate members of their election;
 - d. Collect and assemble new member personnel forms and transmit the necessary information concerning new members to the Executive Director of The National Society.
 - e. Order certificates and jewelry for newly elected members and certificates for those selected to receive special awards, and a certificate for the Vice-President;
 - f. Receive the initiation fees of new members and transmit the money to the Chapter Treasurer;

- g. Transmit to the Executive Director of The National Society on or about January 1 of each year a list of all active members together with their annual national dues;
 - h. Submit an annual report of Chapter activities during the year to the Executive Director of The National Society;
 - i. Perform such other duties as appropriate or demanded of the Secretary.
- (5) The Treasurer shall:
- a. Keep the financial records of the Chapter;
 - b. Receive all funds and pay all expenses incurred by the Chapter;
 - c. Make investments or otherwise manage the money as authorized by the Executive Committee;
 - d. Perform such other duties as may be appropriate to the office or as may be delegated to him.
- (6) The Public Relations Officer shall:
- a. Serve as Chairman of the Committee on Speakers and Publicity;
 - b. Report to the Editor of the Phi Kappa Phi Journal on activities of the Chapter and items of interest about Chapter members;
 - c. Be responsible for local publicity on such matters as: election of officers, new members, special awards, and others matters as appropriate.

- d. Perform such other duties as may be appropriate or as may be delegated to the office.

C. Nomination and Election of Officers.

(1) Nominations.

The Committee on Nomination of Chapter officers shall prepare a slate of nominees and present it at a regular or special business meeting of the Chapter. Additional nominations may be made from the floor.

(2) Qualifications of Nominees for Office.

a. Nominees for elective offices of the Chapter

shall meet the following requirements:

- i. Each nominee shall have maintained active membership in the Chapter for at least 1 1/2 years prior to the submission of his nomination.
- ii. Each nominee for office of President-Elect and each nominee for office of Secretary shall have held an office or a committee membership, or both, during his active membership in the Chapter.
- iii. Each nominee for an elective office shall give his consent to the nomination.
- iv. Each nomination shall be accompanied by a record of the nominee's activities as a member of the Chapter and of the University Faculty.

- v. All nominations made from the floor must meet the qualifications outlined immediately above.
- b. The office of Vice-President shall be filled by that most recently elected Junior who has the highest accumulative grade-point average and who is otherwise qualified.

(3) Term of Office.

Officers shall assume their duties upon installation at the annual banquet, and shall serve for terms as designated in Paragraphs "a" through "g", following.

- a. The office of President is filled by succession of the President-Elect for a period of one year.
- b. The President-Elect shall serve for a term of one year and then shall succeed to the Presidency.
- c. The Vice-President shall serve for a term of one year.
- d. The Secretary shall serve for a term of two years beginning in even-numbered years.
- e. The Treasurer shall serve for a term of two years beginning in odd-numbered years.
- f. The Public Relations Officer shall serve for a term of two years beginning in even-numbered years.
- g. If, at the expiration of his normal term, an officer's successor shall not have been duly elected and qualified, such officer shall continue to serve until his successor is elected and qualified.

(4) Voting.

- a. Voting for all officers, except the Vice-President, shall be by mail ballot. The slate of nominees as established at a duly constituted business meeting shall be mailed by the Secretary to all active members of the Chapter. The ballot shall be returned by a specified date to the Chairman of the Committee on Nomination of Chapter Officers. The Committee shall count the ballots and report the results to the Chapter President.
- b. To be elected a nominee must receive a majority of the votes cast for that office. In case no nominee receives a majority on the first ballot a runoff election shall be held. If there are only two nominees and a tie vote both names shall be placed on the runoff ballot. If there are more than two nominees, those receiving the greatest number of votes on the first ballot (including ties) and whose total votes constitute a majority of the votes cast shall have their names placed on a runoff ballot. Voting shall continue until one of the nominees receives a majority.
- c. No election is necessary to fill the position of Vice-President. (See Article IV, Section 2, above.)

D. Filling Vacancies.

- (1) If the office of President becomes vacant the President-Elect shall succeed to the Presidency.

- a. If the succession occurs prior to the first major business meeting in the spring semester, in which case the new President would preside at the major business meetings and at the spring initiation banquet meeting, he shall be considered as having served his term as President and his term shall end with the installation of new officers.
 - b. If the succession occurs after the first major business meeting in the spring semester and after the election of new officers the President-Elect shall succeed to the Presidency and shall serve as President for the remainder of the year and during the next academic year.
- (2) If the office of President-Elect becomes vacant it shall be filled as follows:
- a. If the vacancy occurs prior to the first major business meeting in the spring semester a special election shall be held to fill the office. The person elected shall perform the duties of President-Elect for the remainder of the academic year and shall succeed to the Presidency for the following year.
 - b. If the vacancy occurs late in the second semester after new officers have been elected for the following year the office shall remain vacant until the new officers are installed.

- (3) If the office of Vice-President becomes vacant it shall be filled by that member of the most recently elected Juniors with the highest accumulative grade point average and who otherwise is qualified.
- (4) If the office of Secretary, Treasurer, Public Relations Officer, or member of the Executive Committee, becomes vacant the remaining members of the Executive Committee shall be empowered to fill the vacancy for the duration of the term.

Section 3. Committees.

A. Executive Committee.

- (1) The Executive Committee shall consist of the President, the President-Elect, the Vice-President, the Secretary, the Treasurer, the Public Relations Officer, and the immediate past President.
- (2) A quorum of the Executive Committee shall consist of a majority of its members.
- (3) The President shall be Chairman and all members shall be eligible to vote.
- (4) The Executive Committee shall have authority to:
 - a. Act on routine business items and other matters that may be referred to it;
 - b. Fill vacancies on the Executive Committee as specified under Article IV, Section 2-D, above;
 - c. Recommend changes in fees and dues;
 - d. Authorize special meetings and special elections; and

- e. Make recommendations for any changes deemed valuable to the good of the Chapter.
- B. Committee on Organization and Coordination.
- (1) This committee shall consist of the President-Elect as Chairman, the Secretary, the Vice-President, and two faculty and two student members to be appointed.
 - (2) It shall be the responsibility of this committee to:
 - a. Review and make recommendations for changes in the Chapter Bylaws;
 - b. Determine that the Chapter Bylaws are in accord with the National Constitution and Bylaws;
 - c. Assist in all ways possible in coordinating the work of the various Chapter committees and in coordinating the affairs of the Chapter with The National Society.
- C. Committee on Selection of Undergraduate Student Nominees.
- (1) This committee shall consist of equal numbers of faculty and student members, with at least three of each.
 - (2) It shall be the responsibility of this committee to:
 - a. Prepare a list of student nominees who meet the qualifications for membership described in Article III, Section 2, above.
 - b. Present the list of nominees at a designated business meeting of the Chapter and in a form suitable for use as a ballot.

D. Committee on Selection of Graduate Student Nominees.

- (1) This committee shall consist of at least three faculty members.
- (2) It shall be the responsibility of this committee to:
 - a. Prepare a list of Graduate Student Nominees who meet the qualifications for membership as set forth in Article III, Section 2-B, above;
 - b. Check the list of nominees with the Chapter Secretary and/or with the department heads to determine whether the nominee is already a member of this or another chapter of Phi Kappa Phi;
 - c. Present the list of nominees at the designated business meeting in a form to be used as a ballot.

E. Committee on Selection of Faculty Nominees.

- (1) This committee shall consist of at least three faculty members.
- (2) It shall be the responsibility of this committee to:
 - a. Prepare a list of faculty nominees who meet the qualifications for membership as set forth in Article III, Section 2-C;
 - b. Determine that each nominee is not already a member of Phi Kappa Phi;
 - c. Present the list at a designated business meeting in a form to be used as a ballot.

F. Committee on Selection of Alumni and Honorary Nominees.

- (1) This committee shall consist of at least three faculty members.

- (2) It shall be the responsibility of this committee to:
 - a. Prepare a slate of nominees who meet the qualifications for membership as set forth in Article III, Section 2-D and 2-E;
 - b. Determine that each nominee is not already a member of Phi Kappa Phi;
 - c. Present the list of nominees at the designated business meeting as a form suitable for use as a ballot.

G. Committee on Selection of Candidate for National Society Fellowships.

- (1) This committee shall consist of at least three faculty members.
- (2) It shall be the responsibility of this committee to:
 - a. Make one nomination for the National Fellowships as set forth under Article VII, Section 9. The committee may solicit nominations from active faculty members or they may make nominations on their own initiative;
 - b. Present the name and qualifications of the nominee to the Executive Committee for approval.
- (3) After approval of one nomination by the Executive Committee, the Secretary shall transmit it to the National Committee on Society Fellowships.

H. Committee on Student Honors and Awards.

- (1) This committee shall consist of equal members of faculty and students, at least three of each.

- (2) It shall be the responsibility of this committee to:
 - a. Select nominees for the awards as provided for in Article VII, Sections 3, 4, 5, 6, and 7;
 - b. To present the list of nominees, together with a summary of their qualifications, at a designated business meeting of the Chapter.

I. Committee on Nomination of Chapter Officers.

- (1) This committee shall consist of the three most recent Chapter Presidents and three student members. The most recent past President shall serve as chairman.
- (2) It shall be the responsibility of this committee to prepare a slate of nominees for each of the following offices: President-Elect; Secretary, in even-numbered years; Treasurer, in odd-numbered years; Public Relations Officer, in even-numbered years. (The office of President and of Vice-President are filled as specified in Article IV, Section 2-C.)
- (3) Present the slate of nominees at a specified business meeting of the Chapter.

J. Committee on Annual Banquet and Initiation.

- (1) This committee shall consist of as many faculty and student members as deemed necessary by the President, with the approval of the Executive Committee.
- (2) It shall be the responsibility of this committee to:
 - a. Make all the necessary arrangements for the annual initiation and banquet including selection of

the place, seating order at the initiation and at the banquet, selection of the menu for the banquet, arranging for decorations; and, perform such other duties as may be necessary in organizing and conducting the initiation and banquet.

K. Committee on Speakers and Publicity.

- (1) This committee shall consist of at least three faculty and at least three student members, with the Public Relations Officer as Chairman.
- (2) It shall be the responsibility of this committee to arrange for a speaker at the annual banquet and for such other occasions as may arise, and to assist the Public Relations Officer in the performance of his duties.

L. Auditing Committee.

- (1) This committee shall consist of two faculty members.
- (2) It shall be the responsibility of this committee to audit the accounts of the Treasurer annually and especially at the time of transfer of the Treasurer's records to the succeeding Treasurer.
- (3) This committee shall report to the Chapter at a designated business meeting.

M. Advisory Committee of Chapter Student Members.

- (1) This committee shall consist of the Vice-President as Chairman, and seven or more other student members.

- (2) It shall be the responsibility of this committee to:
 - a. Encourage scholarly achievement among students in the University;
 - b. Study problems common to students, the Chapter, and the University;
 - c. Be alert to more effective means of advancing the aims of the Society;
 - d. Present to the Chapter ideas and recommendations pertaining to Paragraphs "a" through "c", above.

N. Liaison Committee.

- (1) This committee shall consist of the past President as chairman, the President-Elect as Secretary, and the chairmen of the following committees: Committee on Selection of Undergraduate Student Nominees; Committee on Selection of Graduate Student Nominees; Committee on Selection of Faculty Nominees; Committee on Selection of Alumni and Honorary Nominees; Committee on Student Honors and Awards; and, Committee on Selection of Candidate for National Society Fellowships.
- (2) The purpose of this committee is to provide communication among the various committees constituting the framework of the Chapter.

O. Other Committees.

The President, with the concurrence of the Executive Committee, may appoint such other committees as he may

deem necessary to expedite the business of the Chapter.

Section 4. Meetings.

- A. There shall be a business meeting early in the spring semester for the purpose of:
- (1) Receiving selection committee reports and electing new members;
 - (2) Receiving the report of the Committee on Nomination of Chapter Officers;
 - (3) Transacting other necessary business.
- B. There shall be an initiation banquet meeting later in the spring semester for the purpose of:
- (1) Initiating new members;
 - (2) Announcing the recipients of awards and presenting the awards;
 - (3) Enjoying the fellowship of fellow members at the banquet.
- C. Other meetings shall be held during the year as deemed necessary:
- (1) By the President with the approval of the Executive Committee;
 - (2) When one-third of the active members of the Chapter petition for such meeting.
- D. A quorum for transaction of business at any duly called meeting shall consist of at least 15 active resident members.
- E. A three-fourths majority vote of the members present shall be necessary for electing new members.

- F. Notices of all meetings of the Chapter shall be mailed to active student and faculty members. It shall be the responsibility of individual members to inform the Secretary of any change of address.
- G. Parliamentary Rules.
All business meetings of the Chapter shall be conducted in accordance with Robert's Rules of Order.
- H. General Convention.
- (1) The general convention of the Society meets biennially. The Chapter is entitled to one delegate to be chosen from its active members in residence. The appointment of the delegate shall be certified by the Chapter Secretary to the National Executive Director at least ten days prior to the opening of the convention.
 - (2) The Chapter shall, on demand of the National Executive Director, pay a reasonable assessment as its share of the convention fund to be applied toward expenses of the delegate at the convention.

ARTICLE V

Finances

Section 1. Initiation Fees.

- A. The Chapter shall collect from each new member an initiation fee to pay for:
- (1) Lifetime membership in The National Society;
 - (2) Annual dues in the local Chapter for the year following initiation;

- (3) A membership certificate;
 - (4) A Society insignia (standard key or pin; various other insignia are available at extra cost);
 - (5) One ticket to the annual initiation banquet.
- B. The initiation fee shall be established each year by the Executive Committee. It may change from year to year depending upon economic conditions.

Section 2. Annual Dues.

- A. Annual dues for the year beginning September 1 shall be set by the Executive Committee upon recommendation by the President.
- B. Any member of the Chapter may become a Life Member by payment of a life membership fee as specified by The National Society.
- C. Chapter members who have retired from active professional duties may, upon payment of a fee as specified by The National Society, be designated as active members for life without further payment of Chapter or National dues.
- D. The membership fee for an honorary nominee shall be paid by the North Carolina State University Chapter.
- E. Honorary and Life Members in residence shall be exempt from payment of local Chapter dues.

ARTICLE VI

Official Insignia

- Section 1. The initiation fee includes the standard official insignia (key or pin) of the Society. The form of the insignia must be

selected by the new member, in consultation with the Chapter Secretary, and recorded on the personnel form to be filled out by all new members. In addition to the standard insignia, others are available at extra cost.

ARTICLE VII

Honors and Awards

Section 1. Membership Certificate.

Each newly initiated member shall receive at his initiation a membership certificate appropriately inscribed, embossed with the official seal of the Chapter, and signed by the President.

Section 2. Freshmen Recognition.

A certificate or letter from the Chapter President shall be presented to all Sophomores who during the two semesters of their Freshman year earned honors or high honors in scholarship.

Section 3. Sophomore Certificate.

Each year a certificate is given to the Sophomore who had the highest cumulative grade point average in his class at the end of the fall semester. To be eligible for this certificate, the student shall have been enrolled for both semesters of the Freshman year and the fall semester of the Sophomore year at North Carolina State University.

Section 4. Junior Certificate.

Each year the Chapter presents a certificate to the Junior who had the highest cumulative grade point average in his class at the end of the fall semester. To be eligible for this award a transfer student shall have earned at least

half of his total credits at North Carolina State University and shall have been a full time student at North Carolina State University for a minimum of three consecutive semesters or the equivalent.

Section 5. Senior Certificate.

Each year the Chapter presents a certificate to the Senior who had the highest cumulative grade point average in his class at the end of the fall semester. To be eligible for this certificate a transfer student shall have earned at least half of his total credits at North Carolina State University and shall have been a full time student at North Carolina State University for a minimum of four consecutive semesters or the equivalent.

Section 6. Master's Certificate.

The Chapter shall present each year one or more certificates to Master's degree candidates in recognition of superior intellectual achievement. To be eligible a candidate shall have been in residence for at least three consecutive semesters and shall be in the process of completing the requirements for his Master's degree within the current academic year.

Section 7. Doctor's Certificate.

The Chapter shall award each year one or more certificates to doctoral degree candidates in recognition of superior intellectual attainment and achievement in research. To be eligible a candidate shall have been in residence for at least three consecutive semesters and shall be in the process of completing the requirements for his Doctor's degree within the current academic year.

Section 8. Vice-President's Certificate.

Each year the Chapter presents a certificate to the student who has served as Vice-President of the Chapter.

Section 9. National Society Fellowship Award.

The Chapter may select each year an applicant for a National Society Fellowship Award, following the procedures and regulations prescribed by the Committee on Fellowships of The National Society.

Section 10. Other Awards.

Other awards may be presented from time to time by the Executive Committee with approval of the Chapter. These may be awards in recognition of outstanding service, or certificates to past officers of the Society, or such other recognition as may be deemed appropriate.

ARTICLE VIII

Amendments

Section 1. These Bylaws may be amended by a three-fourths majority vote of the members present at a duly called meeting at which a quorum is present, provided that the proposed amendments have been submitted to the active membership in writing at least ten days prior to the time of the meeting.

Section 2. The Bylaws of the North Carolina State University Chapter shall be in harmony with the Constitution and Bylaws of The National Society and when changed a certified revised

copy shall be filed with the Executive Director of The

National Society.
