Purpose of Organization

The mission of Pi Beta Phi Fraternity for Women is to promote friendship, develop women of intellect and integrity, cultivate leadership potential and enrich lives through community service.

Membership Requirements

Any woman attending a college or university where a chapter of Pi Beta Phi is maintained, who has good scholarship, excellent character, congeniality and appreciation for the work of the Fraternity, who is enrolled in at least 12 credit hours and who has not been initiated into another National Panhellenic Conference group.

Pi Phi expects every member to support all chapter, Fraternity and university regulations and obey all local, state, provincial and federal laws. Pi Phi depends on members to fully participate in chapter activities, meet all financial obligations, strive to achieve academic potential and uphold the highest of moral standards. Officers and Election Procedures

The chapter Executive Council shall consist of the following elected chapter officers: President, Vice President of Moral Advancement, Vice President of Mental Advancement, Vice President of Social Advancement, Secretary, Treasurer, Panhellenic Delegate, Membership Chairman, Recruitment Chairman and Social Chairman.

Chapter executive officers shall be elected annually between November 1 and April 1.

Pi Beta Phi Policy

ON USE OF ALCOHOL

All federal, state and local laws, and university policies and regulations regarding the possession, consumption, sale and/or provision of alcoholic beverages by Pi Beta Phi, its chapters, alumnae clubs, members and pledges shall be obeyed without exception.

In addition, the following policy with regard to alcohol shall be in effect. No alcohol is permitted on Pi Beta Phi property. Pi Beta Phi property includes property either owned or leased by a Pi Beta Phi chapter or House Corporation or designated for the exclusive use of a Pi Beta Phi chapter (for instance, a chapter suite in a university dormitory).

STATEMENT OF POSITION FOR NON-DISCRIMINATION

Pi Beta Phi Fraternity does not discriminate in its membership selection practices on the basis of race, religious affiliation, national origin or handicapped status. Nor will Pi Beta Phi tolerate such discrimination by its chapters.

AGAINST HAZING

The Grand Council of Pi Beta Phi reaffirms its position and that of the National Panhellenic Conference that hazing in all of its forms is prohibited in any chapter of Pi Beta Phi.

ONE-TIME PAYMENTS

International Pledge Fee **\$35.00**
Payable at time of pledging

International Initiation Fee **\$115.00**
Includes a life-time subscription to *The Arrow*, the Fraternity's magazine, and a plain golden badge.

House Corporation Fund Fee **\$75.00-\$225.00**
Each Pi Beta chapter has a House Corporation. Every initiated member is a member of that corporation. Before initiation, each pledge makes a one-time payment to the House Corporation as the member's "investment in the future" of the chapter. Each chapter and its House Corporation determine the amount of the local House Corporation fee.

OTHER PAYMENTS

Annual International Dues **\$90.00**
After initiation each chapter member pays international dues.
