Article I - Preamble

Section I - Name

The name of this organization shall be the North Carolina State Roller Hockey Club, hereinafter referred to as the N.C. State Roller Hockey Club.

Section II - Type of Organization

The N.C. State Roller Hockey Club shall be incorporated as a non-profit organization under the laws of the state of North Carolina, in which it operates.

Section III - Affiliation

The N.C. State Roller Hockey Club shall be affiliated with North Carolina State University, hereinafter referred to as NCSU. According to NCSU, the N.C. State Roller Hockey Club is an officially recognized Club Sport.

Article II - Mission Statement

The purpose of the N.C. State Roller Hockey Club is to provide an organized Club for the sport of roller hockey to students, faculty, and staff of NCSU. The eternal goals of the N.C. State Roller Hockey Club is to unify, compete in, and promote the sport of roller hockey both locally and on the collegiate level.

Section III - Staff of the 2001 - 2002 North Carolina State Roller Hockey Club

The N.C. State Roller Hockey Club may hire those who are to perform certain duties and meet certain needs necessary in meeting the mission statement and goals set by the officers. Anyone hired to accomplish the above criteria are on a volunteer basis only, and is not to be on a payroll. A Coach is to be chosen by a unanimous vote of the officers (Article III, Section II). A Faculty Advisor is appointed by the President (Article III, Section II). Either of these people may be relieved of their position at any time during the year. To relieve the Coach of his position, a unanimous vote is required. To relieve the Faculty Advisor is a duty of the President (Article III, Section II)

Section V - Elections

The Election of Officers for the N.C. State Roller Hockey Club will be held in April. of each year, by secret ballot. Each Club member will get one ballot. The ballot will contain five lines. Beside each line one officer position will be written (1. President, 2. Vice President, 3. Secretary, 4. Treasurer, and 5. Communications Chair). Each club member will vote for a candidate to fulfill that specific position. Winners will be declared by a majority count. In the event of a tie, a runoff will be held in like manner for the candidates involved in the tie. If a tie remains after the runoff, the decision will be made by the voting of the current officers. New Officers will obtain their position on the last day of exams, in the month of May, following the Election. By this day, all newly elected officers are to have been fully trained by the officer which formerly held that position.

Article IV - Membership Requirements

Section I - Members

Membership in the N.C. State Roller Hockey Club is open only to students, faculty, and staff of North Carolina State University. After all of these requirements have been fulfilled (Article IV, Section II, Section III, Section IV), he or she will be an official member of the N.C. State Roller Hockey Club.

Section II - Prior Certifications

Before taking part in any event sanctioned by the N.C. State Roller Hockey Club (tryouts, practices, games, scrimmages, etc.), one must fill out a waiver form and have it submitted to the President. In turn, the President must submit it to the Club Sports Office. A student ID must also be shown to the President, as proof of affiliation with NCSU.

Section III - Tryouts

In the event of Try-outs, one must fulfill it's requirements as well, in order to obtain membership to the Club. The requirements for Tryouts are set by the Coach (Article III, Section IV).

Section IV - Dues

After which one has fulfilled the requirements mentioned (Article IV, Section I, Section II, Section III), he or she must pay dues to the N.C. State Roller Hockey Club. Dues will be set by the Officers, according to how much they think is necessary to uphold the budget. The Officers of the Club have the decision on where these funds are to be spent (Article III, Section II).

Article V - Meeting Requirements

In order to be able to participate in any event sanctioned by the N.C. State Roller Hockey Club, one must fulfill the Membership Requirements (Article IV). In order to participate in practices and try-outs of the N.C. State Roller Hockey Club, one must have the equipment necessary. A

helmet, gloves, skates, stick, elbow pads, and shin guards which cover the knees are required. In order to participate in games and scrimmages of the N.C. State Roller Hockey Club, one must fulfill the equipment regulations of the N.C. State Roller Hockey Club (Article V) and those requirements of the League or Association and rink affiliated with that game or scrimmage.

Article VI - Amendments and By-Laws

Section V - Elections

The Election of Officers for the N.C. State Roller Hockey Club will be held in April of each year, by secret ballot. Each Club member will get one ballot. On the ballot, four names are to be written. The names must be in order of which the member wants to vote for officers (i.e. 1. President, 2. Vice President, 3. Secretary, 4. Treasurer). A vote for President will be worth 4 points, Vice President 3 points, Secretary 2 points, and Treasurer 1 point. The Club member with the most points will be the President for the following year. The Club member with the second most points will be the Vice President for the following year. The Club member with the third most points will be the Secretary for the following year. The Club member with the fourth most points will be the Treasurer for the following year. New Officers will obtain their position on the last day of exams, in the month of May, following the Election. By this day, all newly elected officers are to have been fully trained by the officer which formerly held that position.

Article IV - Membership Requirements

Section I - Members

Membership in the N.C. State Roller Hockey Club is open only to students, faculty, and staff of North Carolina State University. After all of these requirements have been fulfilled (Article IV, Section II, Section III, Section IV), he or she will be an official member of the N.C. State Roller Hockey Club.

Section II - Prior Certifications

Before taking part in any event sanctioned by the N.C. State Roller Hockey Club (tryouts, practices, games, scrimmages, etc.), one must fill out a waiver form and have it submitted to the President. In turn, the President must submit it to the Club Sports Office. A student ID must also be shown to the President, as proof of affiliation with NCSU.

Section III - Tryouts

**Constitution of
The Roller-Hockey Club of NCSU**

- Article I** **Name & Purpose**
- Section 1** This organization shall be known as The Roller-Hockey Club of North Carolina State University.
- Section 2** This club shall provide an organized structure for the participation in and the enjoyment of the sport of roller hockey for the North Carolina State University community.

- Article II** **Membership**
- Section 1** Membership shall be open to all regularly enrolled students, staff, or alumni who are interested in the participation or contribution to the sport of roller-hockey.
- Section 2** Any person who has a desire to contribute to the sport shall be offered membership. Membership shall be granted by the officers of the club upon collection of membership dues.
- Section 4** The officers of the club reserve the right to discontinue any membership without notice and without refund if that member is guilty of unsportsman like conduct.
- Section 5** The club will offer associate memberships to those other than mentioned in Section 1. The criteria for associate membership will be determined on an individual basis.

- Article III** **Officers**
- Section 1** The elective officers of this club shall be the President, Vice-President, Treasurer, and Secretary.
- Section 2** The duties of the President shall include, presiding over official meetings, organizing meetings, and official correspondence.
- Section 3** The duties of the Vice-President shall include, presiding over official meetings in the absence of the President, and contribution to official decisions.
- Section 4** The duties of the Treasurer shall include, management of club funds and contribution to official decisions.
- Section 5** The duties of the Secretary shall include, informing members of events and contribution to official decisions.
- Section 6** The officers of this club shall be elected by the club to serve a term of one year, beginning the first week of May each year.
- Section 7** Election of officers will be held during the first week of April. All current active members in good academic standing are eligible.

- Article IV** **Dues**

Section 1 The dues for the club per semester shall be assessed by the club Treasurer and ratified by a majority vote of active club members.

Article V

Amending the Constitution and By-Laws

Section 1

Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A two-thirds (2/3) majority vote will be required for ratification.

Article VI

Meetings

Section 1

The frequency and length of meetings will be determined by the availability of playing surfaces and by member participation. A meeting of at least half the club members should occur at least once a month.
