# NORTH CAROLINA STATE UNIVERSITY RUGBY FOOTBALL CLUB

## CONSTITUTION

### I. General Purpose

The basic purpose of this organization is to encourage and promote the game of Rugby Union Football at North Carolina State University.

### II. Membership

Membership is on a voluntary basis and is open to any student, faculty or staff member. An individual may join or resign at any time by notifying the secretary.

### III. Financial Obligations

Membership dues are obligatory and are paid at the beginning of each semester. They are used only for the financing of group activities. If it is necessary to cover a deficit, a further levy may be made.

### IV. Objectives

1. To further and develop amateur sports and, in particular, Rugby Union Football
2. To provide social and physical activities by encouraging and developing the sport of Rugby Union Football and the participation therein by amateurs.
3. To arrange and conduct games with other Rugby Union Football Clubs.
4. To cultivate social entertainment and promote friendship and sociability among its members.

### V. Organizational Structure

- A. The elected positions of this organization shall be the following: President, Vice-President, Secretary, Treasurer and Captain.
- B. The President, Vice-President, Secretary and Treasurer, together with the faculty advisor, shall constitute an Executive committee.
  1. The Executive Committee, by majority vote, may take any action without approval of the Club, but all such actions may be subsequently vetoed by a 2/3 vote of the members present at a duly called meeting with a quorum in attendance. A quorum is defined as 75 percent of all members.
  2. The President shall have the responsibilities of making all appointments subject to the approval of the Executive Committee.
  3. The Executive Committee shall not have the power to make any financial commitments beyond the balance of the treasury without majority approval of the Club.
- C. Each of the elected positions of this organization shall be on a yearly basis with no person holding more than two elected positions simultaneously.
  1. Elections shall take place during the first general club meeting of the spring season. Those elected will assume office at the beginning of the fall season.
  2. Nominations for each position shall be made at the first general club meeting of the spring season.
  3. Elections will be held for the positions in the order described in Section V, paragraph A except for Captain.

4. Any vacancy occurring in these positions shall be filled at the next meeting.

D. A selection committee shall be elected by the club members. The purpose of the selection committee shall be to select the playing sides for club matches.

VI. Meetings

A. It shall be the responsibility of the Executive Committee to establish a time for meetings which is convenient to the majority of the members.

B. Transaction of official business at any scheduled meeting shall require the presence of a quorum (defined to consist of at least 30 percent of the members), with a simple majority vote ruling.

VII. Alterations

After initial adoptions, any modifications of the above sections shall require approval of a 2/3 majority at any one meeting, as in Section VI.
