

# SCUBA Club Constitution

## Article I Name & Purpose

### Section 1

This organization shall be known as the SCUBA club. It was formerly known as the Aqua Team.

### Section 2

The purposes of this club shall be to promote SCUBA diving, underwater conservation and give divers a networking opportunity. We will promote safe diving practices among NCSU students.

## Article II Membership

### Section 1

Membership shall be open to all regularly enrolled students who are interested in SCUBA diving.

### Section 2

Any NC State student, diver or non-diver will be permitted into the club.

---

## Article III Officers

### Section 1

The elective officers for this club shall be the President, Vice President, Secretary and Public Relations. They will be in charge of event planning, keeping track of money and planning all club activities.

### Section 2

The officers shall be elected by the club members to serve a term of one year, beginning in August and ending in April of the following year.

### Section 3

Officers will be elected by ballot at the end of April. Candidates must be elected by a majority.

## Article IV Dues

### Section 1

Dues for the club shall be in the form of special assessments voted on by a majority of the

club members present and voting. If the club chooses to collect dues they will cover membership for the entire year.

## **Article V Amending the Constitution and by-laws**

### **Section 1**

Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the members present and voting shall be required.

## **Article VI Meetings**

### **Section 1**

The club shall meet as determined by the club membership each semester.

---

## **Article VII Committees**

### **Section 1**

The club shall make provision for any standing committees needed and/or for forming any special committees when needed.

---

## **Article VIII Trips**

### **Section 1**

Only certified divers will be allowed to go on diving trips. Liability forms must be signed before leaving on dive charters.

# **Aqua Team Constitution**

## **Article I – Name and Purpose**

### **Section 1**

We the people of Aqua Team come together to form a more active scuba club. This club shall be known as no other than Aqua Team.

### **Section 2**

There is no affiliation with national or regional groups

### **Section 3**

The purpose of Aqua Team shall be to dive safely and often, participate in other scuba related activities, and to help advocate the sport of scuba diving among students of NCSU and provide a safe environment in which to do so.

## **Article II - Membership**

### **Section 1**

Acceptance into the Aqua Team shall be open to all regularly enrolled students or certified divers who have a passion for or interest in scuba diving.

### **Section 2**

New members of Aqua Team must have a scuba certification, or be currently enrolled in a NCSU scuba class. For acceptance, they must come to a meeting with proof of either, and show it to a team officer. Upon confirmation, they will be allowed to enter the Aqua Team

## **Article III – Officers**

### **Section 1**

Aqua Team shall have at its head 4 officers. They shall be President, Vice President, Secretary, and Public Relations. Their duties shall be as follows: President- Event planner, treasurer, Manager of all club activities and other officer's responsibilities. Vice President- Direct assistant to the President, shares in all his duties and responsibilities. Secretary- type flyers, calendars, or any other publications and also assist the president.

## **Article IV – Dues**

### **Section 1**

Dues shall be in the form of special assessments voted on by a majority of the club members present and voting.

## **Article V- Amending the Constitution and By-Laws**

### **Section 1**

The constitution may be amended by a 3/4 vote.

## **Article VI – Meetings**

### **Section 1**

Regular meetings of this organization shall be held once every 2 weeks

### **Section 2**

A quorum shall consist of 5 voting members
