Article I Name & Purpose

Section 1

This organization shall be known as the:
Services Management and Consulting Club at NC State University. (SMCC)

Section 2

The primary purpose of this club shall be to introduce and prepare students for careers in services management and consulting.

Article II Membership

Section 1

Membership shall be open to all regularly enrolled MBA students at NC State University who are interested in becoming involved in management consulting or services management.

Section 2

New members will be registered and approved each Fall semester.

Article III Officers

Section 2

The officers shall be elected to serve a term of one year, beginning September 1st. If the need to appoint an officer arises before September 1st, club members will be interviewed for the position by remaining officers. The President and Vice President must serve as a club officer prior to appointment. At least three officer positions must be filled by incoming 1st year students.

Article IV Dues

Any decision to start or cease collection of dues will be made at the discretion of club.

Article V Amending the Constitution and by-laws

Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting. They shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the members present and voting shall be required.

Article VI Meetings

Article VII Committees
