## ARTICLE I:

## NAME

Section I. This organization shall be known as the North Carolina State University Ski and Snowboard Club

## ARTICLE II:

## PURPOSE

Section I. The purpose of this organization will be to promote education and participation in the sports of snow skiing and snowboarding both in recreational aspects. The organization will also promote snow-skiing at the competitive level.

## ARTICLE III:

## MEMBERSHIP

Section I. <sup>Regular</sup> Members of this organization will be students, faculty and staff of North Carolina State University who have an interest in the sports of snow skiing and/or snowboarding and who are in good standing with the university.

Section II. <sup>Associate</sup> Members of this organization may be any individual interested in the sports of snow skiing and/or snowboarding who have signed a Waiver and Release Form For Non NCSU Participants drafted by Student Legal Services.

## ARTICLE IV.

## OFFICERS

Section I. The officers of this organization will be chosen from and by the active, <sup>regular</sup> members of the club.

A. The officers will be: President, Vice President, Secretary, and Treasurer.

B. The election of these officers will take place at the last meeting of the spring semester.

## ARTICLE V. DUTIES OF OFFICERS

## Section I. The President will

- A. Be responsible for organizing all Club activities and for approving all plans for club activities.
- B. Enforce all provisions of this constitution.
- C. Be responsible for reporting to the Club Sports Coordinator in the Intramural-Recreational Sports Office during the first two weeks of school.
- D. Be responsible for submitting a tentative schedule of activities for the year both on and off the campus including dates which a state vehicle will be needed.

## Section II. The Vice President will

- A. Assume duties of President during his absence.
- B. Be a member of all committees and assist the President.

## Section III. The Secretary will

- A. Be present to take minutes of all meetings.
- B. Conduct correspondence for the club.
- C. Notify members of club functions.
- D. Keep a proper record of equipment.
- E. Be responsible for submitting a club roster to the Intramural-Recreational Sports Office and for keeping it updated.
- F. Be responsible for submitting health insurance and risks, hazards and physical stresses forms to the Intramural-Recreational Sports Office.

## Section IV. The Treasurer will

- A. Keep an accurate record of all accounts and will be responsible for collecting dues.
- B. Assist the President in budget preparation.
- C. Submit a statement of all club funds on hand, both in checking and savings, at the end of each semester.

## ARTICLE VI. ELECTIONS

- Section I. The officers will be elected by a majority vote of at least one half of the total membership.
- Section II. The officers will serve for two semesters with new officers being elected at one of the last business meetings of the spring semester and taking charge pending election.
- Section III. Officers may be removed from office by a majority vote of the active members in a meeting consisting of at least one half the total membership.

## ARTICLE VII. FACULTY ADVISOR

- Section I. The faculty advisor(s) will be a member of the faculty or staff of NCSU and will be selected by the members of the club.
- Section II. The duties of the faculty advisor include:
- A. Attending a minimum of three business meetings of the club (preferably the first business meeting of each semester and the last meeting of the spring semester).
  - B. Approving all club activities.
  - C. Assisting the members in the organization and planning of projects.
  - D. Serving as a source of information.
  - E. Advising the members in making their yearly budgets.
  - F. Accompanying the club on outings whenever possible.

## ARTICLE VIII. DUES

- Section I. The amount of dues will be determined by a majority vote of members present at the first business meeting of the fall semester in agreement with the Club Sports Coordinator.

## ARTICLE IX. BYLAWS

- Section I. The president will have the power to appoint a committee for the purpose of recommending bylaws for the organization. The bylaws will become effective when passed by a majority vote of club members and with the consent of the Club Sports Coordinator
- Section II. Should the Club become inactive or disband and a new club has not been formed within a period of one year, all property of the Club will become the property of the Intramural-Recreational Sports Office.

Section III. This constitution will be updated each year.

CLUB ACTIVITIES

Section I. Club activities will include club meetings, fund raising and the participation in the sports of snow skiing and snowboarding

- PREAMBLE: We the Snow Ski Club of N.C.S.U. find it our responsibility to promote the sport of snow skiing, to educate our members as to the value of snow skiing, and to create a greater understanding among our members through fellowship in a club that represents the winter sport of snow skiing.
- ARTICLE I. NAME
- Section I. This organization shall be known as the North Carolina State University Snow Ski Club.
- ARTICLE II. PURPOSE
- Section I. The purpose of this organization will be to promote education and participation in the sport of snow skiing both in competitive and recreational aspects.
- ARTICLE III. MEMBERSHIP
- Section I. The membership of this organization will be limited to students, faculty and staff of North Carolina State University who have an interest in the sport of snow skiing and who are in good standing with the University.
- Section II. All individuals must comply with the University requirements as well as the Intramural-Recreational Sports Office requirements concerning health insurance and risks, hazards, and physical stresses forms. After completion of all required forms, membership becomes effective upon payment of yearly or semester dues. A yearly membership lasts through the fiscal year starting on the first day of classes.
- Section III. A member exhibiting unsportsmanlike conduct, may be expelled from the club by a majority vote of the club membership.
- ARTICLE IV. OFFICERS
- Section I. The officers of this organization will be chosen from and by the active members of the club.
- A. The officers will be: President, Vice President, Secretary, and Treasurer.
- B. The election of these officers will take place at the last meeting of the spring semester.

Article IX

Section IV

Any article of this constitution or part thereof that is in direct violation of the student Government constitution or by-laws shall be null and void and declared unconstitutional by the President of student Government. Any differences of opinion between the Club and the President of student Government shall be brought before the Legislature, whose decision shall be final.
