

Society of Naval Engineers

Purpose: The purpose of the Society of Naval Engineers is to promote and develop the academic, philanthropic, and professional growth of its members.

Membership Criteria: The Society of Naval Engineers is only open to students who are currently enrolled in North Carolina State University Naval Officer Training Corps Program, Marine Corps Enlisted commissioning program, Naval enlisted commissioning program, Naval Nuclear enlisted commissioning program, or Navy ROTC College program. Furthermore, these students must be enrolled in at least 12 hours of engineering courses, or have an engineering major. To be an active voting member a semester grade point average of 2.5 must be maintained. If this is not upheld, the member is put on suspension and is not allowed to vote on any society matters, or partake in any society functions or activities. Members are automatically admitted if they meet these criteria. There are no standing dues required for the Society of Naval Engineers.

Officers: The Society of Naval Engineers has the following executive structure:

President:	presides over meetings and presents budgets/expenditures to the ROTC unit commanding officer
Vice-President:	maintains the member standing standards as listed above and oversees all event committee heads
Secretary:	Takes minutes at meetings and informs the NROTC unit webmaster of any potential changes in events/activities
Treasurer:	Oversees the proper submission of a budget for each semester, and oversees the use and distribution of this money upon approval of this budget

Meetings: Meetings will occur once a month after the first NROTC lab of the month. (i.e. meetings will be the first Tuesday of every month at 7:30 p.m.) These will serve to introduce new members, brainstorm for activities that further the purpose of the Society of Naval Engineers, and plan out such activities.
