

Sports and Classic Car Club

Constitution

Date: November 1, 2000

Article I

Section 1: Title

This organization shall be known as the Sports and Classic Car Club (SCCC).

Section 2: Purpose

The purpose of this organization is to promote the enjoyment and knowledge of sports cars and classic cars to both members of the SCCC as well as the general public.

Article II

Section 1: Membership Requirement

Membership shall be open to all regularly enrolled students and faculty who show an interest in sports cars, classic cars, or automotive fields in general, or in the activities of the club.

Section 2: Member Selection

Members shall be accepted into the SCCC solely based upon the interest in the club.

Article III

Section 1: Office Positions

The elective officers for this club shall be the President, Vice President, Treasurer and Secretary.

Section 2: Terms of Office

The officers shall be elected by the club members to serve a term of one year, beginning exactly one week prior to elections.

Article IV

Section 1: Dues

Dues for the club shall be \$5.00 a semester -or- dues for the club shall be in the form of special assessments voted on by a majority of the club members present and voting.

Article V

Section 1: Amending the Constitution and by-laws

Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member for the proposed amendments. A majority of 2/3 for the members present and voting shall be required.

Article VI

Section 1: Meetings

The club shall meet monthly -or- the club shall meet as determined by the club membership each semester.

Article VII

Section 1: Committees

The club shall make provision for any standing committees needed and/or for forming any special committees when needed.
