# Constitution of The NCSU Squash Club

Article I	Name & Purpose		
	Section 1	This organization shall be known as the NCSU Squash-Club	
	Section 2	This club shall provide an organized structure for the participation in and the enjoyment of the sport of squash for the North Carolina State University community.	
Article II	Membership		
	Section 1	Membership to the club shall be open to all regularly enrolled students, staff, or faculty who are interested in the participation or contribution to the sport of squash and are in good standing with the university. Membership shall be granted upon completion of all required forms and payment of membership dues.	
	Section 2	All individuals must comply with the university requirements as well as the club sports program requirements concerning health insurance, and Risks, Hazards, and Physical Stresses Forms.	
	Section 3	All members found guilty of unsportsman like conduct may be voted put of the club by a majority vote of at least half of the active club members at a regular club meeting, and with the approval of the club sports assistant director shall have their membership canceled.	
Article III	Officers		
	Section 1	The elective officers of this club shall be the President, Vice-President, Treasurer, and Secretary.	
	Section 2	The duties of the president shall include, presiding over official meeting, organizing meetings, the submission of Risk, Hazards, and Physical Stresses Forms to the intramural recreation office, and reporting to the club sports assistant director.	
	Section 3	The duties of the Vice-President shall include presiding over official meetings in the absence of the President, and contribution to official decisions.	
	Section 4	The duties of the treasurer shall include, management of club funds and contribution to official decisions.	
	Section 5	The duties of the secretary shall include, informing members of events, official correspondence and contribution to official decisions.	
	Section 6	The officers of this club shall be elected by majority vote of at least one half of the active club members, to serve a term of one year, beginning the first week of May each year.	

Section 7

Election of officers shall be held during the first week of April. All current active members in good academic standing are eligible for election.

Article IV

Dues Section 1

The dues for the club shall be assessed by the Treasurer, ratified by the majority vote of active club members, and approved by the club sports assistant director.

Article V

Amending the Constitution and By-Laws

Section 1

Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A two-thirds (2/3) majority vote and the approval of the club sports assistant director will be required for ratification.

Article VI

Meetings Section 1

The frequency and length of meetings will be determined by the availability of facilities and by member participation. A meeting of at least half the club members should occur at least twice a month.

Article VII

**Faculty Advisor** 

Section 1

The faculty advisor will be a member of the faculty or staff of North Carolina State University and will be selected by the members of the club and approved by the club sports assistant director.

Section 2

The duties of the faculty advisor shall include, the attendance of at least three business meetings of the club per year (preferably the first business meetings of the fall and spring semester and the last meeting of the spring approval of all club functions, semester). accompaniment of the club on outings whenever possible. and helping the club on making its yearly budget.

Article VIII Club Activities

Section 1

Club activities shall include club meetings, practice, clinics, squash-tournaments, games, and social events.

Section 2

All club activities are subject to approval by the faculty advisor and the club sports assistant director.

Article IX

Rules

Section 1

The rules of play shall follow those outlined by the World Squash Federation.

Section 2

These rules may be modified in affiliation with those outlined by the United States Squash Racquets Association for North American Singles or Doubles. A majority of at least half of the active members and the approval of the club sports assistant director will be required for ratification of any changes.

## **CONSTITUTION**

### August 1, 1997

Article I	Name and Pi Section 1.	urpose This organization shall be known as THE SQUASH CLUB.
	Section 2.	The purpose of this club shall be to promote competitive squash for men and women of all skill levels.
Article II	Membership Section 1.	Membership shall be open to all regularly enrolled students who are interested in squash and club participation.
	Section 2.	Means of selecting members. THE SQUASH CLUB shall be open to all those interested in improving their game through competitive play. Members are expected to maintain good sportsmanship.
Article III	Officers Section 1.	The elected officers of this club shall be PRESIDENT, VICE PRESIDENT, SECRETARY, TREASURER, and ADVERTISING AGENT.
	Section 2.	The officers of this club shall be elected by the club members to serve a term of one year, beginning in the fall semester.
Article IV	Dues Section 1.	Dues shall be determined by majority vote of club members based on the club's current needs. Dues will not be a major factor in one's decision to join the club. Current dues are \$5.00 per semester or \$8.00 for an entire year as of August 1, 1997.
Article V	Amending the Section 1.	Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the members present and voting shall be required.
	Section 2.	All amendments to this constitution or by-laws shall be subject to

approval of the Student Government.

Section 3. Any article of this constitution or part thereof that is in direct violation of the Student Government constitution or by-laws shall be null and void and declared unconstitutional by the President of the Student Government. Any differences of opinion between the club and the President of the Student Government shall be brought before the Legislature, whose decision shall be final.

Article VI Meetings

Section 1. THE SQUASH CLUB meeting dates are determined by majority vote of club members and based on attendance and participation. Current meetings are held weekly as of 8/97.

Article VI Committees

Section 1. THE SQUASH CLUB shall make provision for any standing committees needed and / or for forming any special committees when needed.

Article VII General

Section 1. Members must complete any insurance or release form required by the university

Section 2. Officer duties. Note below the description of office responsibilities and duties

PRESIDENT: Expected to follow responsibilities outlined in the NCSU Intramural Sports Club Program. Shall organize meetings and activities of the club, however will never dictate over the majority.

VICE PRESIDENT: Will assist the president as necessary in fulfilling his duties. Will assume duties as president should the president become temporarily or permanently incapable of fulfilling his responsibilities.

SECRETARY: Shall be responsible for taking note of meeting topics. Shall keep track of attendance and current standings of club members. This includes release forms and dues.

TREASURER: Shall be responsible for keeping track of all club money transactions and the club checking account.

ADVERTISING AGENT: Shall be responsible for club promotion through the use of media and flyers. May ask for relief through the help of individual members.

Note: All club members should attend meetings. If an officer plans on missing a meeting, he will notify the president ahead of time.
