Article I Name & Purpose

Section 1

This organization shall be known as the Student Film Club

Section 2

The purpose of this club is to promote Film as a serious form of art and increase student appreciation of film through facilitating the screenings and discussion of art films and filmmaking. The club will also function as a meeting place for students interested in film and students interested in filmmaking.

Article II Membership

Section 1

Membership shall be open to all regularly enrolled students who are interested in viewing, discussing, or making film.

Section 2

All applicants to the club shall be accepted to join at first. However, showing interest in film and the screening is necessary for renewing membership.

Article III Officers

Section 1

The officers for this club shall be the elected by the club members.

Section 2

The positions and number of officers can change as they club officers see fit.

Section 3

Each officer serves a term of one semester. The president has to have at least 2/3 of the votes to be elected.

Section 4

The sponsoring faculty for this club is Dr. Maria Pramaggiore.

The officers will choose the material to be screened and organize the activities of the club. Recommendations and requests from the members will be considered. The sponsoring faculty's recommendations and guidance will be welcomed as well.

Section 5

Article IV Dues

Section 1

There shall be no dues for this club as for the spring and summer semester 2003. Dues for the club shall be in the form of special assessments voted on by a majority of the club members present and voting.

Article V Amending the Constitution and by-laws
Section 1

Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member for the proposed amendments. A majority of 3/4 for the members present and voting shall be required.

Article VI Meetings
Section 1

The club shall meet twice a month. Some meeting will be film screenings on-campus or off-campus.

Article VII Committees
Section 1

The club shall make provision for any standing committees needed and/or for forming any special committees when needed.

Article VIII Section 1

This club promotes and fosters students' interest in art. Civility is required in all aspects. Under no circumstances does it tolerate, racist, sexist, or anti-social behavior of any kind.

Section 2

This club adheres to the North Carolina State University Policy and regulations.

Section 3

The club respects the copyright and intellectual property law. The club will not screen any material that is not authorized for screening.
