Article I Name and Purpose

	Section 1	This organization shall be known as the Student North Carolina Association of

Article II	Membership	*
	Section 1	Membership is limited to students attending North Carolina State University (undergraduate or graduate) who are majoring in or associated with education. Members must also pay yearly dues.
Article III	Officers	1953
	Section 1	The elective officers for this club shall be the president, vice president, secretary, and treasurer.
	Section 2	The officers shall be elected by the club members during a full-member meeting at the end of the spring semester to serve for the following fall and spring semesters.
	Section 3	The duties of the officers are as follows: <u>President:</u>
		• To conduct / oversee executive and member meetings
		• To assure that all SNCAE officers are fulfilling their office duties

- To plan and successfully complete monthly activities for SNCAE members
- To form / maintain an open relationship with members of NCAE, including but not limited to keeping NCAE informed about SNCAE activities at NCSU and vice versa.
- To keep SNCAE members informed about upcoming events
- To keep the community and prospective members aware of SNCAE at NCSU
- To set long and short term goals for SNCAE

Vice President:

- To complete duties of the SNCAE presdeint in the vent of his or her absence
- To assist in the completeion of the other officers' duties in the event of their inability to do so
- To assist in the maintenance of the SNCAE web page

Secretary:

- To take notes at every SNCAE meeting
- To read the minutes of the previous meeting at the beginning of each SNCAE meeting
- To make meeting minutes available to members upon theier request

• To update the SNCAE web page periodically

Treasurer:

- To keep an accurate and current record of all finencial transactions
- To inform club members of available finances at each club meeting
- To balance the SNCAE checkbook
- To be in charge of depositing and withdrawing funds from the treasury
- To be involved with fund raising activities
- To give advice on any program that would require funds from the treasury

Section 4 Officers are to follow the standard parliamentary procedure chain of command: president, vice president, secretary, treasurer.

Article IV Dues

Section 1 Dues are currently \$30.00; \$12.00 for the National Education Association (NEA), \$12.00 for the North Carolina Association of Educators (NCAE), and \$6.00 for the NCSU chapter of SNCAE. These dues are subject to change on a yearly basis; proper notification will be given in advance.

Article V Amending the Constitution and By-laws

Section 1 Amendments to the constitution or by-laws may be presented and voted upon on the same meeting date. A majority of twothirds of the members present at this meeting is required.

Article VI Meeting Requirements

Section 1

Attendance is encouraged, but is not mandatory. Emphasis is placed on service activities.
