# Constitution of the Baccalaureate Student Social Work Association

## **Purpose**

We, social work students of North Carolina State University, being vitally interested in the welfare of our surrounding population and recognizing the need for unity of purpose and action, desiring sound communication among the individual members and other organizations, do hereby form an association for this purpose. In addition, we recognize our charge to promote a socially responsible society through education, consideration of diversity (cultural, ethnic, gender, race, spiritual, and sexual orientation), and community service. This constitution shall be the structure of laws by which the association shall preside. The purpose of the constitution is to create a working order of laws by which we shall operate: as we purpose to further our professional development and make valuable contributions to local charitable organizations/agencies.

Article I.

Name A BS

Section 1.

The name of this association shall be the Baccalaureate Student Social Work Association". The organization was developed in September 2006 because of the merger of the three social work student associations: Undergraduate Student Social Work Association, Student Association of Black Social Workers, and the Student Association of Christian Social Workers

Article II.

Membership

Section 1. In order for one to become an active member, one must attend a minimum of one meeting, pay \$5.00 in dues, and participate in one of the following: service project, fundraiser, or event. An event is defined as any activity where one is speaking and/or representing the BSSWA.

Section 2.

All Social Work Faculty members are welcome to attend meetings and functions.

Article III.

DUES

Section 1. Regular Members.

Dues shall be \$5.00 per year for membership in the BSSWA.

Section 2. Officers.

Dues shall be \$5.00 per year for all elected officers for membership in the BSSWA.

Article IV.

# Meetings

Section 1. Regular Meetings

There shall be a minimum of one scheduled meeting per month. Meeting will be announced on the Social Work List Serve five (5) days in advance and will be held at such a place and time as the Executive Committee shall determine.

Section 2. Special Meetings

Special meetings of the members may be subject to the call of any officer or upon request of at least three members, at least twenty-four hours in advance. Also, special meetings of the members may be called for any purpose at any time by any member, by the action of a majority of the total membership of BSSWA.

Section 3. Notice of Special Meetings

Notice of the date, time, place, and purpose of the special meeting shall be e-mailed at least two (2) days before the actual special meeting.

Section 4. Voting

If a quorum is present, the vote of a majority of duly authorized dues paying members in good standing shall be the act of BSSWA. At any meeting of the members, each member entitled to vote on any matter to be voted upon at such meetings, shall be granted one vote and may exercise such voting right either in person or by written proxy.

Article V.

# SSWA's Commitment to Diversity

In order to accurately reflect the current BSW student population, the members of BSSWA will make a good-faith effort to elect/appoint qualified officers to ensure that all members are fairly represented. In order to determine the diversity of the current student population, the BSSWA faculty advisor will request and retain pertinent statistics and will utilize them in order to provide guidance to the BSSWA.

# **EXECUTIVE COMMITTEE**

Section 1. Offices

The officers of this committee are the President, Vice-President, Secretary, Treasurer, Historian, and CHASS Representative,

Section 2. Meetings of the Executive Committee

The Executive Committee will hold their meetings one week prior to the general meetings. The Committee will establish the meeting place and time at the beginning of each semester.

## **ELECTION OF OFFICERS**

How Elected. Other duly authorized members in good standing shall elect the executive committee. Each officer shall serve for a period of one year or two consecutive semesters (normally fall through the spring of the following year). Should any person holding the office not be able to fulfill the term, emergency elections will be held in order to fill the vacant position. Elections shall be held at the last BSSWA meeting of the spring semester.

Section 3. Voting

Voting shall take place by secret ballot, with any two officers tallying the votes and announcing the results at the same meeting, majority rules. In the event of a tie, votes will be held once more with the President refraining from voting.

Article VI.

# OFFICERS

Section 1. Number and Designation.

At all times, six (6) duly authorized members in good standing shall be officers of BSSWA. The designation of such officers is outlined in sections two (2) through seven (7) of this Article V.

Section 2. President.

Preside at all meetings and act as spokesperson for the association. The President shall have power to act for the association when meetings are not possible, with responsibility to report his/her actions to the association at the next meeting. The President shall be responsible for organizing any necessary committees, and recruiting members to help with various projects of the association.

Section 3. Vice President.

At the request of the President, or in the absence or disability of the President, the Vice President shall perform all the duties and may exercise all the powers of the President. The Vice President shall also monitor, coordinate, and oversee the activities of each standing committee.

Section 4. Secretary.

The Secretary shall record records membership information for active members, the attendance of the members at meetings, and the content of each meeting/event. All records shall be made available to the members via e-mail and posting on the Department of Social Work Homepage. The secretary shall keep a record of any committees formed and shall keep record of the progress and actions of the committee. The Secretary is responsible for all BSSWA correspondence (Thank you notes, letters of request, etc.) and for reporting such correspondence to the members at meetings.

Section 5. Treasurer.

The Treasurer shall record the financial status of the association and keeps records of each transaction. This officer will also keep accurate accounts of all receipts disbursements, and other business transactions of BSSWA. On a monthly basis, the Treasurer will report out the financial status of the BSSWA to the organization.

Section 6. Historian

The Historian shall document visually and orally the activities of the BSSWA; shall on a monthly basis update and maintain the archives of the organization. This duty is to include recording outreach events of the BSSWA by camera or other digital devices.

Section 7. CHASS Representative.

Attend every meeting of the CHASS council. The CHASS Representative shall be responsible for acquiring our operating funds from the CHASS Council. The CHASS Representative shall be a contact person for our association within the College of Humanities and Social Sciences. If the CHASS Representative cannot attend a meeting, he or she will appoint someone to represent BSSWA at the CHASS meeting.

Article VII.

AFFINITY GROUPS

The purpose of the affinity groups is to reflect the diversity that is represented within the organization at large. It also serves as a means to form committees for community service projects. These groups are meant to be adaptable: every election year, an evaluation will be conducted by the Executive Committee with the guidance of the BSSWA faculty advisor, in order to determine breakouts by representation.

Article VIII.

# **ORDER OF BUSINESS**

The normal order of business for meetings will follow the agenda distributed to everyone present at the beginning of the meetings. The order of business may include, but will not be limited to, the following:

Announcements
Minutes of the previous meeting
Report of the Treasurer
Committee Reports
Unfinished Business
New Business
Discussion
Adjournment

Article IX.

Section 1.

In the event that a student has a request for financial assistance to participate in a school activity such as: conferences, leadership retreats, campaigns, etc. then the student must submit a proposal to the BSSWA requesting these funds. If the budget of the BSSWA can afford these requests, then the association will allot up to \$250.00 per semester in scholarships to the requesting member(s). The student who qualifies for this assistance must agree to report back about what he or she learned through their experience at the next scheduled BSSWA meeting.

This constitution shall be the structure of laws by which the association shall preside. ### Article I

### Name

Sec. 1 The name of this association shall be the "Student Social Work Association".

### Article II

# Membership

- Sec. 1 All interested Social Work students are eligible for membership in the SSWA
- Sec. 2 In order for one to become a member, one must attend a minimum of two meetings/events of the SSWA.
- Sec. 3 In order to *maintain* one's membership, members must attend at least two meetings/events per semester.
- Sec. 4 All Social Work Faculty members are welcome to attend the meetings and functions of the SSWA

### Article III

### Meetings

- Sec. 1 There shall be a minimum of one scheduled and announced meeting per month.
- Sec. 2 Special meetings shall be subject to the call of the preesident, or upon request of at least three members, at least twenty-four hours in advance.

### Article IV

### Officers

- Sec. 1 The officers of this association shall be elected by vote of the members.
- Sec. 2 The officers shall be: President, Vice-President, Secretary, Treasurer, NASW Representative, and CHASS Representative.
- Sec. 3 The duties of the officers shall be as follows:

<u>President</u>--Preside at all meetings and act as a spokesperson for the association. The President shall have power to act for the association when meetings are not possible, with responsibility to report his/her actions to the association at the next meeting. The President shall be primarily responsible for organizing the activities of the SSWA, considering all the suggestions from his/her fellow officers and the members of the SSWA

<u>Vice-President</u>—Perform the duties of the President in his/her absence. The Vice-President shall be responsible for organizing any necessary committees, and recruiting members to help with various projects of the association.

Secretary--Record the attendance of the members and the content of each meeting/event. All records shall be made available to the members upon request. The Secretary shall keep a record of any committees formed and shall keep records of the progress and actions of the committee. The Secretary is responsible for all SSWA correspondence (thank-you notes, letters of request, etc.) and for reporting such correspondence to the members at meetings.

<u>Treasurer</u>--Record the financial status of the association and keep records of each transaction. The treasurer is responsible for purchasing any refreshments and/or materials needed by the association. The treasurer shall report the transactions and financial status of the association at each meeting.

NASW Representative--Inform members of all local NASW events. The NASW Representative shall be a contact person between our association and the National Association of Social Workers.

CHASS Representative—Attend every meeting of the CHASS Council. The CHASS Representative shall be responsible for acquiring our operating funds from the CHASS Council. The CHASS Representative shall be a contact person for our association within the College of Humanities and Social Sciences.

Article V

### Election of Officers

Sec. 1 Elections shall be held during the last meeting of the SSWA each

- semester. Nominations shall be accepted at that meeting. Members may nominate themselves or another member for any office.
- Sec. 2 Voting shall take place by secret ballot, with any two officers tallying the votes and announcing the results at this same meeting, simple majority sufficing.
- Sec. 3 In the event of a tie for any office, the President shall call a special meeting within five days for the purpose of a run-off.
- Sec. 4 Voting rights shall be limited to *members*—those who have attended at least two meetings/events *this same semester*.

### Article VI

### Amendments

- Sec. 1 This constitution may be amended only by vote of the simple majority of active members present.
- Sec. 2 Any proposed amendment to this constitution shall be submitted, in writing, to the president prior to the meeting on which it is to be voted.

### Article VII

### Faculty Advisor

- Sec. 1 The Association shall ask one Social Work faculty member to serve as advisor. The faculty member shall be asked at the time of the SSWA elections.
- Sec. 2 The advisor shall serve as liaison between the SSWA and the Social Work Faculty, and as a resource for the officers of SSWA; for the period of one academic year.

### Article VIII

### SSWA Colors and Motto

Sec. 1 The colors of the association shall be red and white. The motto of the association shall be "Social Workers empower the world."

### Article III

### Meetings

- Sec. 1 There shall be a minimum of one scheduled and announced meeting per month.
- Sec. 2 Special and/or emergency meetings shall be subject to call by the president or upon request of at least three active members at least twenty-four hours in advance.

### Article IV

### Officers

Sec. 1 The officers of this organization shall be elected from the active members.

- Sec. 2 The officers shall be: President, Vice-President, Secretary, and Treasurer.
- Sec. 3 The duties of the officers shall be as follows:

### President:

Preside at all meetings, act as spokesperson for the association and have emergency power to act for the association when meetings are not possible with responsibility to report his or her actions to the association at the next meeting. In case of a tie in any legislative action, the President shall cast the deciding vote. The President shall ask for committee volunteers as needed, and shall attend all Council of Humanities and Social Sciences meetings or appoint a representative in his or her stead.

### Vice-President:

Perform the duties of the President in his or her absence, act as chairperson of the Program Committee, introducing each program and speaker and
present the programs to the association. The Vice-President shall ask
for volunteers to serve on the Program Committee. In the spring, the VicePresident shall reserve a room on campus for the meetings to be held the
next year. The Vice-President shall announce all meetings and related
functions in the Technician, and Green Sheet, and is responsible for
announcing said meetings in social work classes.

### Secretary:

Take and report minutes at each meeting. The secretary shall keep records and make them available to any association member upon request. The secretary shall make a list of committee members as committees are formed and turn said lists over to committee chairpersons. The secretary shall also be responsible for all association correspondence (i.e., thank-you notes, letters of request, and any other correspondence necessary) and for reporting said material to members at the meetings. The secretary shall contribute minutes and other agenda to the Archives, located in the basement of the library, for future reference. These materials shall be presented in such a manner as to be easily referred to when needed.

### Article V

# Election of Officers

- Sec. 1 Elections shall be held the day of the last meeting in March.

  Nominations will be accepted at this meeting. Voting shall be
  by secret ballots, with current officers tallying votes and
  announcing results in that same meeting, a simple majority
  sufficing.
- Sec. 2 In the event of a tie for any office, the President shall call a special meeting within five days for the purpose of a run-off.
- Sec. 3 Voting rights shall be limited to active members of at least one month.

### Article VI

### 'Amendments

- Sec. 1 This constitution may be amended only by a vote of the simple majority of active members present.
- Sec. 2 Any proposed amendment to this constitution shall be submitted in written form to the President prior to the meeting on which it is to be voted. Any such approved legislation shall constitute the by-laws.

### Article VII

### Faculty Advisor

- Sec. 1 The association shall ask one Social Work faculty member to serve as advisor. The faculty member shall be asked at the time of the Association elections.
- Sec. 2 The advisor shall serve as liason between the association and the Social Work faculty for a period of one academic year.

### Article VIII

# Advisory Committee Representatives

Sec. 1 Three student representative to the Advisory Committee to the the Social Work Program shall be elected by said association at the time of the annual election of officers. One representative shall be nominited from the Junior Class for a term of two years. The second representative shall be a Senior nominated for a period of one year.

### Article IX

# Rosemary A. Fike Merit Scholarship

Sec. 1 Active membership in the Association is one of the requirements for eligibility to receive the Rosemary A. Fike Merit Scholarship for Social Work Students.

### Article X

### SSWA Colors and Motto

Sec. 1 The colors of the association shall be light gray, burgandy and navy blue. The motto of the association shall be "For the Human Touch, Try a Social Worker."

In the spring, the Vice-President shall reserve a room in the Stüdent Center for the next year's meetings to be held. The Vice-President Shall announce all meetings and related functions in the Tecnnician in aedition to asking all Social Work faculty menters to announce said meetings in their respective classes.

Recording Secretary: Take and report minutes and roll at each meeting.

The recording secretary shall keep records and make them available to any association member upon request. The recording secretary shall make a list-of committee members as committees are formed and turn sold lists over to committee chairpersons. The recording secretary shall keep a list of active members and a list of all members their addresses and shone numbers.

Corresponding Secretary:

Be responsible for all association correspondence (1.e. thank you notes, letters of request, and any other correspondence necessary) and for reporting such correspondence at association meetings.

Treasurer: Keep a full and accurate record of all financial transactions of the association at the first meeting of every month.

### Article V

### Vice-President:

Will perform the duties of the President in his absence, shall act as chairperson to the Program Committee, shall help set up programs to the best interest of the members, present the program to the club, and be in charge of the introduction of each program and speaker. The Vice-President shall appoint the members of the Program Committee and have the responsibility for publicity (announce times and places in class and in the Technician).

### Secretary-Treasurer:

Shall keep the minutes and roll of each meeting, shall keep a full and accurate record of all financial transactions of the club, and appoint an assistant if necessary.

### ARTICLE VII

### Legislation

- Sec. 1. Only active members shall have the power to vote, unless otherwise specified.
- Sec. 2. A majority vote shall decide all issues; except those otherwise specified.
- Sec. 3. In case of a tie, the President shall cast the deciding vote.

### ARTICLE VIII

### Amendments

- Sec. 1. This constitution may be amended only by a vote of the majority of active members present.
- Sec. 2. Any proposed amendment shall be submitted in written form to the President prior to the meeting at which it is to be voted on.

### ARTICLE IX

### By Laws

As soon as this organization shall be put into operation, the President shall have the power to appoint a committee for the purpose of recommending by-laws for the organization. These by-laws shall become effective when passed upon by a majority. Other by-laws may be added at the motion of any member, if it meets the approval of the majority of active members present.

  Will perform the duties of the President in his absence and shall act as advisor to the Program Committee.
- Secretary-Treasurer:

  Shall keep the minutes and roll of each meeting, shall keep a full and accurate record of all financial transactions of the club, and appoint an assistant if necessary.

Program Committee Chairman:

Shall act as Head of the Program Committee and help set up programs to the best interest of the members and present the program to the club and be in charge of the introduction of each program and speaker.

### ARTICLE VII

### Legislation

- Sec. 1. Only active members shall have the power to vote, unless otherwise specified.
- Sec. 2. A majority vote shall decide all issues; except those otherwise specified.
- Sec. 3. In case of a tie, the President shall cast the deciding yote.

### ARTICLE VIII

### Amendments

- Sec. 1. This constitution may be amended only by a vote of the majority present of active members.
- Sec. 2. Any proposed amendment shall be submitted in written form to the President one meek in advance before the meeting is to be voted on.

### ARTICLE IX

### By Laws

As soon as this organization shall be put into operation, the President shall have the power to appoint a committee for the purpose of recommending by-laws for the organization. These by-laws shall become effective when passed upon by a majority. Other by-laws may be added at the motion of any member, if it meets the approval of the majority of active members present.

Attached is a line item budget request for support of the <u>Student Social</u> <u>Work Association</u> for the Spring Semester of 1976. As you know this Association was formed and approved by Student Government during the Fall Semester of 1975.

Attendance at the three meetings of the Association after the Constitution was approved has been exceptionally good, usually in excess of 25 members. Since the Social Work program is educational preparation for the profession, our members are affiliating with the National Association of Social Workers and plan some joint activities, particularly student participation in the North Carolina Chapter of NASW. Transportation of students to meetings and workshops of the professional association is requested as student representatives are expected to share these professional experiences with fellow members of the Student Social Work Association.

The budget item for stationery represents the proposed purchase of 500 sheets of letterhead and envelopes for the Association's business correspondence. Fifteen dollars (\$15.00) for long distance telephone calls would make possible telephone calls to the four other campuses which have student Social Work organizations, to secure speakers and handle other business and program activities of the Association.

Office supplies represent mats, stencils, paper for meeting announcements, postage and duplicating costs.

Four hundred dollars (\$400.00) for speakers will be used for honoraria and travel of leaders in the Social Work profession to speak to and/or lead workshops for the Association members.

Currently there are approximately 100 students enrolled in the Social Work program who are members and potential members of the Association.
