**Constitution Of The Turkish Students Association
North Carolina State University**

ARTICLE I: NAME AND PURPOSE

Section 1 : Name- This organization shall be known as the Turkish Student Association , referred to as TSA from here onwards.

Section 2 : Purpose- The TSA shall:

- (i) exist as a common bond among the Turkish Students at NCSU ;
- (ii) facilitate cultural exchange between the Turkish Students and the Community ;
- (iii) co-ordinate social, cultural and educational programs for students and the community ;

ARTICLE II: MEMBERSHIP

Section 1 : Requirments :

Membership of TSA shall be open to all students who are:

- (i) registered Turkish students at NCSU for that semester or summer session ;
- (ii) family members of the registered Turkish students at NCSU ;
- (iii) students and their family members who are not registered during that summer but were registered during the preceding spring semester and will be returning for the coming fall semester.

The membership of the TSA shall be divided into active and associate membership, as defined in Section 2 and 3 of this Article respectively . In addition , honorary membership can be awrded as per section 4 of this Article.

Section 2 : Active Member :

All Turkish students shall automatically be considered as active member

Section 3 : Associate Member :

Any person who desires to participate in the activities of TSA and meeting the requirements of section 1 of this article , can be an Associate Member.

Section 4 : Honorary Member :

Any person who is interested in the activities of TSA but does not qualify as an active or associate member as defined in preceding Section 2 and 3 of this Article , can be awarded an Honorary Membership by the Executive Council.

ARTICLE III : ORGANIZATION

The TSA shall be composed of two bodies

- 1) The General Assembly
- 2) The Executive Council

Section 1 : The General Assembly :

The General Assembly shall be composed of all the members as defined in Article II.

Only the active members shall be considered as the voting members.

Section 2 : The Executive Council :

The Executive Council shall consist of six officials and a faculty advisor.

The six officers shall be :

- President
- Vice-President
- Secretary
- Treasurer
- Officer 1
- Officer 2

ARTICLE IV : ELECTION

- (i) The election shall be held not later than April 15 of each year .
- (ii) The Executive Council shall announce the date , place, and time of election at least three weeks in advance .
- (iii) The announcement pertaining the election shall be done utilizing all the available media so as to reach the maximum number of active members .
- (iv) Only the Active Members can vote in the election .
There shall be no voting by proxy.
- (v) Candidates for the executive council members should be active members of the TSA .
- (vi) The election shall be held for all the posts in the executive council .

ARTICLE V : DUES

- (i) Dues for the club shall be in the form of special assessments voted on by a majority of the club members present and voting .

ARTICLE VI: AMENDING THE CONSTITUTION AND BY-LAWS

- (i) Any article of this constitution or part thereof that is in direct violation of the Student Government constitution or by-laws shall be null and void and declared unconstitutional by the President of Student Government. Any differences of opinion between the club and the President of Student Government shall be brought before the Legislature , whose decision shall be final .
